Para 1.20	Catalyst operates entirely by invitation in local schools, currently 2 secondary and 5 primary schools where the clubs, support groups and 1-to-1 mentoring are valued by staff and young people. Young people are referred for mentoring by school staff, with parental permission. Senior teachers, middle managers and key staff all value the contribution made by mentors who come alongside young people to provide support and a listening ear. Other community activities are open to all young people in the community including "Donuts at Dusk", "Impact" after-school drop-in club, Saturday Night events.
