# Annual Treasurer's report to the PCC St Mary the Virgin

Our cash balances over the year 2018 has seen a decrease in total and the accounts show a deficiency in our income over expenditure by £36,438.06.

In 2018 the parish share payable to the diocese to cover the Rectors salary, pension and central costs reduced by 8% to £58.3k (£1,100 pw) from £63.4k in 2017 (this was due to the vacancy). The parish share will increase again in 2019 to 62.5k.

Our covenanted income was consistent with the previous year at £55.7K, however our money received from weekly cash giving and donations decreased from £10.6k in 2017 to 9k in 2018. Over all, outgoings increased by 45% to £178.7k resulting in our annual shortfall over £142.2k income by the above mentioned £36,438.06. This can be attributed to the increased outgoings for the buildings project on fees and surveys, some £77.6k in 2018. This has led to the building fund being exceeded in 2018 (starting balance £27.2K, ending balance -£46k) but this was adjusted from the general funds through-out the period.

Rental income on a net basis for the school house, which we manage for the Dioceses, brought in a further  $\pm 7k$  in 2018 although we saw some expenditure on it for garden maintenance of  $\pm 1,032$ . This increases the school house fund restricted in our balance sheet to  $\pm 54k$ .

This leaves us with available cash balances of £94.3k after deduction of the school house fund as shown in the statement of assets. This represents a 31% reduction on the previous year (£136.7k).

Income received from housing a phone mast in the church tower has brought in a further £11.5k for the year (£26.5k to date).

I would like to thank Heather Melling for her work as our covenant secretary and also to Gail Phillips for helping count the weekly cash takings from our collections along with others. Also, I would like to thank Richard Selby for his on-going help and support in maintaining the parish accounts. Thanks again to Ron Neil for examining these accounts.
