

APCM MEETING HELD AT ST.MARK'S CHURCH, OULTON BROAD

ON THURSDAY 19th APRIL 2018 at 7.30pm.

VESTRY MEETING – 65 Parishioners in attendance including The Chairman and Secretary

1. **MINUTES OF LAST YEAR'S MEETING ON THE 26th APRIL 2017.** These were agreed and signed as a true record after minor amendment.
2. **ELECTION OF CHURCHWARDENS.** The Chairman, Venerable David Hayden, thanked the retiring Churchwardens, Sandra Stone and Roger Pitchers, for their service to the Church during the past twelve months. The two nominees for the posts of Churchwarden were:- Lesley Denny (proposed by Dorothy Strowger, seconded by Roger Pitchers) and Geoffrey Ansdell (proposed by Richard Soanes, seconded by Mandy Marler). Both were unanimously elected to serve for the forthcoming year.
3. **RATIFICATION OF ELECTION OF CHURCHWARDEN FOR ST.LUKE'S.** For the coming year and because both newly appointed Churchwardens attend both St. Mark's & St.Luke's Churches, it was unanimously agreed that the post would be shared between Geoffrey Ansdell and Lesley Denny.

1. **APOLOGIES FOR ABSENCE:-** Paul Newson, Avril Soanes, Alan Zipfel, David Powell, Margaret Bullen, Lynne Scofield, Mary Ansdell, Brenda Jones, Maggie Barnes, Maurice & Maureen Dowding, Stephen & Carolyn Woodcock, Mandy Marler, Sylvia Beatty.
2. **MINUTES OF THE PREVIOUS APCM HELD ON THE 26th APRIL 2017.** These were agreed and signed as a true record after minor amendment.
3. **MATTERS ARISING FROM THE MINUTES.** No matters were raised.
4. **ELECTION OF FOUR DEPUTY CHURCHWARDENS FOR ST.MARK'S.** Liz Hepburn, Paul Beatty, Jo Zipfel, and Catherine Scott were elected.
5. **POLICIES.** The Chairman explained the importance of the various Policies relating to aspects of the work in the Church and all were accepted unanimously. Similarly the Inventories for both St. Mark's and St. Luke's were accepted.
6. **RECEIVING OF WRITTEN REPORTS AND QUESTIONS.** The previously circulated booklet of Reports was accepted and thanks were expressed to all those who had contributed to the writing and production of the document.
7. **ACCOUNTS FOR 2017.** John Hunt expounded various aspects of the 2017 Accounts making the following points: - the completion of the West Window was a huge financial achievement and had allowed "St. Mark to keep the Church under his watchful eye!" – that said as a result other aspects of the church giving were not doing so well to the extent that at the end of the year the St. Mark's general fund showed a deficit of £11,950. Action to remedy this situation include a scrutiny of our income and outgoing expenses, efforts to have more Hall bookings, and a Stewardship campaign. Commenting further he took the meeting through the whole accounts and explained the "Reserves Policy"(each Church should retain 3 months worth of funds in the Bank to allow for emergencies. St. Luke's were "doing well" and with income about the same level as in the previous year, had

finished the year with a £3K surplus. John encouraged the meeting to always consider on-line purchases using "Easy Fund-Raising.org" as this was a way of helping Church funds. He thanked all those who give to the church and to those who help him with aspects of the envelope scheme, cash counting, and banking. In response to a question the Parish Share in respect of St. Mark's with St. Luke's was not reduced during a period of interregnum. John was thanked by the Chairman for all he does in respect of Church finances.

8. **PRIEST IN CHARGE, DAVID HAYDEN.** David Hayden began by thanking all who are in the fellowship of St. Mark's with St. Luke's encouraging others and working as a great team all pulling in the same direction; he added that we look forward to having St. Michael's joining us in the future. He drew attention to the fact that Rev. Sarah Quantrill was nearing the end of her curacy and was beginning to look at possible Parishes to begin her ministry adding that St. Mark's would not be having another Curate for the foreseeable future. Commenting on the future David drew attention to the work being undertaken on the Parish Profile, the preparation for the new Incumbent, planning permission in respect of a possible new Vicarage and building for St. Mark's, and the possible Team Ministry with St. Michaels. "We will all continue to have a big emphasis on looking outwards to preach the Gospel".
9. **HOME GROUPS AND DISCIPLESHIP.** Rachel Hayden amplified her circulated report in respect of the House Groups and emphasised the need to encourage more of the fellowship to join in. In respect of the Youth Work for the 15 to 18 year old group which meets on Friday evenings with Gracie Wright as joint leader, numbers are growing and the fellowship is encouraging.
10. **CHILDREN AND YOUTH WORK.** Liz Hayden explained that she had now assumed the responsibility for the Youth & Children's work and that, sadly, "we have not done very well" – however, from small beginnings our approach will bring positive results. Special mention was made of Stella Saunders and her work with Starfish, Sarah Quantrill for her work in the local schools and many other places, Gemma Eglington and her helpers in the Sunday School, All those who are involved in the Holiday Clubs, and Rachel Hayden with the 15plus age group.
11. **ELECTIONS TO THE PCC.(6 Vacancies).** The following were elected to serve on the PCC for the following year - Stella Saunders, Jacquie Berrey, Gordon Judd, Jo Zipfel, Peta Baker, and Catherine Scott.
12. **PCC MATTERS TO BE CONSIDERED AT THE NEXT MEETING.**
 - a. Val Waterman raised the question of whether a special collection could be taken during the week of "Christian Aid". Matter to be considered by the "5th Sunday Special Collection" Committee.

3. **DATE OF NEXT PCC MEETING.** Wednesday 18th May 2016 @ 7.30pm Will Stewart Room. St. Luke's Council Meeting 12th May 2016 @2.00pm at the Vicarage.

This group is for over 15's. We meet on Friday evenings to learn about Jesus, laugh, pray, play crazy games and consume large numbers of Jaffa Cakes! There are currently 7-10 young people attending, all of whom, it seems, are in competition to come up with the trickiest question to ask Rachel! It's great! Gracie Wright co-leads and Gemma is joining us for a 6 week block before Easter while she studies for her Youth qualification. We've finished Youth Alpha and during Lent we're using Bible Study material based around the film, 'The Greatest Showman' which, I'm sure, will involve Karaoke and costumes but also tackle some big issues. Gracie organised a Christmas party with bowling and buffet. Debate nights are really popular, we've tackled issues such as Euthanasia and Homosexuality this year. We have an online group chat so that the young people can ask questions, and share testimonies. There is also a prayer page for requests. This is such a fantastic group of young people, all at different stages of their spiritual journey. I'm so excited about what God is doing in each of their lives. It's a privilege to see them grow.

SAFEGUARDING OFFICER'S REPORT

- There are currently 38 people with up to date DBS (Disclosure and Barring Service) checks – 16 for working with Under 18s, 4 for working with Adults at Risk and 18 for working with both Under 18s and Adults at Risk.
- Holiday Club – for each event all 18 year olds or over, excluding the Refreshments/ Lunch team had valid completed a Confidential Declaration Form and key adults had appropriate DBS (working with Under 18s).
- I was asked by the Norwich Diocese to attend a meeting with Eleanor Stobart (an Independent Consultant) on Thursday 2nd August along with 6 other Parish Safeguarding Officers, which I did, as part of the qualitative review of Safeguarding training within the Church of England which the Diocese of Norwich had been selected to be part of.
- The Safeguarding Policies for both Children and Young People and Vulnerable Adults are visibly displayed at both St Mark's and St Luke's as well as appearing on the church's website.

PCC REPORT

During the year ending December 2018 the PCC met 5 times in full session under the Chairmanship of Priest-in-Charge, David Hayden in the chair to consider matters relating to God's work in both St. Mark's and St. Luke's and once to consider, with the St. Michael's PCC, the impending formation of the new Benefice/Team Ministry of St. Mark's, St. Luke's and St. Michael's. In February the Church was pleased to be able to have the opportunity to dedicate the West Window, the renovated Church Organ, and the replacement Alter kneelers (particular thanks to the very talented team who produced these. Relating to that the PCC have been involved in approving the Parish Profile for the new benefice, the proposed new Vicarage in the garden of the current St. Mark's Vicarage and the implications for St. Mark's Church itself in terms of access roads and installation of utilities. Other matters which are currently being considered include the upgrade of the Church and Hall multi-media /sound systems, additional and more flexible lighting in the Church, and the need to encourage more individuals to become volunteers in the undertaking of the continuing work of our Lord's work.

At each meeting John Hunt, Church Treasurer, talks through his previously circulated financial report and the PCC remains eternally grateful to him for his diligence, knowledge, suggestions, and control over the Church finances (a particularly poignant area with the likely shortfall in respect of the 2017 Financial Year) – all attributes which he also shows in his preparation of the annual budget documents. Gill Williams circulates her Safeguarding Report which covers another important aspect of the Church's work in-line with current Legislation.

On a personal note can I thank all the members of the PCC for their prayers, support, patience, and encouragement shown to me during another busy year.

Maureen Dowding accompanies the choir on the piano for the anthems and is a tremendous asset as well as a remarkable person. Each of the choir members is extremely loyal and continues to make sure that the choral tradition at the Church survives. They cannot be praised highly enough. Because each of the choir members is so multi-talented however, and required in other places to do vital Church work, it is not possible to have a robed Choir in each of the Mark 1 services. Former members of the choir do a sterling job in singing from the pews!

I have been instrumental in the Church ordering another filing cabinet for the Worship Band music to be filed together, organising the Band rota for the services, and co-hosting a social after a Band 'clear-up' at the Church and a review of the equipment. Matthew Zipfel has worked hard with others to improve the sound equipment of the Band and Church and Rob Newby does an exceptional job as sound engineer for the Band virtually every week. Most of the Worship Band music filing, the publishing of the band rota, and looking after the general welfare of the band is done magnificently by Graham Meadows. David Drake leads the Youth Band rehearsals and encourages this vital side of the development of the Church music. The rehearsals come under the general supervision of Rachel Hayden and volunteers sit in whilst they rehearse. Each of the band members is highly valued for the work that they do.

We are very fortunate to have a team of very talented pianists/organists who deputise at St. Marks when I am not able to attend a service, and also to make sure that the musical worship at the services at St. Mark's and St. Luke's is led effectively. The team comprises Mary Ansdell, Ruth Pawsey, Maureen Dowding, Gillie Powell and Valerie Walker. We are very fortunate to have the instrumentalists and the instruments to play.

The choir, band and Church musicians participate in concerts held throughout the year in order to bolster the Choir Fund, the Will Stewart Scholarship Fund and/or general Church Funds. These are greatly appreciated by many.

As you will see, the music at St. Mark's is as a result of great team-work and we tend to be a caring family within a bigger Church family. We encourage and are concerned for each other as members of families are. Each member of the Choir and Bands is vital to this team and I am very thankful for each one.

Music at St. Mark's continues to flourish and enhances the worship at all the services except the quiet 8am Holy Communion.

The refurbished organ and grand piano enhance the traditional Mark 1 services and the grand piano the Wednesday morning Communion. We are often joined by Stewart Green

The freedom to Marry in church has been an ongoing discussion, the superintendent Registrars certificate will now name the church where the wedding is to take place however to keep to the spirit of church legislation there needs to be a link between at least one of those being married to the church. Bishop Graham asked what marriage means in 21stC Britain both today and tomorrow, this remains a live issue.

Church survey forms with church deanery plans were requested, an apology for both St Marks and St Michael's was accepted due to our status of interregnum and new organisation. Prayer was held for the parishes/ benefices in interregnum and for the deanery mission to itself. We discussed ministries of welcome, friendship and social justice, schools access - after school clubs and our links with other organisations and care homes, Arrangements made for Deanery day of prayer in July and Bishop Graham's visit to Lowestoft. In October we reconvened at Somerleyton Church with a snapshot of the 6 rural parishes in this benefice and the problems of all being listed buildings with churchyards still open.

Digital communications were discussed the user being 'us', the importance of realising that the average reading age 9 for online and digital presentations, the fastest growing group of online users is the 55+ age group, all churches require a 'Facebook' page and we must keep it updated and open for everybody. The importance of safeguarding was stressed.

We have been asked to pray using the Novena for a new Bishop.

The Deanery are planning a Dabble and praise together day on Saturday May 11th at St Margaret's church 10 am -4pm every benefice to come and take part in activities and every benefice to come with an activity!

GARDENING TEAM

The gardening team of 3 has continued happily through the last year, which has not been without incident. PLANNED GIVING OFFICER'S REPORT

In January 2018, a little earlier in the year than usual due to the large deficit of £11950 for 2017, we held our regular campaign for planned giving; this took the form of a letter to those on the electoral roll, being a lighter touch event than in the previous year due to the interregnum. However only 36 returns were received, and in 2018 the accounts show that regular giving at St Mark's reduced by £3911. We are holding another low-key campaign again this year during Lent. Please fill in and return your giving slip

For all donors, if you are not already doing so, please consider giving using bankers standing order, usually monthly: this is very convenient, both for donors (in not having to remember cash or to write out cheques) and for cashiers and the treasurer! It is also more secure and confidential. It is under full control by yourself and can be amended or stopped at any time simply by telling your bank. It can also be managed electronically if you use internet banking.

We are now able to claim the equivalent of Gift Aid on cash donations of less than £20 each (the Gift Aid Small Donations Scheme, GASDS). So if you are not able to Gift Aid, please just put cash on the plate or use the coloured weekly envelope system. Please make sure each donation is less than £20, for example if you are not able to attend church, give envelopes to someone else or drop them into the church office rather than putting multiple envelopes on the plate so that you are giving more than £20, in which case your donation doesn't qualify for GASDS!

One way to help without giving any more directly is if you shop on line, e.g. with Amazon, John Lewis, M&S, eBay, Argos. These retailers (and many more) are happy to give a small donation (e.g. 0.2% of sales) to charities if you order via a website called www.easyfundraising.org.uk. It is very easy. You need to go to this site and click on "support a good cause", then "choose a good cause". Put in the box "st marks and st lukes oulton broad" and it should find it. You then need to click "sign up" to register. Try it and see, after that you can shop with any of the retailers listed on this site, and there are many household names. You can even download a toolbar that reminds you to go through this website if later you forget and you go to eg. Amazon first. At present we receive about £25 each quarter from this source but it could probably be a lot more. Please do consider this, it costs you no more!

Another important source of income for the church is legacies. Please consider leaving the church a gift in your will. It is very easy and can be done by "codicil" if you have already made a will. This just needs to be signed by yourself and two witnesses all in each others' presence, and kept with your will. And gifts to a charity, such as the church, are free from inheritance tax so may be used to reduce the taxable part of your estate, if applicable, which would otherwise be taxed at 40%. The PCC

FINANCE

TREASURER'S REPORT

St. Mark's and St. Luke's financial statements for 2018, which have been adopted by the PCC, are presented as a separate document to this report. They have been independently

examined by Mr John Beevor and thanks are extended to him.

For 2018 we continued to pay parish share and other dues in full. However this is becoming more of a challenge as explained below.

Regarding St Mark's General Fund, we have a continuing overall deficit (excess expenditure over income) of £3266 in 2018. This was due to a combination of factors, but mainly that giving by standing order decreased from 2017, due to loss of some generous givers. Cash and envelope donations increased but not by enough to offset the shortfall. Income from events continued at a relatively low level. Against this the expenditure was contained by careful management to less in 2018 than 2017, good news in the face of some increased costs.

This deficit has reduced our reserve from £13850 at the end of 2017 to £10584 at the start of this year. In 2017 the PCC adopted a reserves policy to hold 3 months of running expenses which can be calculated as about £122K/4 = £30.5K; we now hold a third that amount, enough to run the church for just one month. So we are both contravening our policy and sailing very close to the wind.

Action continues to attempt to reduce this deficit in 2019. We have an ongoing stewardship campaign due to finish on Easter Day and are hoping for increases in giving. We hope for a strengthened events programme with proceeds directed to the General Fund. And there is potential additional use of the hall by new users.

At St Luke's, giving was higher than in 2017 and there were no large building developments (work undertaken on the front entrance is being billed in 2019). consequently there was a surplus of £3011 in the General Fund and the position is very healthy with an adequate reserve.

In 2018 our two churches also paid £6476 to charities, including Casa Hogar Vida, the Children's Society, Foodbank, Swanland Africa Trust, Pathways care farm, and many other charitable causes. The total donated is equivalent to more than 10% of direct regular giving.

At both churches the PCC can be thankful for the help of all our fund-raisers and event organisers.

Looking forward, we are asked in 2018 to pay an increased (by 2.9%) parish share of £64497 (£5375 per month) from both churches. The PCC's aim, in common with other churches in the Deanery, is again to meet 100% of this target. This year it will be a struggle and we will have to decide in the Autumn if it can be achieved.

The treasurer wishes to pay tribute to all the fund-raisers for their work and all who assist in managing the church finances with such assiduous good stewardship. And thanks are as ever due for the continuing hard work by our cashiers who carry the responsible tasks of counting

NOTES TO THE FINANCIAL STATEMENTS FOR BOTH CHURCHES FOR THE YEAR ENDED 31 DECEMBER 2018

Accounting Policies

The financial statements have been prepared in accordance with the Statement of Recommended Accounting Practice: Accounting and Reporting by Charities (SORP 2005), issued in March 2005, UK Accounting Standards and the Charities Act 2011. The financial statements have been prepared under the historical cost convention. The financial statements include all transactions, assets and liabilities for which the PCC is responsible in law.

Funds

Restricted funds represent donations or grants received for a specific object or invited by the PCC for a specific object. The funds may only be expended on the specific object for which they were given. Any balance remaining unspent at the end of each year must be carried forward as a balance on that fund. The PCC does not usually invest separately for each fund. Where there is no separate investment, interest is apportioned to individual funds on an average balance basis.

Unrestricted funds are general funds that can be used for PCC ordinary purposes.

Designated funds are sums set aside out of General Funds for specific purposes. They can be transferred to unrestricted funds at any time.

Incoming Resources

Planned giving, collections and donations are recognised when received. Tax refunds are recognised when received. Grants and legacies are accounted for when the PCC is legally entitled to the amounts due. All other income is recognised when it is receivable. All incoming resources are accounted for gross.

Resources expended

Grants, donations and the diocesan parish share are accounted for when paid, or when awarded, if that award creates a binding or constructive obligation on the PCC. All other expenditure is generally recognised when it is incurred and is accounted for gross.

Fixed assets

Consecrated and benefice property is not included in the accounts in accordance with s10(2)(1) of the Charities Act 2011. Movable church furnishings held by the vicar and churchwardens on special trust for the PCC and which require a faculty for disposal are inalienable property, listed in the churches' inventories, which can be inspected (at any reasonable time). Equipment used within the church premises is depreciated on a straight-line basis over four years. St. Mark's portakabin is depreciated on a straight-line basis over ten years. Individual items of equipment with a purchase price of £1000 or less are deemed fully depreciated when the asset is acquired.

Reserves Policy

The Parochial Church Council of St. Mark with St Luke needs to hold reserves to be able to meet its ongoing expenditure efficiently and to ensure there is sufficient resource available to cover liabilities obligations and contingencies in the event of loss of existing sources of income. The PCC believes that the necessary level of reserves is equivalent to approximately three months of average expenditure from the General Funds. This level will be maintained by close management of finances and forward planning by the use of appropriate budgets. Restricted and Designated Funds have their own objectives and the necessary levels are kept under close review by the PCC. This policy will be reviewed annually as part of the audit process.


