Charitable Status

Barton Methodist Church is a charity (No.1135451) in its own right. Thus the Church Council, as well as having the role set out in the Constitutional Practice and Discipline of the Methodist Church (CPD), is also the Board of Trustees of the charity and the Minister is the Chairman. Thus, this Annual Report and Accounts is for the Charity Commissioners as well as the church. This determines to some extent its form and contents. One effect of this is that the church is able to deal directly on matters such as Tax Reclaims on Gift. Aided donations rather than through the charitable status of the Methodist Church.

Mission Statement

To know Christ and to make Him known.

We exist to encourage and celebrate a loving relationship with God.

To that end we will endeavour to:

- make followers of Jesus Christ by sharing our faith,
- be a good neighbour and share God's love,
- offer a warm welcome in a safe place,

General Church Meeting

The General Church meeting shall be held for fellowship, for mutual counsel respecting the condition of the Local Church, including its financial affairs, for the election of church stewards and representatives and for any other purpose, which the Conference may direct (SO621). It meets at least once a year (SO622).

The minister and all members of the Local Church are the voting members of the meeting (SO620(1)) but the meeting is open to all other persons who are on the community roll (SO620(2)).

Note:

There are other ex-officio voting members of the meeting who do not generally attend (SO643(1))(other circuit ministers etc.) and posts (e.g. lay workers) set out in(SO606(1).

The Church Council

The members of the Church Council are Managing Trustees of Barton on Sea Methodist Church under the terms of the Model Trust as set out in 'The Constitutional Practice and Discipline of the Methodist Church' (CPD). CPD is reviewed and amended as necessary at Conference each year, is largely coposed of Standing Orders (SO's) and where appropriate these are quoted in this report.

The members of the Church Council are also the Trustees of the Charity (see above under Charitable Status).

"The Church Council has authority and oversight over the whole area of the ministry of the church, including the management of its property. Aims and methods, the determination and pursuit of policy and the deployment of available resources are its proper responsibility. In many cases it will appoint committees* which have authority, in their own areas of responsibility, to initiate action, co-ordinate the work done in the church, advise the Church Council and report to it, being subject to its authority and oversight" (\$0603). It meets at least twice a year (\$0613).

* The Individual Reports' set out later are made initially to a Committee/Forum and form a record of the activities carried out under the auspices of the Church Council during the report period.

Reports

1 Church Life

1.1. Worship

a) Services

Graham Westbrook

Rev Ros Hollingsworth has now completed five years of ministry and has embarked on her new role as Superintendent Minister of a London Circuit. In the past year Ros has continued to move us forward with new ideas to encourage us to deepen our Christian life and by doing so move along our individual paths of faith.

As suggested in previous annual reports the age range of the membership and congregations is made up, almost exclusively, from the retirement sector and continues to get even older. The year has seen a number of members move away from Barton to be closer to family, move into residential care homes and join the Kingdom of God.

Whilst the number of people moving into Barton remains constant many come from unchurched backgrounds and do not automatically seek out a church in the community. This is a clear change from a decade or so ago when the church in Barton believed it could remain with a constant membership from regular churchgoers moving into the area.

The decline in membership and attendance at worship, as in many churches throughout the UK, will continue at Barton (see the table below). It is a significant challenge to the church to encourage and provide teaching and a pattern of worship which would appeal to younger retired people.

We continue to share the first monthly evening service with Highcliffe Methodist Church. The timing of evening service at Barton has been changed for a trial year to commence at 4pm instead of 6.30pm and, although the change has not resulted in increased congrgations, it has been decide to stay with the changed time.

We also continue to share a United Service with our friends from the Parish Church and these provide an ecumenical approach to our worship which benefits both sets of participants. On Easter Sunday we shared in a fifth ecumenical sunrise service on the cliff top led by Ros with folk from a number of churches in the area. This service is fast becoming an expected event and 35 attended.

A full range of services have been part of the Easter and Christmas celebrations. Through invitation cards delivered to the majority of

properties in Barton by church members this has encouraged visitors to attend

Once a quarter at an evening service we share in a Healing and Wholeness Service at which prayer ministry is offered and this is greatly appreciated by those who attend.

We are fortunate to be able to welcome visitors to the area either visiting relatives or holidaying. Refreshments after the Sunday service and Tuesday morning services provide an excellent opportunity to share and grow in friendship and is much valued by those who attend regularly. We are able to invite a number of ministers and local preachers to lead our Tuesday morning services and we benefit from the diversity of approach preachers at these services are able to provide. It is also good that we are able to share special services with the Pre-school i.e. mothering day, harvest, nativity and end of term leavers' services which has enabled children, parents, grandparents etc. to attend and to be introduced to Barton Methodist Church.

Our average attendance for services during the year under review is shown below and compared with two years ago.

The total number of communicants through the year was 1,145 (last year 1,305)

In May, June, July and August 2018 we had a reduced number of Communion Services. This was the period when Revd Ros Hollingsworth was on sabbatical and while we were waiting for our new minister, Revd Martin Keenan, to commence his ministry with us in September 2018. This would in part account for the reduced number of communicants between September 2017 and August 2018.

Attendance at the Maundy Thursday evening Communion Service increased very slightly. After many years of having the same light meal (which preceds the service) we made a change to the menu.

I would like to express my sincere thanks and appreciation to all the Communion Stewards who, throughout the year, have carried out their duties so willingly. There have been no changes to the Communion Stewards through the past year and we remain 11 in number.

c) Welcomers

Barton church continues to provide Welcomers before Sunday morning services which is of great benefit to members and visitors. For various reasons the number of people on the list of volunteers has declined recently so I would be pleased to hear from anyone willing to join the rota. It is not an onerous task, all we ask is for a commitment to being at church early to Welcome the members of the congregation and take the offertory at the same service once or twice a quarter. There is always an opportunity to change if necessary. Please speak to me if you are interested in joining us.

d) Worship and Prayer Forum

The W&P Forum meets 3 times a year to discuss, and arrange, special Services (e.g. Christian Aid, Meeting Point Anniversary, Pre-School Services, etc.) or requests for guest Preachers. This year we also talked about the 8am Services and, after discussion, took the recommendation to Church Council that we should no longer offer these. This

recommendation was accepted by the Church Council. We have discussed the Sunday 4pm and Tuesday 10am Services.

The Forum supported and encouraged an Advent Prayer leaflet (produced by Valerie Westbrook) to enable people to focus their prayers during this time of preparation. We also approved the introduction of a team of Intercessors, who are ready to lead these prayers during our Sunday Services.

The Forum is open to all and members of the Church are encouraged to participate in this aspect of our faith and witness.

1.2 Pastoral

Note 1.2 covers the year between the pastoral committees in Oct 2017 and Oct 2018 since the current membership is for the latter date and the attendance at worship count is done in the month of October.

a) <u>Pastoral Committee</u>

All members of the church and some adherents have a Pastoral Visitor and, although distribution of the church Newsletter (now called News and Views) to folk on their 'list' is a good method by which regular contact is ensured, the care extends beyond this, particularly in times of need. This has become more important since reducing the frequency of production of the newsletter from every month to every two months.

The Pastoral Committee meeting was held on 9th October 2018 and the commissioning of Pastoral Visitors took place on 14th October. All Pastoral Visitors are continuing their work this year, except for Harold & Mary Holcombe and Peggy Barton who have stepped down after a number of years faithfully fulfilling this role. Happily two people, Julia Newman and Eileen Stack have agreed to become a Pastoral Visitors. Several people offered to add folk to their lists, to cover those giving up this year and keep all lists at a reasonable level. I wish to thank everone for their tireless work for God in this role.

1.3 Church Family Activities (Church Family Forum)

Children and Young People:-

a) <u>Barton Pre-School</u>

Ann Mayled

At the start of the academic year, the number of children on the register was lower than in previous years and this was a cause for concern. However, over the course of the year we did welcome a number of new children and although we were not as full as we had been in the past, this did put us in a much better position.

We cared for the children of 20 families, including those with English as an additional language. The children all seemed to get along with one another really well and there were no real behavioural issues.

Over the course of the year, the children have attended services in the church, which they always enjoy as do the parents. The nativity service was particularly entertaining with Rev David Hollingsworth leading this for the first time. Following the service, we held our Christmas Fayre which raised £328 and which was used to buy new resources for the children.

The New Forest Ranger visited us, bringing along all sorts of animal skins and skulls for the children to explore. The children also made visits to 2 local nursing homes to join in a variety of activities with the residents. It is hoped to continue this in the coming year. Rev Bailey very kindly let us invade his space again this year for our sports day which was held on one of those very hot days we had. The children took part in a number of different physical activities and were very proud to receive a medal and some bubbles in recognition of their efforts.

We have just completed our first year of longer opening hours with the majority of the children now staying for the lunch clubs that are held on a Monday & Thursday until 1 and until 2 on a Friday. I must express my thanks to the bowls club who put back their starting time to allow us more time to clear up once the children have left. We are looking forward to the year ahead and whatever challenges it may bring.

b) <u>Safe-guarding</u>

The church's safeguarding policy document was reviewed at the October Church Council (as it is annually) and readopted. At the same time an

additional policy document was tabled on Safeguarding in respect of 'Church Photography, Publicity and the Internet' and this was adopted. Copies of all policies are displayed for public view in the Welcome Area.

Refresher courses continue to be held on a regular basis for church members who are in any way involved in activities which will necessitate a knowledge of the policies and practice.

It is good to see the social interaction of all those who attend including parents, grandparents, friends, carers, toddlers and babies.

Our average weekly attendance from 07.09.17 to 19.07.18 was 15 children and 11 adults.

We enjoy outside entertainment from Diane at Hartbeeps and we all benefit and have great fun.

We usually have an end of term party for the toddler and baby group at the end of each term.

Our wonderful, loyal and flexible team include 8 assistants and 3 refreshments ladies who attend on a rota basis. We all aim to have a get together twice a year in December and July, usually at The Amberwood in Walkford, and enjoy a splendid lunch.

We are looking forward to meeting our new Minister, Rev. Martin Keenan and family in the near future.

The Crib Service on 24th December 2017 was well attended. It was good to see the parents, grandparents and children in church from our Toddler and Baby Group plus children who used to attend our sessions and commenced big school. Rev. Ros. Our Anniversary service in October 2017 was led by Tony Coghlan. A rather poignant occasion as his name had been suggested by our friend Joyce Church as someone she knew and liked. We can say he did her proud. This year we will have Rev. David Ellis to lead our service – a name familiar to many.

September sees the installation of a new Minister for Barton Church and we welcome him and extend an open invitation to him and his wife to join us at our meetings.

g) Flower Ministry

h) Short Mat Bowls Club

During the year up to the end of July the club had some 22 active members 10 of which resulted from advertising in local publications.

2 Finance Committee

2.1 Church Treasurer

This committee met three times during the year and discussed in detail all aspects of the Church's income and expenditure. The usual accounts for the General & Property Fund and the Benevolence Fund, for the year ending 31st August 2018, were presented to the Church Council meeting held on 16th October 2018. A list of all funds is shown below, with last year's totals included for comparison. Detailed accounts are available on request.

2.1.1 General & Property Fund (GPF)

Expenditure exceeded income by £2800. This overspend was covered using money from a bequest received last year.

(a) <u>Income</u>

Offertory income continues to fall, but income from hall use has increased.

(b) <u>Expenditure</u>

The Circuit Assessment was up by £737 which means that the offertory income no longer covers the Assessment. Many other items of expenditure have increased since last year, which together with some "one-off" purchases has created the overspend.

2.2 Envelope Scheme

Madeleine Eurich

Regular giving in the form of the Envelope Scheme is a convenient and popular way to contribute to Church funds and there are currently some 50 members who make their offering in this way.

It is valuable in providing a reliable source of income and is completely confidential and secure as well as being a check for those who Gift Aid (see 2.3 below).

Another way to give which some people find more convenient is to set up a standing order with their bank and together these two contribute over 80% of total general giving to the church.

2.3 Gift Aid Katey Betts

The gift aid scheme is still running smoothly and now have some sixty people participating on a regular basis with several one off donations from visitors. HMRC are very prompt in paying the due money into the church bank account once the claim has been processed on line. This is done quarterly.

3 Property

. Michael Stopher

The Property Committee met three times during the year and reviewed various tasks.

A new water softener that automatically regenerates the resin bed was installed under the dishwasher in the kitchen. This supplies a continuous flow of softened water to the dishwasher, without the need for someone spending one and a half hours carrying out a manual regeneration.

The south and west perimeters of the Church were cleared of all weeds and vegetation and tarmac was laid over the ground to form easily maintained pathways.

The minister's vestry toilet was completed renovated, installing new sanitary ware. Some re-plumbing was necessary and this was followed by complete redecoration.

Other minor maintenance work has been carried out to ensure that the buildings continue to be fit for purpose. Six additional tables were purchased.

d) Christian Aid

£2,079.25 was raised by the Barton-on-Sea Christian Aid Group in the group's ninth year (June 1st, 2017 – April 30th, 2018).

This year our financial year ended one month earlier than usual on 30^{th} April and therefore the total for 2017 - 2018 does **not** include monies raised during Christian Aid Week 2018 (£3,319.36).

Christian Aid Week can end as late as 21st May and it was always a rush to complete the paying in and paperwork before the end of our old financial year on 31st May. For this reason our financial year will be 1st May□ 30th April from 2018-2019 onwards.

The 21st "Tea in the Garden" took place on Friday, June 16th, 2017. 102 supporters came together to raise £942.66 for the vital work carried out by the charity in over 37 countries around the world. Stalls sold

homemade cakes, jams, jewellery, clothes, bric-a-brac, books, cards and gifts and, with prizes generously donated by local businesses, our popular raffle added to the entertainment of the afternoon.

The sale of 1,380 little Christmas cards at New Milton Junior School in December not only brought in £133.80 but also raised the children's awareness of Christian Aid's Christmas Appeal for food aid in South Sudan and Burkina Faso. Every pound raised was match-funded by the UK Government which meant that the little Christmas cards raised £267.60 in total.

In Burkina Faso Christian Aid provided tools to enable families to grow and sell vegetables, as well as nutritional ingredients and training to provide healthy meals for malnourished children. 2017 was eighteenth year that this well-established and popular Christmas event at the Junior School has taken place.

The sale of 330 general greetings cards throughout the year raised a further £165.00.

Various fundraising events throughout the year raised a total of £837.79:

- Barton Methodist Church: two coffee mornings (£429.20)
- St.Mary Magdalene's: Quest Group sponsored walk—organised by Rosemary Bailey and helpers (£175.50)
- Pop-up events: cards and gifts in the kitchen; soup lunch (£233.09)

We started trialling pop-up events this year and they proved **pop**ular (excuse the pun).

"Pop-up Cards in the Kitchen" (£88.09) and "Pop-up Soup Lunch" (£145.00) raised £233.09 between them.

Pop-up events are quick and easy to organise and can raise awareness of Christian Aid's work amongst your friends and neighbours as well as raising funds. They're micro fundraising events which anyone can organise! Google "pop-up events" for ideas — basically whatever you're interested in can inspire a pop-up event: pop-up tea party; pop-up plant stall, pop-up quiz evening, pop-up musical soirée, pop-up choir — if anyone would like to host a pop-up event, please let me know.

We have 74 members, with 10 on the waiting list. 25 new members have started during the year. We also have 6 members in nursing homes/respite. Unfortunately 20 members have passed away.

We celebrated Joan Simms 100th Birthday, not quite the eldest as Katie Abel is 105. Our members always receive Birthday cards. We are continuing to celebrate 90th Birthdays, with Cup Cakes for all members. Thanks to Annette O'Flynn.

Our members are well looked after, receiving 'Goody Bags', at Christmas, Easter and summer break. These include Cup Cakes, chocolates, sweets, Easter Eggs and a Palm Cross.

We have introduced a free raffle twice a month, which our members enjoy. The winner receives a free lunch the following week. We also give our members the opportunity to buy greetings cards, jigsaws and handmade items at reasonable prices for members who find it difficult shopping.

All the current paper work relating to occupancy has been updated and circulated to the tenants.

All flats are fully occupied which continues to reflect a very healthy financial situation.

The new sun lounge roof has now been completed at a cost of £10,000. Other repairs include replacing the entry phone system and a replacement boiler for Marandell (our bungalow).

Our harvest communion date is set for 26 September to be led by Simeon Woodcraft from Whitefield road Evangelical free church. The Christmas lunch has been arranged with Bartley Lodge, Cadnam, on 15th December.

e) <u>Basics Bank</u>

Ruth & Roger Richardson

The New Forest Basics Bank has now been in operation for 14 years. Demand for services has grown significantly during this time, so much so, that the organisation is beginning to out-grow the distribution centre at the United Reformed Church Lymington, and the Trustees are investigating the possibility of re-locating.

The year ending 30 April 2018 saw a continuing increase in demand for services with the number of food parcels distributed rising from 845 in the previous year to 940. In total, 2000 people were supported, 724 of whom were children. The approximate cash value of a parcel for a single person was calculated to be in the region of £33/£36.

Christmas 2017 was once again hectic with 300 seasonal parcels prepared and distributed. The distribution team was once again supported by the Lymington and Pennington Town Mayor, Cllr Barry Dunning. Donations, both financial and in kind, have continued throughout the year in abundance. The Trustees are extremely grateful to members of

The Barton-on-Sea Methodist Church, Townswomen's Guild and others for their generous support in giving donations both in kind and financial to support the work. In addition to the contributions from Barton, many Churches and other organisations throughout the New Forest area regularly make donations. Collection points at Waitrose in Lymington, Sainsbury's in Brockenhurst and the Community Store in Pilley are of considerable help too, as is the large quantity of produce donated by Churches and Schools at harvest time. Individuals and organisations are increasingly helping the cause in original ways, for example, several

families have benefitted from a generous offer from a local Pub to provide a weekly Sunday Lunch to a family in need.

Looking forward to the rest of this year, it is anticipated that requests for assistance will continue unabated. The Universal Credit initiative is being rolled out in this area this coming Autumn: other areas where the system already in place have reported a five-six week delay from the end of the present benefit system to commencement of its replacement, so further increases in demand for our local services are expected. As a result of this and taking into account other pressures in the community, continued support from contributors will be very much appreciated.

f) <u>Traidcraft</u> Alison White

Traidcraft was established 30 years ago to help poor people to get a fairer share of the profits of trade, challenge injustice and ensure that trade works for everyone.

The founder, Richard Adams, said "...for me it had been the impact of a suffering world...that made me seek ways in which the power of business could be placed at the service of the poor rather than as a mechanism to exploit them..."

As a Church we are committed to using Fairly Traded of Rain Forest Alliance tea, coffee and sugar and ask groups who use the church to consider doing this. The advantage of Traidcraft is that all the profits go to help the underprivileged and the poor of our World to set up businesses and co-operatives so that they can compete on an even playing field, thus enabling them to feed and educate their families.

I run a small stall on Sunday mornings after service and at Table top sales selling a variety of Traidcraft goods. I am grateful to my loyal customers – every sale helps somebody in the world to have a better quality of life.

g) <u>Revive Café</u>

A good year for the team. We all worked well together and enjoyed time with the regular customers. Although they are few in number we are pleased to see them.

We had a profitable year. After donating to the church we were able to give £50 each to New Milton Carers Group, Street Pastors and New

Forest Disability Information. Helpers have connections with all three local charities.

I have put invitations in every church magazine this year and we have tried 'special ' events. Leaflets also went out to local groups. But this has not increased our clientele.

We are willing to serve again this coming year but recognise a review will be necessary at the end of the year, to assess the effectiveness of this activity as part of the church outreach.

But for now a big 'thank you to the loyal team without whom the cafe wouldn't operate.
