Due to a very generous legacy, income increased from £27506 to £117096. No major works were required in the year so expenditure was only £582 (2017 - £888), mainly on churchyard maintenance. The value of investments fell by £12130 (2017 – increase of £7640), leaving a surplus of £104384 (2017 - £34258) to be added to reserves, in preparation for anticipated expenditure under the next quinquennial inspection, which is scheduled for 2019.
