The Ebor Academy Trust (EAT), a multi-academy trust, is responsible for the Robert Wilkinson Primary Academy (RWPA). The charity's trustees can nominate two Members and one Director to the Board of the EAT, and up to 3 governors for the Board of Governors for RWPA.

In line with the Charity's first objective, as well as being sited on land owned by the Charity, the Academy and its current and former pupils are the principal beneficiaries of bequests from the Charity under its first objective.

The objectives are:

- The advancement of education primarily for the benefit of children in the Parish of Strensall with Towthorpe and particularly the pupils of Robert Wilkinson Primary Academy. This includes making available land owned by the charity, as determined by the trustees, to the above Academy; and promoting the education of those under 25 and in need.
- 2) The relief of those in need by virtue of poverty, hardship or distress and resident in the above Parish or surrounding area by the provision of assistance and support (financial or otherwise) in such ways as the trustees from time to time think fit.

However, the trustees shall not be obliged to provide funding for the above which should otherwise be provided by the state (whether through central or local government or otherwise).

Summary of the main activities undertaken for the public benefit in relation to these objects (include within this section the statutory declaration that trustees have had regard to the guidance issued by the Charity Commission on public benefit)

The two major benefits paid by the Charity in 2018 were a matching contribution to the monies raised by other parties, including the Friends of Robert Wilkinson School, to build a Memorial Garden in the Academy grounds celebrating 300 years since the establishment of a school in Strensall, and funding the purchase of more Chromebooks for use in Year 3. The garden was not covered by funding for which the Department for Education is responsible and so the charity's contribution fits with the first objective.

The next largest benefit activity has been the usual provision of book grants to former Robert Wilkinson Primary School pupils, and other young people living in Strensall, to help purchase books and similar materials for their university courses. This is in support of the first objective.

Assisting with the costs for a pupil to go on the Academy's Year 6 residential trip to Hawkhirst also supported the objectives.

Again the trustees have received relatively few requests for assistance in the period under review. This has meant that the Charity's funds have increased slightly over the year.

In their decisions to agree to requests for funding, the trustees have had due regard to the guidance issued by the Charity Commission on public benefit.

This Charity's accumulated funds are still well in excess of the targeted reserve.
