Another year has successfully passed Whittington and Oswestry YFC, the club has taken part in many events some of which have been Stock judging, Entertainments, Shropshire show, Oswestry Show, Rally, the Clay Pigeon Shot, the Bowling Competition, fencing, Tug of war, and many more.

The Club has raised money to cover the expenses of running the club by holding a Dinner Dance, Oswestry Show Dance and Pound Dance all held in the local village hall. The Club also held a Charity Race Night, Carol singing, Sunday plough and a Charity performance of the entertainments which raised money for our three chosen charities, Lingen Davies Appeal, Air Ambulance and Cancer Research. Money was also raised for Mountain rescue Brecon team in aid of James Corfield on Oswestry Show day in the Club Marquee by running a blow-up bounce castle.
