Notes to the Accounts

1 Basis of accounting

The financial statements have been prepared under the Charities Act 2011 in accordance with the 2014 version of Accounting and Reporting by Charities: Statement of Recommended Practice (SORP) applicable to charities preparing their accounts in accordance with FRS102 – the Charities SORP (FRS102) and taking note of the Update Bulletin 1 issued in 2016.

2 Funds

The funds held constitute: General Funds held for any purpose of the Church which are Unrestricted. Restricted funds which are held for a narrower purpose. There are no Endowment funds. Details of each material fund are disclosed in the final note to these accounts. Any funds may be represented by more than just cash.

3 Accounting policies Basis

These accounts have been prepared on the basis of historical cost except that investments are shown at their market value at the end of the year, on the accruals basis to show a true and fair view of the Church's financial position and activities.

Incoming Resources

Income is included in the Statement of Financial Activities (SOFA) when the Church becomes entitled to the resources, and the trustees are reasonably certain they will receive the resources; and the monetary value can be measured with sufficient reliability.

Resources Expended

This is recognised when a liability is incurred, or a constructive obligation arises, that results in the payment being unavoidable. Liabilities are recognised as soon as an outflow of economic benefit is considered more likely than not under the legal or constructive obligation committing the Church to pay out resources.

- * To create a community of belonging offering pastoral care to all members and particularly those in need.
- * To serve God through our community both the community local to the church and the world-wide community.

Services are held on a Sunday morning at 10.30am catering for all ages, an evening service at 6.30pm every other week, and other services dependant on the Christian calendar. The Church is an active member of Churches Together in Central Exeter.

St Thomas Methodist Church is building on its closer links with St Thomas Parish Church as part of the Anglican Methodist Covenant and Riverside Church by sharing mission opportunities within the community.

The church premises are extensively used both by the church in the course of its arranged activities and also by a large number of community groups. Further details concerning the activities of the Church can be found on the Church website.

EVENTS OF THE LAST YEAR.

The following progress has been made in the year:

- (1) Messy Church continues as a regular feature in church life.
- (2) Boys Brigade, Guides, Rainbows and Brownies are all sponsored groups and the Church runs its own Pre-School, as well as Carers and Toddlers and a Friday Café.
- (3) Various Church groups meet during the week and other groups supporting various local community ventures meet on the premises.
- (4) Church Council acts as the Leadership Team and has developed a Sunday Stewards Team involving over 60 people.
- (5) The Church continues a social programme for members to develop their common life together. Holiday @ Home continues to grow and attract new members. It has enhanced the social and pastoral life of the Church, especially for the elderly.

- (6) The Church has responded to the needs of the local community by offering practical help and by responding to appeals to humanitarian needs across the world. It is a member of the St Thomas Community Association and has actively supported it.
- (7) The Church has responded to the needs of the community by continuing an Adult Literacy and Numeracy (ALAN) Club. This runs weekly and currently has over 60 students with 27 helpers. It has been a great joy seeing people develop their skills and confidence.
- (8) Church Council continues with its programme of decoration and enhancement of Church premises. The garden continues to bloom and attracts lots of visitors.
- (9) The Church has had the vestry redecorated
- (10) The Church has continued the work of replacing the old lighting with new LED lights
- (11) All doors in the Church have been repainted.
- (12) New outdoor lighting has been installed to add to the security of the building.
- (13) Apart from our normal acts of worship, various services have been held throughout the year, celebrating, remembering and reflecting, all involving large numbers from the community. Schools are holding their Festival celebrations here in the Church, while the Minister is actively involved in assemblies etc... within the schools. We have an active group of folk who with the Minister go into several nursing homes, conducting communions and various acts of worship.
- (14) The Church is involved with others in providing a Christmas Day lunch and social event for over 40 folk who would otherwise be alone. A Carol Service was once again conducted on this occasion to the folk and it was really appreciated.
- (15) A very successful celebration was held in the church to celebrate the one hundredth anniversary of the end of the First World war

FINANCIAL INFORMATION

The General Account for the year ended 31 August 2018 showed a surplus of £10,014 after providing an accrual of £11,318 in connection with building refurbishment in progress.

We have a policy of holding six months expenditure in reserve on the General Account and organise various fundraising projects and events to provide adequate income.

We maintain a benevolence fund which is a restricted fund to enable loans and gifts to be made at the discretion of the minister. At 31 August 2018 the balance in the Benevolent Fund was £341.
