Structure, Governance and Management

Governing document : Constitution adopted on 24 November 2017

The Charity is a trust registered as a Charitable Incorporated Organisation

Trustees are appointed as volunteers and based on their connection with the founding rationale for the charity, their experience and skills needed to pursue the objectives of the Trust, to drive strategy and also ensure effective management and governance.

Objectives and Activities

The objects of the Charity are :

a) The preservation and protection of mental health among young people residing permanently or temporarily in the South of England by the provision of help and support to such young people who have experienced or who are currently experiencing mental health problems.

b) The advancement of education of mental health issues among young people to promote understanding in the wider community.

The trustees have had regard to the guidance issued by the Charity Commission on providing a public benefit and consider that the activities undertaken fulfil the charitable purposes of the Trust.

Principal activities and review of the period:

The financial results and statement of assets and liabilities are show on page 2. In summary the Charity has generated a surplus of £38,644 during the period. Funds raised are generated by a mix of events such as sponsored runs, a tennis tournament and a music festival amongst others. In addition the Charity received a £5000 grant from CAF Toure Foundation to support the Mental Health training that the Charity funded for local schools.

The main focus for the Charity in 2017-18 was to connect with local schools and assess their needs in the arena of mental health. This resulted in being asked for two main areas of support. Firstly to provide funding for Mental Health awareness/ First Aid training and initially the trustees provided support to 3 local schools. Secondly the trustees were asked to provide funding for professional counselling to be provided to pupils. This was also provided as it was clear that there was insufficient funds within schools budgets to provide this to young people in need of help.

It has taken some time to roll out this support and much of the surplus generated in 2017-18 will become committed in 2018-19 for this purpose. In addition the trustees have reached out to 3 other local schools and are now moving towards supporting a total of 6 local schools in 2018-19. Feedback received in our follow up discussions with these schools is extremely positive and the trustees are confident that the Charity is meeting its objectives and look for new ways in 2018-19 and beyond to expand the support given not only to local schools but also local sports clubs and other youth organisations.

Financial Review

The Charity only commits funds that are already generated to ensure that it remains solvent at all times.
