Charity Staffing

Infosound employs two part-time staff - a Managing Editor and an Administrator.

The balance of the Managing Editor's working week, which comprisies overseeing all editorial policy, audio production and day-to-day running of the charity, is carried out on a voluntary basis. The Administrator, who's job includes some fundraising and publicty as well as minute-taking and other administrative tasks, also contributes her time as necessary.

Infosound has retained its small number of volunteers, who help in a variety of practical ways, including fundraising, publicity, audio work and advising, as appropriate.

All of the charity's trustees are appointed, or reappointed, by the members at Infosound's Annual General Meeting, which is held in May of each year or, if necessary, at a Trustees' meeting convened for that purpose.

Governing document

The Association is a charitable unincorporated association and the purposes and administration arrangements are set out in our constitution.

Charitable purposes

The charity's purposes, as recorded in our constitution, are to serve the needs of any person resident in the United Kingdom who is blind (severely sight-impaired) or partially-sighted (sight-impaired) or labouring under some temporary or permanent incapacity or disability which makes reading print material inaccessible to them, by the provision of information in audio and other accessible formats.

Activities and achievements

January 1st 2018 saw the launch of Infosound's new core service - a round-the-clock broadcast of news and information about living with sight loss, listeners' comments and some music, playing all day, every day for vision-impaired listeners to hear whenever it suits them. Importantly, the Infosound broadcast is complemented by an on-demand service - "Infosound Select" - which enables listeners to choose which individual current audio items they wish to hear – again whenever it is convenient for them.

Both services have been made available to hear over any landline or mobile phone, on the Infosound web site, on several specialist audio players provided by UK sight loss charities, as a podcast and on Amazon voice-controlled smart speakers.

Aware that, despite this broad array of distribution platforms, some more elderly listeners may still only be able to hear information on a CD or memory stick delivered to them, the trustees were particularly keen to maintain the free syndication of all our originally-produced content, which is equally relevant to the listeners wherever they are in the UK, to talking newspapers and magazines, radio stations and other information providers. This bring our public service information to an even wider potential listenership.

Also, with the winding-up of our own nationwide CD distribution in 2017, Infosound became a more immediate information-provider with new content able to be added at very short notice, rather than having to be limited to only offering one monthly "snapshot" of available relevant information about living with sight loss. Most notably, this new delivery structure benefited our "Audio Noticeboard" of listeners' phoned-in hints, tips, comments, opinion and news, which we were able to turn into a far more dynamic way of enabling vision-impaired people to have a much stronger voice on Infosound.

Trustee remuneration and expenses

The trustees did not receive any remuneration or expenses during the year.

Financial review and reserves policy

Infosound's trustees are mindful of its uncertain income after Spring 2019 as two major long-standing funders will cease, or be re-assessing, their contribution towards the charity's running costs. Because of this, a decision was made, early in 2017, to make savings in order to build a heathy reserve to make sure the service could remain viable for as long as possible.

During 2018, Infosound placed its main employee on part-part/part-voluntary working and appointed a part-time administrator to take on some of the non-audio production/editorship tasks. Some further slight savings were found in the charity's already paired-down running costs, building on the savings made by stopping the CD service and its comparatively costly national distribution in the previous year.

By the end of 2018 the trustees had put in place reserves able to cover more than a year's running costs.

However, the trustees are very aware of the disproportionately high level of volunteer effort that is underpinning the charity and all efforts will therefore be made throughout 2019 to address this with a concerted fundraising effort and greater partnership working across the sector. In 2019, the trustees hope to attract support from within the vision-impairment sector, which may be inclined to consider the substantial promotion Infosound is freely, and constantly, giving to the work that it does.

Medical Insurance Scheme account

Infosound runs a private group medical insurance scheme, offered by medical insurers WPA, which is available to the charity's Trustees, staff and volunteer members who wish to join. It is run on a zero-balance basis with group members paying their individual premiums to Infosound, which in turn pays WPA for the group premium. In this way, there is no cost to the charity for running this scheme. This scheme is run entirely separately from the charity's work and accounting and all funds are held in a separate bank account from the charity's operational current and savings accounts, with premiums being collected into, and paid out from, this account.

Independent Examiner's Report to the Trustees of Infosound

I report on the accounts of the charity for the year ended 31 December 2018 which are set out on pages 3 to 4.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts. The charity's trustees consider that an audit is not required for this year under section 144 of the Charities Act 2011 (the Charities Act) and that an independent examination is needed. It is my responsibility to:
