The charity is constituted as a Trust with a Trust Deed Dated 06/06/1994 as a governing document.

The charity's Objectives and activities are the prevention and alleviation of animal suffering (for further details see clause (B) of the governing document.

Achievements and performance

With planning permission we have been able to replace our 5 old pens with 11 pens and one large cat unit, from Peticular Pens, which comply with new legislation for boarding catteries, putting us well in front of any proposed future legislation on animal accommodation for animal rescue groups. The extra pens allows us to take in animals from those people who are in respite care. We have further planning permission to replace the animal utilliy room and the isolation room, which we have already laid the base for. We've continued with our ever important spaying and neutering work and education on animal welfare.
