Structure, Governance and Management

The charity is a Charitable Incorporated Organisation registered on 20 September 2016 Trustees are appointed at the AGM. Certain trustees are appointed to be responsible for specific projects and activities of the charity.

Objectives and Activities

The objects of the charity are:

- 1) To relieve the suffering of animals in need of care and attention in Turkey
- To relieve the suffering of stray animals in Turkey the main day to day activities include neutering, veterinary treatment, foster care and permanent rehoming both in Turkey and abroad.
- 3) The charity promotes humane behaviour to animals and provides education to the public pertaining to animal welfare in general

Main Achievements in the year

Fundraising

We have again produced and been successful with our yearly KAPSA UK calendar. As it is now becoming so popular, we increased the print run from 100 to 250 and sold out completely.

Another annual event that is proving successful is the Black Friday auction. Plus over £3000 was raised to recognise the 10^{th} anniversary of the Turkish charity KAPSA, through another online auction.

Neutering

We continue to actively promote the neutering programme in Kalkan, Turkey and during 2018, 187 (144 2017) dogs and 352 (304 2017) cats were neutered. Our volunteers are based both in the UK and Turkey.

Re-Homing

More dogs (12) have successfully been re-homed in the UK as a result of appeals on both the website and Friends of Kapsa Facebook page. This continues to be a growing trend.

Winter Feeding Programme

Once the tourists leave Kalkan, restaurants close and the number of locals living in Kalkan reduces, which means the food supply for the street animals decreases. As local tourism has expanded and more villas built, so has the area covered by the feeding programme. Last winter we had 68 registered dog feeders and 90 cat feeders. We were providing an average 1200 kilos per month and helping over 1000 animals. We spent in excess of 25,000 lira (around £5000) to supply the volunteers in Kalkan with sufficient food for the programme.

Veterinary Treatment

By far the biggest expense is the on-going veterinary treatment for neutering, injury from car accidents generally resulting in broken legs and hips, and illness such as parvo and distemper. Over 100,000 Turkish Lira was spent during 2018.

Thanks goes to the dedication of the trustees and volunteers both in the UK and Turkey who have helped make all this possible through their hard work and commitment.

<u>Future Plans</u>

We continue to look to expand our volunteer base and fundraising activities with new projects for 2018.
