Irene Orford Area Chair British Scouting Overseas British Scouting Overseas (BSO) provides the UK Scouting programme to young people (generally UK citizens) currently living outside the UK. We have around 3,700 members, of many different nationalities, in 62 Groups in 29 different countries throughout the world.



As global travel and work increases, BSO provides programme continuity for a young person (or adult) in their Scouting "career" as they live in different places in the world and enables uninterrupted progress towards their awards and training.



BSO is structured into four Districts (Northern Europe; France and Iberia; Middle East; and Rest of the World), supported by an Area Commissioner, a small Area Team and the UK International Commissioner. BSO is part of The UK Scout Association delivering the same 6-25 programme and Adult Support as would any UK based Area or County.

Of course, our locations bring a number of challenges, but our imaginative, talented and committed leaders and adult supporters work tirelessly to make sure young people are able to enjoy the very best that Scouting has to offer.

The overall growth of the Area continues, although a little more modest than in previous years. The nature of BSO means that we are vulnerable to changing global business plans and we can lose a number of leaders from the same Group at the same time. Therefore, whilst there will be short term fluctuations. the trend is expected to continue upwards with some exciting development initiatives within the Districts.





Our ongoing Development Plan includes developing and enhancing good working relationships with host country national associations, to forge Scouting links and to work in partnership to develop programme initiatives. Regulation and legislation change in the countries in which we operate create operational challenges for BSO and close co-operation with host country associations is vital. We already have affiliation arrangements with associations in France, Belgium and Luxembourg and recently we have

reached an accord with Oman and the United Arab Emirates.



Congratulations to all of our leaders and adult supporters who have been recognised for their contribution to Scouting. This is not only National Awards but also Service, Commissioner and local awards. It is a great step forward that consideration and recommendations for Awards have been delegated to Area and Districts and thanks to Irene and the Area Awards Panel for their hard work in promoting the Awards process and making is easier for great service to be recognised.





It is truly inspiring to see young people taking part and achieving their, Chief Scout's Awards, Queen's Scout Awards, Duke of Edinburgh's Awards and Explorer Belts— well done for your hard work. Thank you to all of the leaders who have guided and supported our young people in reaching their goals.





As BSO has grown, the DCs and their teams have worked hard to encourage a sense of belonging to their Groups and to support young people, leaders and supporters who may feel isolated. It is really encouraging to see the increasing number and range of exciting Group and District activities enjoyed by young people, and huge credit to the leaders who make this possible.

We make extensive use of technology to meet and provide support but getting together face to face, working with each other, sharing stories and experiences makes Scouting what it is. DCs make great efforts to meet their Groups despite the distances, supporting leaders and putting a real face to the name.



Thanks to members of the Area Team, Area Executive and the Area President for taking the time and making the effort to "drop in" on BSO Groups whilst they were passing on other business – it is really appreciated by the young people and adults.



Most Districts held a District Camp during the year, including Rest of the World District (well done to RoW DYC Victoria for the imaginative use of technology and time zones to get everyone together and linked online) and these have been a huge benefit to everyone involved.

The nature of BSO creates a number of challenges to provide support and training for our adult volunteers. We have developed a range of approaches for online and face to face delivery, including inter-district support, making use of our own skills rather than having to use external resources. The Area Training Team have expanded to provided more local support, and it is encouraging that since this work started, over 135 Wood Badges have been



awarded. Huge thanks to Rikki Bilverstone for driving this initiative forward



Building from last year, we have continued supporting the development of effective governance across BSO and each District now has its own executive and supporting team. It continues to be a challenge matching the requirements of BSO and the rules in host countries and we continue to support to DCs develop robust approaches which work with local circumstances. In turn this will be cascaded to individual Groups. The Area Chair, Irene Orford has established regular meetings with the District Chairs to maintain the momentum for this important work.

In July / August 2018, 120 young people and 18 adults represented BSO at the Chamboree International Camp in Cheshire. This was the biggest area-wide event so far and provided as great opportunity for young people & adults from all parts of BSO to come together. It also provided the first and only opportunity for the BSO / BGO World Scout Jamboree Contingent to get together before the Jamboree itself!





The feedback from the young people showed that they had the time of their lives, participating in a huge range of activities, making friends across Scouting - BSO certainly made a great contribution to the event



Bringing so many young people together from all over the world was a challenge, and, my thanks to the Sarah Lightfoot and the leadership team for their enthusiasm, determination and good humour in leading this highly successful event.

At the time of writing the final preparations are being made for Unit 99 - our BSO Unit - to join the adventure of the World Scout Jamboree and as this report will be presented, the first flights will be taking our young people and leaders to West Virginia USA.





36 Young People and 4 Adults are about to embark on a life changing adventure – they will make BSO and BGO proud.

The management and coordination of

the Unit has been a huge challenge and thanks to Jon Copnor, BSO Unit Leader, and his team, Becca Felgate, Mairi-Claire Dunlin and Caroline Coleman, as well as Clive Leader from the UK Contingent Support and Ben Balaam, Area

Treasurer for their hard work, perseverance and good humour in bring the Unit together.





In March 2019 60 BSO members took park in the annual Scouts and Guides Monopoly Run in London. It was a frantic and exciting weekend for all the young people and thanks to Nathan Prince for organising and co-ordinating





In May 2019 the Area Team and DCs held the annual face to face gathering during and after the Northern Europe District Camp. In addition to myself, the DCs (Dominic, Jon,

Steve & Tony), Matt Lightfoot, Rikki Bilverstone & Graham Eden were there, and it was great that John May, Area President was able to join us for part of the time.

The wide-ranging discussions explored the future strategy and direction of BSO, developing stronger support mechanisms for growing the area (and indeed what BSO might look like in 5 years' time). We also explored how BSO could incorporate the National Strategy Goals for Growth, Inclusivity, Youth Shaped and Community Impact, and shape these for the BSO context.

#### Development Plan 2018-2023

#### THEME: YOUTH SHAPED

The nature and demographics of BSO means that the age profile is skewed younger than the rest of TSA. However, it is appropriate that the emphasis of the ongoing national strategies is reflected in this strategy to better engage with young people to shape the delivery of BSO scouting. It is important to try to avoid "token" appointments; it will be essential that there are meaningful and outcome focused roles and programmes, and that appointed YCs are involved in key decision-making processes. Every young person should be able to shape their Scouting experience and we empower our adult volunteers to make this a reality at every level; Scouting is for young people and they are our reason to be. If we empower young people to drive decision-making this will stimulate new thinking

#### THEME: COMMUNITY IMPACT

BSO Scouting aims to make a positive impact on the local communities in which we operate. It is important to have excellent, transparent working relationships with host country NSOs and host country local groups and to engage, wherever possible, with local communities.

#### THEME: ADULT SUPPORT

The geographical spread of BSO creates challenges to best support adults. Imaginative and flexible use of technology helps maintain contact to isolated leaders; this needs to be continually developed. It is right and proper that young people can enjoy exciting Scouting safely and Leader training is a key aspect to ensuring high quality activities.

#### THEME: INCLUSIVITY

Every young person deserves the opportunity to take part in Scouting and BSO is working to identify and, where necessary, remove barriers to participation. BSO membership will be reflective of the wider expatriate society regardless of their ability, faith, gender, background or financial circumstances. Although the broad principle of BSO is to provide the UK Scout Programme for UK ex-pats, membership is open to all nationalities (other than, with some exceptions, host country nationals). In some areas, local circumstances require care in providing co-educational scouting and in some cases is it more appropriate that arrangements are in place to support both BGO & BSO.

#### THEME: COMMUNICATION

Effective communication is a challenge for BSO. There are numerous communication channels which need to be used effectively to engage with BSO membership, to enable young people and supporters to have access to and be able to contribute to discussions and decisions which affect them.

#### THEME: ENGAGEMENT

Although BSO is an Area of the UK Scout Association and takes an active part in national programmes, it does have to operate in a flexible way in order to comply with UK based requirements and to provide the best opportunities for young people. There is, in some areas of TSA, limited awareness of BSO and it is important to engage with other parts of TSA to make sure BSO's needs are taken into account.

#### THEME: GROWTH

In many respects, growth for BSO is opportunistic rather than something that is specifically sought. The global and national economies can significantly affect the presence & scale of ex-pat communities. In addition, the geographic spread makes the UK style approach of growth development & support impractical and there is limited capacity to support un-managed growth. Nevertheless, it is considered that there are opportunities for planned growth, in particular with International Schools

#### THEME: GOVERNANCE

Because BSO operates throughout the world, local legislation and regulation means that a flexible approach to the management and administration of Groups and Districts is required. BSO needs to develop the Executive role across the whole Area and to understand where there are variations to POR and why these are in place. The role of the Executive is often overlooked but for BSO it is important to ensure that there is awareness and management of governance arrangements which differ from normal. Also included here is data management. There is currently (Sept 2016) considerable lack of confidence in Compass data. It is important to try to rebuild faith in the system and to make sure the record data is correct

#### THEME: EVENTS AND ACTIVITIES

The wide geographical distribution of BSO provides a challenge for joint activities to develop a sense of belonging and participation. It is possible to have coordinated events organised on a District or Area basis and it has been demonstrated that young people who take part develop awareness of other scouting provision and other parts of BSO. It also provides unparalleled development for the young people themselves

There are a number of Area-wide activities that can be supported to further the core themes of the Development Plan
