Chair of Trustees' Report for the year ended 31 March 2019

Once again, it has been a huge pleasure to chair the SW Notts Scouts Executive Committee over the past year. The Committee meets about once every six weeks. I was away for two of the earlier meetings and sincere thanks to Tim Orton for chairing those meetings in my absence.

As always, the meetings have been well attended and many thanks to the District Commissioner Simon Clark, Secretary Pat Atkins, our Treasurer David Pidgeon and the other team members Jane Andrews, Andy Brown, Chris Coats, Maurice Gosling, Carmel Gummett-Kemp, Ed Hewes, Matthew Horton, Tim Orton, Chris Philips, Pete Treagus and Karen Wood, for their enthusiasm and their commitment to enabling scouting in our area.

Early in the year Stuart Kemp stepped down from the Committee and from his roles as District Scout Network Commissioner and ASL at 6th Beeston due to relocation to Finland; he was warmly thanked for his various contributions to scouting. In December Chris Coats stepped down as District Explorer Scout Commissioner and was warmly thanked for his contributions over many years; his place was ably taken by Andy Brown. At this AGM, Karen Wood steps down from the Executive Committee and she was warmly thanked for her wide-ranging contributions to scouting and especially in her role as Deputy District Commissioner. Karen will be part of the leadership team for the Euro-Jamboree taking place in Poland in 2020.

Notable achievements and milestones were reported and discussed by the Committee during the year and included the following:

The composition of the new Appointments Advisory Committee was agreed. The details of a Sponsored Walk to help raise funds were agreed and supported. Numerous other fundraising events for the International Jamboree were reported on and supported; all the required funding is now in place. SW Notts also agreed to support a Euro Jamboree to be held in Poland. Feather Flags were made available to Groups and there was a good uptake of these. It was agreed that An Outdoor Field Guide (compiled by Jonathan Tait) would be made available to Groups at a reduced cost. GDPR training was made available to Committee members and Group Section Leaders. A means of online booking for the Hemlock Campsite was put in place. SW Notts Scouts were represented at the Riverside Festival at Trent Bridge. The annual Bonfire and Fireworks on the Hemlock Campsite was extraordinarily successful this year with large numbers of participating Groups and visitors. A Water Safety Badge was instigated. Extensive plans were put in place for a St George's Day celebration; unfortunately, the day had to be cancelled because of the weather. Arrangements were put in place for a Renewal of Promises at a scout event on Dovecote Recreation Ground in June. Plans are in place for significant participation in the Hemlock Happening in Bramcote Hills Park in June. A new Sponsoring Agreement between 1st Toton (St Peter's) Scout Group and the Parish Church has been signed by all the relevant parties

The Committee has agreed to provide a new trophy to be known as "The SW Notts Scouts Development Trophy" in memory of Barrie Carter. The trophy will be awarded annually to groups or individuals who have made significant contributions to the development of scouting in our area.

We report on the accounts of the District for the year ended 31 March 2019 as follows:

Respective responsibilities of the Trustees and Examiners

The Charity's Trustees are responsible for the preparation of the accounts in accordance with the Charities Act 2011 ("The ACT"). The Trustees consider that an Audit is not required for this year under section 144 of the Act and that an independent examination is needed.

It is our responsibility to:

Examine the accounts under section 145 of the Act, To follow the applicable Directions given by the Charity Commission (under section 145(b) of the Act), and To state whether particular matters have come to my attention.

Basis of Independent Examiners' report

Our examination was carried out in accordance with general Directions given by the Charity Commissioners. An examination includes a review of the accounting records maintained by the District and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts and seeking explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit and consequently no opinion is given as to whether the accounts present a 'true and fair' view and the report is limited to those matters set out in the statement below.

Treasurer's Report for the Year to 31st March 2019

The 2018/2019 set of accounts show it has been a successful year financially with a surplus of \pounds 3,721. Receipts rose to \pounds 41,711 with a smaller increase in payments to \pounds 37,990. The reason there was a larger increase in receipts is due to the membership fees retained. The 2018/19 figure of \pounds 5,941 represents the fees collected in March 2019 and is \pounds 8,234 higher than the previous year which was affected by timing issues explained at last year's AGM

Both the amounts received and paid for Activities have increased significantly. This is mainly due to the jamboree contingent raising £11,165 towards the £14,010 paid during the year. There is one further payment to be made in 2019/20 of £3,690.

The other amounts received are similar to those in the previous year with the annual fireworks extravaganza again being a huge success producing a surplus of £5,100. The district also received a share of the proceeds of the sponsored walk, £266. A similar event has been organised for 2019 with the proceeds being retained by the groups involved apart from a nominal charge to cover the district's expenses.

Payments include the continued investment in training for leaders and grants to groups/individuals.

District running costs included our investment in feather flags to enable Scouting to be more visible at events. It also includes the Motion Picture Licence which provides cover for all the groups and units in the District.

The reserves at the end of the year are $\pounds 64,055$ of which $\pounds 5,941$ is the membership fees collected to fund the District's payments in 2019/20. The balance is somewhat above that required by the District's reserves policy and explains the Executives' decision to keep the district levy at the 2018 level in March 2019.

Five years ago I joined SW Notts as your District Commissioner. The years have flown by and I am immensely grateful to everyone for the support that I have received.

I recall my first meeting with GSLs and the District Team. I was faced with a sea of faces who were keen to find out the nature of 'the beast from the City' and what crazy plans I had for the District. I suspect they were somewhat surprised when my first 'action' was to ask them to help me do a SWOT Analysis of the District. Their discussion helped shape the development plan which has been reviewed annually since then to help us meet new challenges.

None of this would have been possible without the commitment of our leaders, helpers and trustees, all working together for the benefit of our young members – so a HUGE 'thank you' to you all for the many hours you devote to volunteering in Scouting.

We have had an exciting year with the Mega Moot camp run by County at Walesby in May last year topping the list as the highlight of the year. Several Groups attended and, despite the soaring temperatures, a fantastic time was had by Beavers, Cubs, Scouts and Explorers – not to mention the leaders! The next Mega Moot is planned for 2022.

The camp also saw Steven Tupper take on the mantle of County Commissioner from Matt Rooney. Steven has given the County Team a good "shake-up" and has been really supportive. We are delighted to welcome him to our AGM this year.

Sections across the District have had a fun-packed year. Particularly pleasing is an increase in joint activities, with leaders from different Groups/Units working together to provide a wider programme of activities. Groups have also joined forces for Camps – which is really great news. Let's do more of this sharing of resources across the District. It's good to work together and, in the process, learn from each other.

Six of our Explorer Scouts are heading off to the World Scout Jamboree in West Virginia, USA in July. They will also be visiting New York, Washington DC and then heading to Canada for Hosted Hospitality (aka Ho-Ho). Congratulations to all six attendees (and their parents) for their sterling fundraising efforts and my thanks to Karen Wood who coordinated their funding.

We have four Explorer Scouts attending the European Jamboree (Eurojam) in Poland in 2020.

Lots of Beavers spent a day at the Mega Moot in May last year and had a fantastic time. There were also loads of Beavers participating in the NESST Walk at Walesby. Colonies throughout the District have been doing more and more activities 'away from base' and it is amazing to see the increased scope of the weekly programmes offered to our Beavers by their leaders.

In addition to attending the Mega Moot, our Cubs had a fun-packed activity afternoon September. Some Packs also took part in the NESST Challenge Walk earlier this year. It has also been pleasing to see more Silver Chief Scout Awards being achieved across the District.

Nights Away for Scouts are on the increase for the second year running, with Scouts continuing to camp throughout the UK rather than predominantly locally. We have also seen Scouts camp abroad (again) this year – which is brilliant. Troops are now linking with other Groups more frequently to provide an activity, which is really encouraging. I hope this will continue.

The District played a major role in planning and participating in the Riverside Festival in August last year. It was a huge success and County HQ at Linby received loads of enquiries from potential youth members' parents and potential leaders. My special thanks to Jonathan Tait and Connor and Gabby Lynch who were a huge help when an unexpected family emergency meant I could not be there for the entire weekend.

We updated our website (<u>www.swnotts-scouts.org.uk</u>) to incorporate the new Scout Association branding. I am immensely grateful to Connor Lynch who spent many hours making the changes and tweaking elements of the site to make it more accessible. There is now an on-line booking system for Hemlock Camp Site which we would ask you to use. The Events page is a useful way to publicise District/Group events and News stories now command their own page! Simply email me details of local events and news stories and we will do the rest.

We took the bold step to cease having Section ADCs! Instead we now have five ADCs 'Support'. They are Emma Brown, Jane Peberday, Jonathan Gorham, Andy Bennett and Jonathan Tait. If you need help please get in contact with them.

Sadly our plans to re-launch our SASU – announced last year - fell at the last hurdle, but this is something we need to tackle head-on this year. We need a volunteer to take on the role of SASU Manager. If you think you can help in this way please speak to any member of the District Team.

We continue to be grateful to Trevor Robinson who, working quietly behind the scenes, does an amazing job as our District Badge Secretary. I am also grateful to Carol Eley for the amazing job she undertakes monitoring DBS renewals, chasing references for new leaders and arranging for leaders to attend Appointments Committee meetings.

There is one other leader that deserves special recognition. Karen Wood took on the role of Deputy DC in September 2014. She has been a huge support to me, and a magic sounding board for ideas for further development. When Pioneer ESU had a leadership crisis she happily took the reins of that Unit (again!) and membership has soared under her leadership. She has also recruited 2 new assistant leaders for the Unit. Earlier this year (2019) she volunteered to become a contingent leader for Eurojam 2020. She asked if she could stand down as Deputy DC to enable her to concentrate on this new challenging an time consuming role. I reluctantly accepted her decision This means she will also step down from the District Executive where she has been a highly effective Trustee. Add to that the role she took on of coordinating the fundraising for the World Scout Jamboree and you will appreciate the huge scope of her support for Scouting. We will all miss her input, but are delighted she is going to continue to spearhead

Pioneer ESU's development. So Karen, on behalf of the entire District, can I thank you for everything you have done as a member of the District team over the last four and a half years.

Close to a year ago we held a meeting with all GSLs and TAs to discuss how we'd approach training in SW Notts and agreed that we needed more volunteers to work as Training Advisers within each group. As a result, we now have 28 Training Advisers within our District (double where we were) –this level of support really is exceptional and shows just how lucky we are to have such a committed team within the District. Thanks to all the TAs for your efforts over the last 12 months.

Wood Badges

Wood Badges take considerable work to earn and it's fantastic to see 18 Leaders in our District gain theirs over the last 12 months. Congratulations to you all.

<u>Training</u>

Induction Training (the weekend course which covers all modules except First Aid) has been a real success story for Nottinghamshire and it's been great to see this well attended again this year with 5 leaders from South West Notts completing the course and a number already signed up to the November 19 course. We also had a good turn out at our District First Aid Course last November which saw 20 adults complete their training. It was especially good to have a number of Young Leaders join the course at their own request. On the flip side, Foundation & Sectional Training have been poorly attended (not just in South West Notts but across the County) and as such, the format of these is being reviewed to try and improve the support we offer to Leaders.

Looking Forward

We do still have a number of leaders who have been in role for 5 months or more and not completed their Getting Started Training as well as a number of Leaders who have been in role for 3 years or more and have not yet earned their Wood Badges. If we can work together to significantly reduce these lists, we really will be in exceptional shape.
