

This new Charter with its By-Laws allows the Society to operate in a far more modern and inclusive manner. To celebrate this milestone, the Society held various events in London in May including the first Board of Trustees meeting. I was pleased to meet with the new members of the Board along with staff and volunteers from many of our member branches at the Commonwealth Council meeting.

Last year also marked my 40th anniversary as Commonwealth President. I have seen many changes within the Society during this time and have worked and met with many inspiring people in the field of drowning prevention. I have been fortunate enough to visit at least twelve member branches on my travels to see the excellent work that is being carried out by Society members. I achieved my Bronze Medallion back in 1983 and was delighted to be presented with a commemorative medal to mark this Anniversary. I was also honoured to be awarded the King Edward VII Cup, the Society's most prestigious award for service.

Capacity building within our member branches continued throughout the year with several workshops taking place in the Asia Pacific and Caribbean regions. These workshops also offered the Society the opportunity to provide our members with the resuscitation training and CPR kits that were kindly donated by Laerdal Medical, to whom we are indebted for their support of the Society over many years.

My sincere thanks go to all our members, supporters and volunteers for your ongoing support of the Royal Life Saving Society.

For the last two years I have reported on the status of our petition for a revised Supplemental Charter, on this occasion I'm delighted to say that in May we were granted our Supplemental Charter and By-Laws. This has been a long time coming but we are finally there and can now move forward with a more inclusive way of working. I would like to express my thanks to everyone who has been involved in this lengthy process.

In April I had the opportunity to attend events around the Commonwealth Heads of Government Meeting in London. It provided me with the opportunity to meet up with other Commonwealth organisations and High Commission staff and advocate for drowning prevention.

I am extremely grateful to a small number of external supporters of the Society who agreed to be part of an informal support group that has been set up as a "think-tank" to help us identify opportunities, to advise us on options and make introductions in areas we do not currently access. The small group, currently called "Friends of RLSS" who held their inaugural meeting in September 2018 and we look forward to working with them and expanding the group during 2019.

I would like to take this opportunity to thank everyone who has supported the work of the Royal Life Saving Society during 2018 but in particular the support I have received from our volunteer Executive Director, Norman Farmer, our Treasurer, Clive Patrickson and from our three major contributing National Branches, Royal Life Saving Australia, Lifesaving Society Canada and RLSS UK.

We have a lot to look forward to in 2019. The World Conference on Drowning Prevention taking place in Durban in October, hosted by our member Lifesaving South Africa will provide us with the opportunity to meet up with colleagues and global drowning prevention experts. The Festival of Lifesaving taking place in Leeds in November, hosted by RLSS UK will ensure athletes from our members have an opportunity to compete at an international level.








- By engaging with and developing our young perople

Development Through Sport:

We will organise Commonwealth competitions that enable inclusiveness and engagement by as many countries as possible, and extend the reach of Commonwealth events beyond national organisations to State/Provincial organisations.

These events will be low in need for equipment and facilities.

Administration:

We will have effective and efficient administrative systems that support the Society's operations and activities.

We will have a system of honours to recognise the valuable contribution by our volunteers.

We will retain relevant RLSS historical records for use in research and for future reference.

Our Achievements 2018

2018 was a significant year in many respects.

In May we learnt that our petition for a Supplemental Royal Charter had been granted. This is something we have been working on for some time; our first Royal Charter was granted in 1924. In 1960, we were granted a Supplemental Charter which established our National Branches in Australia, Canada, Malaysia, New Zealand, South Africa and the United Kingdom. Our new Supplemental Charter modernises our governance and allows us to be far more inclusive.



We were able to form a new Board of Trustees under the auspices of the new Supplemental Charter which held its first meeting in London in May. It was very beneficial to have our new board together for this meeting. We also hosted a Reception on board HMS Belfast to mark the granting of the Charter.

Also in May we were able to host a dinner to celebrate the 40th Anniversary of HRH Prince Michael of Kent GCVO as our Commonwealth President.

Our Council meeting in May confirmed criteria for Membership and recognised Singapore Life Saving Society as a National Branch of the Society.

Our new Supplemental Charter and the By-laws and Regulations made under it, enabled us to create new categories of affiliation including Emerging and Community Organisations. We were pleased to welcome Brunei Beach Bunch and Botswana Lifesaving into the RLSS family. Our network now extends to encompass a total population in excess of 2.3 billion



We continued with our project to equip member branches with resuscitation training equipment. The project involved the distribution of Mini-Anne Classroom kits and a range of supporting documentation through short introductory workshops. In 2018 recipients included Jamaica, Trinidad and Tobago, St Lucia, Sri Lanka, Bangladesh, Brunei Darussalam, Pakistan, Indonesia, Thailand and Philippines. This project is generously supported by Laerdal Medical and provides training equipment in critical lifesaving skills in ten separate countries.

In February and March our Canadian member, The Lifesaving Society, supported regional development workshops in Jamaica and St Lucia and in September held another one in Trinidad and Tobago. These workshops were supported by Speedo International, The Patron's Gift and the Ontario Branch of The Lifesaving Society. The objectives of these workshops were to deliver a Lifesaving Society skills development session for Lifesaving Instructors, Examiners and Trainers, to present the RLSS Commonwealth Emerging Leadership power point presentation to Leadership Conductors, to deliver RLSS Commonwealth CPR for Low Resource Settings, and to deliver Trinidad and Tobago Lifesaving Leadership programs.









As a result of these workshops, more lifesaving organisation leaders have received training and acquired development skills which will benefit their organisations and the communities they serve.

With the intention of raising the profile of RLSS and the issue of drowning and our work in preventing it, we have been represented at various meeting with allied organisations and the Commonwealth and in April attended the Meetings and events held around the Commonwealth Heads of Government Meeting in London.

In partnership with the Asia Pacific Region of International Life Saving Federation our member branch The Life Saving Society Malaysia (LSSM) hosted In Kuala Lumpur the Asia Pacific

Drowning Prevention Workshop from 31st July through to 2nd August. The aim for days 2 and 3 of the workshop was to build stronger in-country lifesaving organisations by developing their relevant knowledge, skills, resources and techniques to enhance drowning prevention initiatives in their countries. The workshop also provided an opportunity to foster inter-organization sharing, collaboration and exchange. We were delighted that between RLSS and ILS members in the Asia Pacific region, 15 countries were represented with over 40 participants.



An outcome of the workshop is that the Malaysian Water Activity Safety Council has decided to adopt the report of the Experts developed at the Workshop and to adopt a common water safety signage system for Malaysia based on ISO 20712-1-2008, and has also given support to a proposal by LSSM for "water safety parks" in regional centres in Malaysia, the purpose of which is to carry the message of water safety to children (pre-school and early school) and the public in natural settings more effectively

We continued with our Speedo Small Grants programme to assist with our members drowning prevention projects and programmes.

In order to harness external input to our plans and operations, we formed an RLSS Network (Friends of RLSS) and held an inaugural meeting in September. Suggestions from this group have already influenced our efforts in fundraising and advocacy.

Having formed a new Board of Trustees, we introduced an Outreach programme that improves the links between RLSS and its membership across the Commonwealth. We will continue with this in coming years.

Although global drowning data has existed for some years, there is none specifically for Commonwealth countries. This information is important to underpin and support RLSS interventions. During the year we made plans to collect this data with a view to launching the results in 2019.

We started the development of a Leadership Pathway and Mentoring Framework administered by a Leadership Development Committee to guide individual and organizational leadership development within RLSS.

We continued to develop plans for Youth Engagement spearheaded by our Youth Trustee and plan to adopt a Youth Strategy in 2019.

We continued to develop a teachers/instructor's guide for the RLSS Bronze Medallion and this will be ready for launch early in 2019.



Planning is well underway for our Festival of Lifesaving to be held in Leeds, United Kingdom in November 2019 and we invited bids to host future events and an announcement will be made early in 2019 for the event in 2021. The Festival aims to encourage participation in lifesaving sport and further development of lifesaving practices, as well as bring the lifesaving family together.

Our Heritage Working Group developed a focus on the preservation of our archive with the intention of making it more readily available. It investigated the possibility of digitisation and applied for funding to support this.

RLSS Diploma

The RLSS Diploma recognises significant contributions to our life saving knowledge. It is one of the Society's oldest and most prestigious international awards. The RLSS Diploma is awarded to individuals and teams, who have added to our knowledge in ways that can save lives and prevent drowning. In 2018 the following achieved the RLSS Diploma.

RLSS Awards and Medals

The King Edward VII Cup is awarded to an individual who has made an outstanding contribution to lifesaving. In 2018 the recipient was His Royal Highness Prince Michael of Kent GCVO.

The Mountbatten Medal is awarded annually for the most gallant rescue or attempted rescue undertaken in the previous calendar year. In 2018 the recipient was Terrence Hinds of Barbados.

The Russell Medal is awarded annually for the most outstanding resuscitation or attempted resuscitation performed in the previous calendar year by a person under 18 years of age. In 2018 the recipient was Stanley McFarlane of Australia.

Collaboration

Drowning is a complex public health problem which goes without recognition or attention in many areas of greatest need. Indeed, it has been called a hidden epidemic. There are more 'at risk' populations in the world needing drowning prevention assistance than there are organisations focused on providing help. The RLSS Commonwealth drowning prevention mission needs collaboration from all national, regional and international organisations and governments to be most effective – cooperating fully for the benefit of people worldwide to reduce the global burden of drowning. Strong partnerships are key to achieving our aim of eliminating drowning in the Commonwealth and have enabled us to support our Member Branches in low resourced settings.

In 2018, key partnerships for RLSS included:

The Commonwealth - the Commonwealth is a voluntary association of 53 independent countries that are united by values enshrined in the Commonwealth Charter. Whilst the Commonwealth's roots go back to the days of the British Empire, membership of the Commonwealth today is based on free and equal voluntary co-operation. The Commonwealth Secretariat implements the decisions and plans of Commonwealth leaders.

Our 29 RLSS Member Branches who continue to work at the national and community level to reduce drowning through:

- Researching drowning and aquatic emergencies to inform practice.
- o Targeted community-based Drowning Prevention projects.
- Training the community and professionals in lifesaving skills for prevention & emergency response.
- Engaging young people in lifesaving and drowning prevention.
- $_{\odot}$ Using the sport of lifesaving to further develop skills and techniques for rescue.
- Monitoring and risk assessing aquatic environments to guarantee safe participation in safe aquatic environments.

The International Life Saving Federation (ILS). Both RLSS and RLSS Member Branches are represented on the ILS Board and on the ILS Commissions and Committees, strengthening opportunities for effective collaboration.

The Royal National Lifeboat Institution (RNLI). We continued to work with RNLI and other organisations in the development of the Basic Aquatic Survival Programme.

Develop and deliver outreach drowning prevention training programmes in Commonwealth countries in Africa.

Hosting a series of meetings in November that will include the Commonwealth Council, the Board of Trustees, and the Advisory Committee of Presidents.

Continuing with our Speedo Small Grants programme to assist with our members' drowning prevention projects and programmes where we can.

Take advantage of the opportunities arising from the RLSS Network (Friends of RLSS).

Develop our Outreach programme to improve the links between RLSS and its membership across the Commonwealth.

Develop and launch drowning data from Commonwealth countries to underpin and support RLSS interventions.

Develop and adopt a position statement on the relationship between the Sustainable Development Goals and Drowning Prevention.

Launch a teachers/instructor's guide for the RLSS Bronze Medallion.

Host a consultation workshop with the intention of developing a revised Strategy to be implemented in the coming years.

Host a Festival of Lifesaving in United Kingdom in November 2019 and work with a host to plan an event in 2021.

Continue to develop an advocacy plan including support materials and appropriate training.

Structure and Governance

RLSS is a registered Charity (Charity Commission England and Wales, Charity Number 306094), an Accredited Commonwealth Organisation and a Recognised Civil Society Organisation. HM Queen Elizabeth II is Patron of RLSS and HRH Prince Michael of Kent GCVO is President of RLSS.

RLSS is incorporated by Royal Charter dated 1924 and governed by a Supplemental Charter dated May 2018, which acts as our constitution and governing document. RLSS is governed by the RLSS Trustee Board. Our RLSS volunteer network consists of our Trustees, Officers, Committees and Working Groups.

RLSS supports and is supported by 29 Member Branches across three Commonwealth regions (Europe/Africa; Asia Pacific; Americas), all working collaboratively to deliver community-led and community-based drowning prevention programmes in nations across the Commonwealth.

RLSS maintains a formal Risk Management Policy and Register which is reviewed on a regular basis by the Board of Trustees and the Officers of the Society.

RLSS is registered with the Fundraising Regulator and is committed to ensuring all RLSS fundraising is legal, honest, open, transparent and accountable.

Financial Summary

Income

2018 total income (£71586) was up on the 2017 total income (£60579) by circa £11k, this is mainly due to income from the London events in May.

As with previous years, much of RLSS' income is currently member payments from the three largest member branches (UK, Canada and Australia). RLSS are looking to diversify income streams, exploring a range of fundraising. The Member Branches have made commitments to continue to support the administration of the Society, allowing any raised funds to be spent on programmatic activity.

Report to the trustees of The Royal Life Saving Society and to the Commonwealth Council

On accounts for the year ended 31 December 2018

The charity's trustees are responsible for the preparation of the accounts. The charity's trustees consider that an audit is not required for this year under section 144 of the Charities Act 2011 (the Charities Act) and that an independent examination is needed.
It is my responsibility to:
 examine the accounts under section 145 of the Charities Act, to follow the procedures laid down in the general Directions given by the Charity Commission (under section 145(5)(b) of the Charities Act, and to state whether particular matters have come to my attention.
My examination was carried out in accordance with general Directions given by the Charity Commission. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeking explanations from the trustees concerning any such matters.
