## ISLE ACCESS – CHAMPIONING ACCESS FOR ALL

The Trustees present their report and the financial statements of the charity for the period 15<sup>th</sup> May 2018 to 30<sup>th</sup> April 2019.

## **Objectives and Activities**

- 1. Equality and Diversity: To relieve disability by providing specialist advice, equipment or access for disabled people, families and carers living in or visiting the Isle of Wight.
- 2. Carers: To preserve and protect the health of those caring for people with physical, mental, sensory or cognitive impairment within the family or home on the Isle of Wight.
- 3. Employment: To provide employment, supported work experience and volunteering opportunities for those residents on the Isle of Wight who are excluded from or have difficulty accessing those opportunities by reason of their disability, age or infirmity.
- 4. Recreation: To promote and provide specialist recreational and exercise facilities for the benefit of the inhabitants of or those visiting the Isle of With who have need of such facilities by virtue of their age, disability or infirmity in the interests of social welfare and wellbeing and with the object of improving their conditions of life and those of their families and carers.
- 5. Work with local businesses, organisations, and tourist venues to help, advise, lobby and encourage to be more accessible to IW residents and visitors and, to embrace and develop the cause of accessibility for all.

## Structure, governance and management

The charity was established as a Charitable Incorporated Organisation (CIO) on 15<sup>th</sup> May 2018. It is governed by the trustees in accordance with the Constitution. The values behind the Constitution are to be inclusive, collaborative and transparent.

## Recruitment and appointment of new trustees

The first (founding) trustees were as notified to the charity commission. Subsequent trustees are appointed in accordance with the Constitution. Skills are drawn from a mix of personal and professional backgrounds including finance, marketing, public relations, legal, education, health services, mental health and disability. All the trustees are Isle of Wight based and all have been DBS checked.

## **Organisational structure**

The charity trustees meet at a minimum of four times per year and since the new trustees took office in January 2019 have been meeting monthly in order to move plans forward. The Chairman, Vice Chairman, Secretary and Treasurer are elected from their number.

## Induction and training of new trustees

All new trustees receive a copy of the Constitution and undertake a DBS check. Charity Commission publications for trustees are made available as appropriate.

## Public benefit statement

In setting the charity's objectives and in establishing the charity and running its activities, trustees have considered the Charity Commission's general guidance on public benefit.

## Risk

The trustees have assessed the major risks to which the charity is exposed, in particular those related to the operation and finances of the charity, and are satisfied that policies and systems are in place to mitigate any exposure to the major risks associated with seeking and obtaining funds. Budgets are set annually and monitored by the trustees.



# Message from Isle Access Chairman – Jonathan Bacon

As the new Chair of Isle Access, I am very pleased to be able to write this introduction to our Annual Report and present the news of a healthy new Charity doing excellent work in the community of the Isle of Wight. The range of activity set out in the "Activities and Main Achievements of the Year" section of the report is, in any view, impressive, for what is still a relatively small organisation and furthermore shows that the Trustees are fully committed to "Championing Access for All". However, this is just the start for us and we have ambitious (but achievable) plans to take our aims forward in both substantive activities and support as well as the provision of education and development of awareness of all aspects of accessibility.

I would like to thank both current and past trustees for their work towards achieving this success and in particular our thank our Chief Executive Officer, Jan Brookes, who had the initial idea for Isle Access and from the outset has driven the organisation forward to be what it is today.



# Activities and Main Achievements of the Year

Our first year with charity status has been busy and we have undertaken the following.

One of our main achievements has been the adapted cycling sessions we have facilitated. We have worked with the charities Wheels for All and Pedalls to bring a range of adapted bikes to the Island to hold taster sessions of accessible cycling. These have been very successful, and interest continues to increase. As well as providing the cycling opportunity we have seen people gain skills such as confidence, independence, trust and balance. Parents, friends and carers have either cycled along with the person or they have had a period of respite, with the person cycling independently. We are in the process of purchasing a fleet of bikes to keep here on the Island thanks to generous grants from Wight Aid and the Island Roads Foundation. This will allow us to offer the accessible cycling on a regular basis.

One of the cycling participants has now become the Isle of Wight's first para triathlete, entering competitions and winning. Her dream is to become a member of the UK para triathlete team.

As a result of the audits we have performed we have facilitated 3 Access Groups, in Ventnor, Cowes and Ryde. These have been very useful to identify problem areas for access within the public realm. Some issues have been addressed whilst others are still ongoing. Representatives from Isle of Wight Council, as well as the Town Councils, have been involved.

One of the highlights of our year was organising an accessible and inclusive activity day to celebrate Disabled Access Day. Located at the Island Riding Centre, various activities were available throughout the day, including the accessible bikes and horse riding for the disabled. Other local organisations were involved with stands exhibiting what they could offer to families. In addition, Hovertravel held a "try before you fly" sessions in order to promote the day overall. It was well received, and plans are underway to hold another day in September.

#### INDEPENDENT EXAMINER'S REPORT

I report on the financial statements of Isle Access for the period ended 30th April 2019, which are set out on pages 1-8

#### Respective responsibilities

The charity's trustees are responsible for the preparation of the accounts. The charity's trustees consider that an audit is not required for this year under section 144 of the Charities Act 2011 and that an independent examination is needed.

Basis of Independent Examiner's report

It is my responsibility to:

- examine the accounts under section 145 of the Charities Act,
- to follow the procedures laid down in the general Directions given by the Charity Commission (under section 145(5)(b) of the Charities Act, and
- to state whether particular matters have come to my attention.

#### Independent Examiner's statement

My examination was carried out in accordance with general Directions given by the Charity Commission. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts and seeking explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently no opinion is given as to whether the accounts present a 'true and fair' view and the report is limited to those matters set out in the statement below.

#### 1 ACCOUNTING POLICIES

1a The financial statements have been prepared in accordance with the Charities Act 2011, using

the Receipts and Payments basis available to small charities.

#### 1b Fund Accounting

Unrestricted funds are available for use at the discretion of the CIO in furtherance of its charitable objectives.

Restricted funds are subject to restrictions on their expenditure as imposed by the donor or contained in the terms of the grant.

#### 1d Incoming Resources

All voluntary giving is included in the financial statements for the period in which it is received.

Donations under Gift Aid and the associated tax recovery are recognised as income when received.

All other income is generally recognised when it is received.

#### 1e Resources Expended

Resources Expended are recognised in the period they are paid and include any attributable VAT, which cannot be recovered. They are allocated to the particular activity to which they relate.

As most of the management and activity of the CIO is carried out by volunteers, this intangible cost is not included within the financial statements as this voluntary contribution to charity is incalculable.

#### 1f Taxation

The CIO is potentially exempt from taxation in respect of income to the extent that such income and gains are applied exclusively to charitable purposes. No provision for taxation has been made in these financial statements.

#### 2 Monetary Assets

The CIO monies are not held in segregated accounts, but for the sake of this financial statement the total of each account is allocated appropriately over the various funds.

#### 3 Restricted Funds

"Restricted Funds represent income which may only be expended on the specific purpose in which they were given as imposed by the donor or contained in the terms of the grant. Any balance remaining unspent must be carried forward as a balance on that fund for future expenditure on that specific purpose or returned; it cannot be absorbed into general funds.
