TRUSTEES' REPORT - FOR THE YEAR ENDED 31st DECEMBER 2018

The Trustees present their report and accounts for the year ended 31 December 2018. The trustees have adopted the Receipts & Payments method of accounts presentation.

Structure, Governance and Management

The Charity was founded in July 1996 for the purposes defined in its Objects as below.

Recruitment & Appointment of Trustees

Trustees are selected from those members and supporters who are closely involved in the work of the Friends and who participate in Church activities in Oxborough.

Organisational structure

The Trustees are the decision making body of the Charity subject to the Annual General Meeting. The Trustees work closely with the members of Oxborough PCC, the pre-existing Parochial Church Council. The administration of the Charity is carried out through the honorary posts as listed in the Reference Information.

Objectives of the Charity

- A) to further the religious and other charitable work of the Christian community in the Parish of Oxborough
- B) to maintain, repair, renew, preserve, reconstruct and improve for the benefit of the public the fabric of the Church of St. John the Evangelist at Oxborough, its monuments, fixtures, fittings, furniture & equipment
- C) to provide or augment the stipend of the Minister of St. John the Evangelist Church at Oxborough
- D) to advance religious education & worship in accordance with the doctrine and principles of the Christian Faith

Activities & Achievements

Through the efforts of the Charity and its supporters the Church of St. John the Evangelist at Oxborough is open to worshippers & other visitors every day of the week from the middle of March until the end of October and at weekends from November to the middle of March. At least 12 services have been held in the church and The Peddars Quire sang for us in the North Aisle in the summer.

Activities & Achievements (continued)

As previously reported thieves stole the lead from the roof of the Bedingfeld Chapel in 2016. The Trustees have worked with their architect and contractor to repair the extensive damage and after some delays the work was carried out in November & December 2018.

Grants and Insurance proceeds as disclosed in these accounts (and prior years) have been received. Sufficient funds were raised to pay for all work & fees, but the work has meant a very severe reduction in the Fabric Fund.

The Trustees continue to plan for the ongoing costs of maintaining the building as advised by quinquennial reports as well as supporting the Ministry of the Parish as guided by the Charity's Objectives. The Trustees welcome all support, both large and small towards the charity's efforts to ensure the Church remains open for worshippers and visitors alike. Mindful that the necessary financial resources cannot only come from the small local community they work to obtain grant funding when required.

The Charity gratefully acknowledges the support of the Oxborough PCC, members of the local community & visitors from further afield in addition to grants from Norfolk Churches Trust, Churchcare (The Archbishop's Council) and the Bishop of Norwich' Fabric Fund. Freewill offerings, donations and specific fundraising events have taken place during the year and are vital to provide resources to enable the Charity to meet its objectives.

Financial Review

For the year ended 31 December 2018, a net deficit of £29,587 was recorded (2017 surplus of £17,761). Net assets at the end of the year amounted to £18,619 (2017: £48,206). Of the Net Assets at 31st December 2018, £9,233 is designated as a Fabric Fund for major repair projects and general repair & maintenance of the Church and Churchyard. (2017: £38,233). Further details are shown in the financial information at the end of this report. Further detail of income, expenditure and the different funds is shown in the accounts.

As all administrative efforts are voluntary the Governance Costs for the year were £Nil.

Reserves Policy

The Trustees agreed a Reserves Policy in 2008 appropriate to the work and activities of the Charity. The Trustees have agreed that a minimum reserves level of £7,000 is appropriate.
