KING'S LYNN WINTER NIGHT SHELTER TRUSTEES REPORT YEAR END 30 JUNE 2019

OBJECTIVES

The objectives of the charity are :-

The object of King's Lynn Winter Night Shelter ("the Shelter") is to provide safe overnight accommodation for homeless persons in King's Lynn during the winter. It runs a night shelter in the town for the five winter months from November to March inclusive. Guests are given a hot evening meal, a bed for the night and breakfast the following morning with as much or as little socialising as the guest wants during his or her stay. Where appropriate the Shelter signposts guests to agencies able to help them exit rough sleeping.

ACHIEVEMENTS AND PERFORMANCE

These are detailed in the Shelter's Impact Report for the 2018/19 winter.

The salient points to draw from that Report are as follows. We accommodated 97 different guests during the winter. Their lengths of stay covered the whole spectrum from one or two nights only all the way through to most of the winter. The outcomes for our guests were as follows:

10 went on to private rental accommodation, 24 to supported housing or hostels, 15 to other accommodation, 6 to prison, 2 returned to their countries of origin, 11 returned to rough sleeping and the remaining 29 are not known. During the winter months the Shelter employed four full-time staff and one part-timer, adding a further part-time staff member to help lead morning and evening shifts part way through the winter. The Shelter was splendidly assisted by 130 volunteers. Although many of them had church links, they came from all sorts of different backgrounds but were united in their desire to serve the homeless in King's Lynn.

FINANCIAL REVIEW

Full details are set out in the Statement of Financial Activity and the Balance Sheet. Both expenditure and more importantly, income exceeded budgeted projections. The Trustees finished the year with funds in hand approximately equal to two winter (i.e. when the Shelter is open to guests) months' expenditure The Trustees consider this to be a prudent level of reserves and will seek to maintain this measure during the coming year

STRUCTURE, GOVERNANCE AND MANAGEMENT

The Shelter is a Charitable Incorporated Organisation constituted by a governing document dated 21st September 2017. The operation is led by the Project Co-ordinator aided this year by an Assistant Co-ordinator.

Direction is given by the Steering Group which comprises of the Project Co-ordinator, the Trustees and representatives if member churches of King's Lynn Churches Together. The Steering Group met regularly, as did the Trustees as a separate body.

Guests are admitted to the Shelter on two criteria: first, that they are homeless and secondly that they pass the Shelter's risk assessment in order to safeguard other guests, volunteers and staff.

MEMBERSHIP AND AFFILIATIONS

Kings Lynn Winter Night Shelter is affiliate with Churches Together in King's Lynn.

KING'S LYNN WINTER NIGHT SHELTER NOTES TO THE FINANCIAL STATEMENTS YEAR END 30 JUNE 2019

1. Principal Accounting Policies

1.1 Basis of Preparation

These accounts have been prepared under the historical cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant note(s) to these accounts.

The accounts have been prepared in accordance with:

- the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 16 July 2014.
- and with the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102)
- and with the Charities Act 2011.

The charity constitutes a public benefit entity as defined by FRS 102.

1.2 Change in basis of accounting

There has been no change to the accounting policies since last year.

1.3 Changes to previous accounts

No changes have been made to accounts for previous years.

2. Accounting Policies

2.1 Incoming Resources

All income is recognised in full in the Statement of Financial Activities in the year in which it is received.

No income is shown net of expenditure.

2.2 Fund Accounting

General funds are unrestricted which are available for use as the discretion of the trustees in furtherance of general objectives of the charity and which have not been designated for other purposes.

Restricted funds are funds which are used in accordance with specific restrictions imposed by donors or which have been raised by the charity for particular purposes. The cost of raising and administering such funds are charged against the specific fund. The aim and use of each restricted fund is set out in the notes of the financial statements.

2.3 Resources Expended

All expenditure is included on an accruals basis and is recognised when the obligation is present.

The charity is not registered for VAT and accordingly expenditure is shown gross of irrecoverable VAT.
