### **Basis of accounting**

### **Incoming resources**

All incoming resources of a revenue nature are included as income to the period to which they relate to donation for the furtherance of the community around Dagenham. The mosque has been illegitimately occupied by a group of illegal group and not authorised persons. They are occupying BHIS and QASA charities premises and collecting funds illegally since 1/11/2015 till today without authority and accountability since they forcefully enter into the charity premises. They aren't depositing any money in the actual charities bank account and legal action is pending against them for financial account disclose and possession of charity premises.

### Resources expended

All expenditure is included on an accrual basis, inclusive of any VAT, which cannot be recovered. Expenditure is allocated to specific activities where the cost relates directly to that activity.

### Restricted funds

Restricted income received are accounted for separately as restricted funds and are used for the purposes specified by the donor
