REPORT OF THE TRUSTEES FOR THE YEAR ENDED 31 DECEMBER 2018

The trustees present their report with the financial statements of the charity for the year ended 31 December 2018. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015).

OBJECTIVES AND ACTIVITIES

Objectives and aims

To promote efficient cost effective and where appropriate , coordinated delivery of emergency services aid. Including , but not exclusively, provision of equipment , training and service development advice to help more effectively reduce loss of life and injuries worldwide due to, but not exclusively, fire, accidents and disasters.

The objectives to be achieved by acting as a communication hub between member organisations and donees for the procurement of equipment, materials and funds, by promoting the work of member organisations, facilitate partnerships and joint projects where appropriate and development of best practice guidance for the delivery of emergency services aid.

Public benefit

The Trustees have paid due regard to the Charity Comission guidance on public benefit when planning the charities activities.

ACHIEVEMENT AND PERFORMANCE

Charitable activities

We have recruited 3 new fire and rescue services, these are London Fire Brigade, South Yorkshire Fire and Rescue Service and Hereford + Worchester Fire and Rescue service. Each has also received training on how to use or database.

We have donated 5 fire appliances through our database.

We have recruited 4 new FIRE AID members. This brings us to 30 members.

Over the year we have gathered further data from our members so ensure that all projects have been represented on the 'Projects Map'. This has resulted in a total of 50 projects represented on the map. We used this information to produce a 'flat' map of all the countries we have worked in, including campaigns, training and delivery of equipment. (See website)

FIRE AID has 246 subscriptions, unfortunately we lost some subscriptions due to the GDPR law changes in May 2018. However, we have been using our social media channels to recruit more subscribers.

We have received over 3,000 website hits.

We now have 912 twitter followers as a result of more frequent posts and engagement with key stakeholders. This is a 29% increase since January 2018.

We now have 3 social media outlets, Facebook, Twitter and Linkedin. We mainly use Twitter to communicate with our stakeholders as we find that is where they are most active.

We have annual funding from the FIA Foundation and a yearly donation from our member AFSA. This year in relation to our HoC fundraising event we raised over £7,000 as well as receiving £3,366 income from the South Sudan project.

We have represented FIRE AID at 5 events. These are: UKRO National Challenge, UKRO Scottish Challenge (speaking at both events). AFSA Development Day, Blue Light Innovation Event, FireEX International London and the Emergency Services Show.

Charitable activities continued

We have held 2 of our own events. These are: FIRE AID fundraising dinner and FIRE AID Conference.

We have featured in 3 external publications. These have been an FIA Foundation Blog, FIRE TIMES Magazine and KFRS website. All these articles have promoted the work of FIRE AID and the benefits of UK fire services to build relationships with us.

FIRE AID has delivered 3 presentations on our work, 1 to Holmatro to secure their £2,000 sponsorship of our Fundraising Dinner, 1 to Fire Industry Association to promote our work and lastly, to the UNRSC to secure membership within the collaboration.

We are now members of the UN Road Safety Collaboration.

We have delivered our first FIRE AID independent project in South Sudan.

FINANCIAL REVIEW

Financial position

FIRE AID has core funding from the FIA Foundation and the Asian Fire Service Association (AFSA) as well as some small one-off donations.

Project specific funding is secured separately by member organisations

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The charity is controlled by its governing document, a deed of trust, and constitutes an unincorporated charity.

Recruitment and appointment of new members

Full membership of the CIO is open to not for profit organisations involved in delivering emergency services aid and who are interested in furthering its purposes, and who by applying for membership, has indicated his, her or its agreement to become a member and acceptance of the duty of members as set out in the constitution.

Affiliate membership is open to UK and international companies and other organisationa.

Duty of Trustees and members

The charity trustees are to manage the affairs of the CIO and may for that purpose exercise all powers of the CIO.

There should be no less than 2 nor more than 7 elected trustees and there should be 1 ex officio trustee (chair) and not more than 5 nominated trustees.

It is the duty of each member of the CIO to exercise his or her powers as a member of the CIO in the way he or she decides in good faith would be most likely to further the purposes of the CIO.

Decision making

Decisions of members of the CIO may be taken either by vote at a general meeting or by written resolution.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 DECEMBER 2018

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charity, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Charities Act 2011. The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Taxation

The charity is exempt from tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.
