WHO ARE WE & WHAT WE DO

We share laughter, joy and hope with the children living through disaster.

OUR VISION

is a world where every child has a childhood filled with laughter and joy.

OUR MISSION

is to use laughter to alleviate the suffering of children living through adversity in areas of crisis including refugee camps, conflict zones and situations of emergency.

Guided by the UN Convention on the Rights of the Child, we recognise laughter, play and relaxation as a stabilising force for children experiencing crisis and we are dedicated to sharing highly visual, nonverbal performances that create joyful experiences with children when they need it the most.

We also support children by creating and delivering child-centered workshops that enable children to connect with each other and that encourage play, make-believe, singing, self-expression, general silliness, and more laughing. Sustainability is important to us so we develop the capacity of local volunteers and NGO workers to deliver joyful, child-centered activities with children in crisis. We achieve this through our practical Train-the-Trainer programme.

CHARITABLE OBJECTS

The relief of need and suffering of people, particularly children, who live in areas of crisis across the world. We achieve this by:

Providing national and international progammes designed to improve the social welfare and conditions of life for children suffering from the effects of living in areas of crisis which result in poverty, trauma, dislocation, marginalisation and social or economic upheaval.

Providing playful performances as a means of psychological support to those affected by crisis and promoting and raising awareness of humanitarian issues.

RATIONALE & APPROACH

Often for the traumatised child, reality has become too serious. By sharing performances and workshops designed to encourage children to laugh and play we directly acknowledge their need for emotional support, respite and reassurance at the very worst of times. It is a way to say to children; "we see you, we care about what happens to you and you are not alone". Experts in Humanitarian Aid describe our work as "psychosocial first-aid".

We simply believe the need for joy, connection and hope is an essential part of what it means to be human.

Our performance methodology is highly inclusive and participatory. We encourage high levels of interaction that puts the children in control. Often they become the heroes of a scene. Given the levels of powerlessness all children in crisis experience creating opportunities for them to be in charge is very important to us.

Through our workshops, we create safe spaces for imaginative play. Children can sing, dance, connect with each other and most importantly of all, simply be children.

WORKING WITH VOLUNTEERS

The professional artists we work with donate their time and expertise for free. They are key to our continued success and enable us to achieve our objective of improving children's lives.

Our artists' wellbeing is extremely important to us and we have designed specific pre, during and post-project protocols to emotionally support all those who volunteer for us.

Selecting artists onto our tours is via application and interview where their experience and aptitude for managing the complexities of this work is taken into consideration.

WORKING IN PARTNERSHIP

Strategic and effective partnerships working with other NGO's continues to support our growth as a charity and our ability to share laughter and lightness with children living in some of the most challenging scenarios in the world. These relationships enable us to:

- mitigate risk for our artists
- expand our geographical reach
- maximise our resources
- received up to the minute information on specific crisis and security issues

Escaping persecution in Myanmar, an estimated 700,000 Rohingya people fled to Bangladesh and now live in refugee camps near Cox's Bazar. 49% of this community are under 18.

We supported the wellbeing of thousands of Rohingya children and their families in Cox's Bazar through our performances and workshop.

Completing five separate tours, we also shared vital safety and/or health messages through our performances. We know the best way for children (and adults) to remember anything is to make it fun, so that's what we did. We also piloted interactive feedback games after our performances to explore how we can improve our appaoch to including playful messaging in shows.

106 adults working with Rohingya Children in Child-Friendly Spaces took part in our three-day training programme focusing on facilitating child-centred games and activities.

We were invited to create a resource and capacity within the WASH Sector in Cox Bazar so children can engage more effectively (playfully) with key issues relating to hygiene and health. Our approach was to ask the Rohingya children the best way to do this. Their response; share songs, make games and pretend you're a germ. So that's what we'll be doing in 2019.

Dhaka is the world's fastest growing megacity, home to more than 17 million people. 2000 new residents move to the capital every day. Life in the city can be challenging with tens of thousands of children and their families live in informal settlements with limited access to basic amenities and education.

We shared performances and workshops with vulnerable children who attend 'Play Labs' (Children's entres) in some of the most challenging areas of Dhaka. Staff, Play Leaders and Community Caregivers took part in our four-day training programme which explored:

- The Playful and Reflective Facilitator
- Non-Violent Communication
- Leading Large Scale Activities
- Early Year Games and Activities

The clowns were also invited to take part in a national conference on Children's Mental Health where we shared a performance and presentation about our role and contribution to the wellbeing of children in the Humanitarian Sector.

Since, 2016 2e have delivered 60 performances with refugee children in Northern Greece. The conditions in the camps are basic with families being housed in tents, temporary wooden structures or metal sea containers. The camps are difficult and sometimes frightening places for children to live in (we know because they have told us).

We shared laughter with hundreds of refugee children and their parents/carers as well as delivering pre-show activities,

performances and workshops in each camp.

Our workshop methodology specifically encouraged high levels of agency as we supported children to lead activities (ours or their own) as well as inviting them to teach us and everyone else songs, dances or skills that were important to them.

Repeated visits to this area means we can tailor our performances and workshops to engage both children and adolescents.

Described as "detention centers" by the UN High Commissioner, refugee children and their families live in containers in small locked compounds in Hungary's Transit Zones. It is extremely difficult to access these sites and there are no dedicated or regular activities for children. The monotony of day-to-day life is compounded in the Summer months when no school takes places.

Spending a day at both the Tompa and Roszke site, we shared laughter and play through performances and workshops with children and their families. We supported our activities with a clownbased Resource Pack to be used by NGO workers to help build up anticipation of the clowns' arrival. The Resource Pack also supported play-based activities that could be delivered after we had left.

We were also invited to deliver a playled workshop to 20 UNHCR staff raising awareness about our child-centred approach to working with children.

The Za'atari refugee camp hosts around 80,000 Syrians who were forced to flee conflict in Syria. More than half of these refugees are children. The camp is now Jordan's fourth biggest city.

The "International Syrian Circus" was set up by ten young adults from Syria to alleviate the boredom they felt whilst at Za'atari. They want clowns to be in their circus so they asked if we could help. Of course, we said yes.

We delivered 5 days of clown training to the "International Syrian Circus".

Children were invited to be part of the activities as well as watch minisharing and performances at the end each day.

There is an important cascade element to this project as the participants from the "International Syrian Circus" shared our games and activities, via regular workshops, with over 100 children living in the camp that year.

STRUCTURE, GOVERNANCE & MANAGMENT

Clowns Without Borders UK became a registered charitable trust on 8th May 2014. Our Trust Deeds are the founding governance document for the charity. We are governed by a voluntary Board of Trustees that meets at least three times a year.

The trustees seek to ensure all our activities are within UK law and the agreed charitable objectives. They are responsible for overseeing the management of all the affairs of Clowns Without Borders UK including setting our strategic direction and agreeing our financial plan.

The trustees are responsible for preparing the Annual Report and the financial statements in accordance with UK law.

The trustees are appointed, elected or reelected for a fixed term of two years, according to procedures set out in our Trust Deeds.

Trustees are recruited following an open application and interviews are held by the Director and Trustees. Induction of Trustees is via a one-to-one meeting with the Director and each Trustee receives a Board Pack with our Annual Report, Code of Conduct and Conflict of Interest Policy. We are also members of Clowns Without Borders International (CWBI), an umbrella organisation formed of 15 international chapters with headquarters in Barcelona. We meet annually to discuss common objectives, our Ethical Charter, best practice and the Statues of Association. These meetings are an important part of the learning and knowledge transfer and sharing of expertise, governance and management between all chapters.

Clowns Without Borders International is also a Consultative Member of UNESCO in recognition of our commitment to peace, tolerance and cultural diversity. CWBI also has Memorandum of Understanding with Plan International to ensure the expedient employment of artists during/after a crisis. This marks a growing worldwide recognition of the impact and effectiveness of our work.
