# LARKFIELD COMMUNITY CHURCH TRUSTEES REPORT FOR THE YEAR ENDED 31 DECEMBER 2018

#### **AIM**

The primary aim of Larkfield Community Church is to provide a Church where every man, woman and child can understand the good news of Jesus Christ and grow in their ministry for the glory of God.

## **OBJECTIVES**

The principle objectives of the charity are:

- 1. The advancement of the Christian religion both in the UK and overseas.
- 2. The advancement, for the public benefit, of religious or other education.
- 3. The relief of the poor, sick, disabled, lonely or homeless.

The Church is a member of the Evangelical Alliance and has a longstanding relationship with "Assemblies of God (AoG) UK"; a Christian organisation that pursues similar objectives in the UK and overseas. The Church works with AoG in assisting other Churches and receives voluntary help itself where needed. During the year, 3 % of Church offerings have been given to help the objectives of AoG, which can best be done on a larger scale than Larkfield Community Church could do independently. The Church is also an active member of the local ecumenical group, Churches Together in Malling.

Directions relating to the Charity are made by the Trustees who are also the Church Elders. They meet at least bi-monthly to receive reports and financial statements detailing the opportunities and risks the Church faces, enabling them to plan or curtail activities accordingly. The Elders together with their wives, the Treasurer/Administrator and the Children and Youth Leaders form the Church Leadership Team responsible for governing the life and teaching of the Church. Day to day decisions on expenditure and activities are decided by the Trustees. The powers of appointment or removal of Trustees rests with the Trustees. Trustees are selected from the Church, since this means the Trustee body is whole heartedly involved in seeing the mission of the Church worked out in practice. The Church has an operational Safeguarding Policy approved by the Thirtyone:eight Safeguarding Organisation and is reviewed annually by the Church Safeguarding Lead.

The Lead Elder (Ministerial status with the AoG) is in receipt of a full work pension. He has agreed with the other Trustees to serve the Church in a voluntary capacity and thus allow funds to be directed where needed.

Since September 2015 the Church has employed an experienced Youth Worker on a PAYE part time basis (20 hours per week) to provide youth work within the Church and in some local Primary and Secondary Schools (clubs, activities, assemblies, mentoring). Following a period of maternity leave the Youth Worker resigned in September 2018. The role was covered by volunteers until a new Youth Worker was appointed in January 2019 under the same conditions. Due to a potential conflict of interest the Lead Elder took no part in the appointment process of the new Youth Worker and the Charity Commission was informed.

From January 2016 the Church combined the Treasurer and Administration role and employed someone on a PAYE part time basis (8 hours per week) to fulfil this function.

Also From January 2016 the Church employed a Caretaker/Cleaner on a PAYE part time basis (8 hours per week) to clean and service the church building (The Dorcas Centre).

From March 2018 the Church employed an experienced Children's Leader on a PAYE part time basis (10 hours per week) to fulfil this function.

It is the work of every member of the Church, whether receiving some remuneration or not, that will make the difference in the Church achieving its aims. This is done through being 'salt and light' in their community, amongst the people they interact with every day; by praying, by visiting the sick and others in need, in being involved in training others, in public teaching and worship, and also in administration. The financial resources of the Church are given by the members and their private assets and equipment are regularly used in the work of the Church. Much of this work is done privately, without recognition, and the hours and value of that time cannot be quantified.

### **ACHIEVEMENTS AND PERFORMANCE**

The Church met in Lunsford Primary School hall on the Brookfield School Site each Sunday morning for sung worship, prayer and bible teaching, including bespoke teaching groups called, '7 Up, J Team and J Tots' for teenagers, juniors and toddlers respectively. A crèche facility was also available. Some Church members also met mid—week in someone's home called, 'House Group' for further fellowship, prayer and bible teaching. Through the lighter months the Church held several additional evening services that included worship, teaching, prayer and a light meal. The Church continued to build on a strong relationship with the 3 Primary Schools that are on the site and, as in previous years, helped them to raise funds at their annual summer fetes.

The Church lease a double classroom sized timber building from Kent County Council called, 'The Dorcas Centre' located on the School site for use during the week. This building was derelict, but has been completely restored by the Church. It is maintained by a part-time paid Caretaker/Cleaner and volunteers from the Church. Mid-week Church activities included:

- Men's/Women's breakfasts (every other month) free breakfast and guest speaker.
- A popular mid-week breakfast club called 'Brekkie Time' free bacon roll/toast and drink; this is a 'drop in' club for parents and children who attend the on-site Schools.
- A mid-week Morning Prayer group.
- A Food Bank (see below).
- A lunch time club called, 'Kingsquad' for the children of Brookfield Junior School.
- A Youth Group on a Friday called, 'Boost' for school years 7-9 and 'Haribos' for those in school year 10 and upwards.
- An Alpha Course a 16 week course held midweek mornings exploring the basics of Christian Faith.

The Dorcas Centre was also made available for use free of charge to the Schools on the site and other community groups such as a Child Minders weekly coffee morning, a weekly elderly 'craft and chat' group and the Girl Guides.

The Church partnered with and gave some funding and/or volunteers to:

- Just One an outreach event at Gillingham Football Ground (over 5000 people in attendance) led by internationally renowned evangelist Canon J. John and sponsored by many churches across Kent.
- Churches and Schools Together (CAST) 3 church members volunteer/work for this charity that provide lunch clubs, student mentoring schemes and prayer/reflection spaces in local Secondary Schools.
- The Family Trust 3 Church members work for this Charity in providing lunch time / after school Christian clubs and assemblies in Primary Schools.
- Street Pastors 2 Church members are Street Pastors in Maidstone.
- A newspaper publication called, 'New Life' (50 copies per month) of uplifting stories for inmates of HMP Elmley.
- Dynamic Future Together Community Interest Company a not for profit company who use
  the Dorcas Centre free of charge to provide, 'Let's do Lunch', a lunch club for senior
  citizens. At least 7 Church members regularly volunteer with this work alongside people
  from other Churches and the community.
- Trussell Trust Food Bank in February 2015 the Church joined a successful Medway Food Bank scheme and appointed a volunteer Centre Manager and several volunteer staff who provide emergency food on a voucher scheme basis to those in financial crisis.
- Maidstone Christian Cancer Care Support Group that offers both practical and prayer support to people (not just Christians) living with cancer.

The Trustees have complied with the duty under the Charities Acts to have due regard to the public benefit guidance published by the Charity Commission.

### PLANS FOR THE NEW YEAR

The key strategies for the Church are to remain the same, however through 2018 the Trustees, following an approach by the Anglican Church, have explored the opportunity to meet in the larger Larkfield Parish Church building to facilitate further church growth. Significant investment would need to be made to make the building multi-functional and fit for purpose e.g. running water, heating, lighting, toilets, kitchen and a children's area. Following initial positive responses between Churches a Working Party was set up of members from both Churches to explore the options. Alas, the parish church council decided ultimately they did not want to make any changes and negotiations ended. The search for a larger building facility continues.

### **FINANCIAL REVIEW**

Finances required to fund the activities are raised through regular giving and one off donations from Church members, supplemented by the refund of income tax from HM Revenue and Customs through the Gift Aid Scheme. Church membership continues to increase and its members continue to give generously enabling the Church to have the confidence to use some of its surplus reserves to fulfil its vision.

General Fund receipts for the year were £41,053 (2017: £44,670) with General fund expenditure amounting to £38,079 (2017: £38,321) resulting in a surplus for the year of £2974. Funds carried forward at the year-end (excluding the below) amounted to £23,469.

In the final quarter of the year the Church received £105,929 from Manna Trust which was a <u>third</u> share from the sale of a property called Elmcroft held in Trust by their 'Mother' Church (originally Manna Christian Fellowship, now called The Life Church, Maidstone).

Originally 4 AoG churches made up Manna, namely, Bearsted Community Church (now Connect Church), The Life Church, Grace Community Church and Larkfield Community Church. The longstanding agreement between the churches was that when Elmcroft was sold the proceeds would be divided equally between the 4 churches. Just prior to the sale money being received however Connect Church formerly ceased being an AoG church and joined another network of churches. This resulted in the money from Elmcroft temporarily being divided 3 ways (excluding Connect Church) until their position was clarified. In January 2019 each church gave Connect Church their entitled share (£26482 each). Effectively each church benefitted from the sale of Elmcroft by £79,446.

The Trustees decided to invest this Elmcroft money and consider it as part of their 'Vision Fund'. Considering this and the fact that offerings were slightly down on 2017, the Trustees decided not to set aside their usual 10% of the Churches annual income in 2018 into their vision fund.

The Trustees have set a policy of retaining £5,000 reserves, sufficient for the foreseeable needs of the Church.

# **GRANT MAKING POLICY**

Gifts to external organisations and individuals are considered by the Trustees on the basis of need and fulfilment of the charitable objectives. There are no upper or lower limits of support. They are generally reactive to requests after careful consideration.

### **RISK MANAGEMENT**

All major insurable risks are subject to Public and Employer's Liability Insurance. Contractual risks are reviewed before being entered into to assess that they could not significantly impact upon the Churches ability to fulfil its objectives. An annual review of areas of risk is undertaken by the Trustees in conjunction with volunteers responsible for the area of activity.

#### STATEMENT OF TRUSTEES RESPONSIBILITIES

Charity law requires the Trustees to prepare accounts for each financial year which give a true and fair view of the state of affairs of the Charity and of the profit and loss of the Charity for that period. In preparing these accounts, the Trustees are required to:-

- Select suitable accounting policies and then apply them consistently.
- Make adjustments and estimates that are reasonable and prudent.
