Our efforts at the Bakau Community Centre to upgrade the toilet facilities have been rewarded in the sense that our tiny efforts attracted the attention of the Village Development Committee, which has released funding and is currently doing major renovations. We are hopeful that they will restore the library we set up about 6 years ago.				
	It would be positive if we could respond to BFA as we are the captains of the Books for Africa project to The Gambia, but this depends on the success of our applications for funding. Fundraising efforts have largely failed so far. The main sponsor has cut funding to half
