As I have been with you in the various building on this site that people have lovingly built
As I have been with you in the planting of churches in Brook Boughton S Ashford, Willsborough
As I have been with you through the ministries of preachers and leaders, through good and tough times,
As I have been with you in Christendom when the church has thrived in the west

I am now with you as you in secular Britain, as you are marginalised as you are small and seemingly insignificant-but remember just like Israel in Deuteronomy 7;7 God wasn't attracted to you and didn't choose you because you were big and important—the fact is, there was almost nothing to you. He did it out of sheer love, keeping the promise he made to your ancestors. was when I chose them-as Jesus chose us to go and bear fruit that will last

So, I am with you as you stand at the river and look out on these new congregations these 3 missional communities in the areas you live-as I was with Moses, so I am with you.

Throughout Lent and up to an early Easter, as well as engaging in understanding what missional communities might mean for us, we looked at another mini series titled "What does it mean To Be Human"? The human condition of everyone born, made in the image of God with the capacity to be heroic and villains, this dilemma struggle of our nature and that God came in Jesus Christ to rescue and free us brought us close to God given us a new heart so that we can hear and receive and love God and serve God in the world. We are given a new identity which is forward looking at all Gods wants to do in and through me in Gods dream for the world. To be alive to Gods call in Jesus Christ to follow Jesus and make disciples of all nations, looking to that day when we will fully be restored renewed and with Christ for ever and until then we are drawn upwards and onwards by the Spirit as God transforms us into Gods image.

In Lent too we joined together for the last time at Brook chapel for a service of thanksgiving for the ministry in the village where on two sites for 100years there has been a Christian witness. Come to give thanks for lives changed

for love share for mission fellowship and gave thanks that as the chapel is sold that God story of love and salvation goes on that Gods living word does not return empty but will continue and grow. [Isaiah 55;8-13]

At Easter, we took our services and outreach into the town centre at the bandstand using visuals music art and participation, as well as words trusting that the holy spirit would work in people's lives. After Easter and before the summer life groups and missional communities continued-Life Groups being small gatherings where we can "do life together" "with Jesus together" -Jesus called his disciples to be with him. being together with Jesus Mark 3;14 and sent out together to those around us. The Missional Communities are the wider geographical area in which the life groups meet- with around 40 or so people connected with Jesus and each other putting down roots where we live.

On Sundays after Easter we spent considerable time exploring both biblically and through the Fresh expressions of church course the possible future shape of mission and ministry at ABC, discussing it in our missional communities after the sermon and sensing with God the way ahead for Gods church in a secular age how to live amongst connect with and build relevant worshipping communities. What could this look like as a town centre church and in our communities in Ashford, taking time to listen, to research to spies out the land gather information and pray much! We explored God doing anew thing through the early church in Acts and through the later stages of Isaiah from 40/43/55/61 as God prepares the people for a new work Gods is doing. It was with great joy and celebration that we baptised three people in July Surbadoer Kaziman, Mark Cripps and Megan Taylor.

In early summer the brigades and youth camp successfully took place in warmer conditions than 2017! Summer saw the holiday club returned and gathered many workers and children young people in fun and conversations about Jesus. This theme continued through all age services during the summer holiday and some of our young people went to summer camp Soul Survivor. Boughton chapel had a work party week to spruce up the outside in preparation for the car park surface that was laid later in the autumn. A BBQ at the manse for the whole church capped off a summer of lots of activity!

The autumn term we celebrated Gods faithfulness again to us in our harvest services at ABC Boughton, Seniors support team and new this year the missional community gathered at the farm, where some of our members live and work- celebrating with the seasonal workers and owners the gathering of the harvest, through song food and community. On Sundays a series from 2 Corinthians run throughout up until Christmas alongside on Sunday sessions exploring how to listen for mission where we live and have our roots, as part of the 3 wider missional community gatherings, in addition to preparing ourselves for training for the winter night shelter which we will be a part of again after Christmas. In December we spread out into the town centre again as well as in our missional communities, Park Farm Care Centre and Longacre's Bybrook garden centre bringing good news about Christs birth, God with us.

So, we give thanks for Gods faithfulness and mercies, Gods leading, for the gift of life and for one another. We thank God for the continued love, hard work calling and dedication of so many brothers and sisters, and for small foundational beginnings in mission and community living. We continue to face the opportunity and challenge to organise, use our resources and give our lives that a traditional baptist church like Ashford, can become a living movement of people who say yes to Jesus call to *follow him* and *go into all the world and make disciples of all nations, to go ...and surely I will be you to the very end of the age.* Matthew 28.

Annual Report and Accounts for the year ending 31st December 2018

The Trustees of Ashford Baptist Church have pleasure in presenting their Financial Report for the year ending 31st December 2018.

Investment Powers

The Church's Trust Deed authorises the Trustees to make and hold investments using the general funds. At the end of the year there was a current account held at Lloyds TSB with a balance of £32,707 and at HSBC a current account with a balance of £10,894 and an Instant Savings account holding £114,216.

Aims and Organisation

Ashford Baptist Church has as its primary aim "To propagate the Gospel and teaching of Jesus Christ and to express that teaching in practical action."

The Church operates in the Borough of Ashford, Kent, based at St John's Lane/Station Road, and in the mission Church of Boughton Aluph. During this accounting period we have sold the chapel in Brook which generated £293,685.

It employed in 2018 joint Ministers, Revds Lorna and Rob Sylvester and also an Administrator who works part-time in the Church office, helping to co-ordinate the life of the Church. These were supported by 6 deacons, the Church Secretary and the Church Treasurer.

Review of Financial Activities and Affairs

The Church is financially dependent on the voluntary support of its members. Gross voluntary income for all purposes, receipts (including legacies) for the year amounted to £182,752. This is a increase of £7,394 over the previous year. Regular donations were sent to Baptist World Mission and Home Mission. Altogether we gave £27,934 to these and other causes.

The conditions governing the proceeds from the sale of Brook Chapel require that these funds be held in a Baptist Together Trust fund. Ashford Baptist Church can draw upon these funds for designated 'capital projects'. This financial period we have replaced Church windows and applied for planning consent to improve the building. This has reduced the balance held in the BU Trust Account to £226,916.

The financial position of the Church at 31st December 2018 showed a surplus of £4,186. This is an decrease of £14,106 on the previous year.

All the Church's assets are employed directly in pursuing the charitable objectives of the Church.

Payment to/in respect of Trustees

No expenses were paid to Trustees during the year but they were reimbursed for materials and postage.

Conclusion

Financially 2018 was a settled year, with income steady and expenses overall in line with budget. The main reason for the surplus made was that we have capitalised the dishwasher (£2,119) and the Church Projector (£5,024).

We are, as always, thankful to God for giving us people, whose service to Him, is seen on a day-to-day basis, but we must not forget those whose work is often not seen but is equally important in the running of the Church.

Our Church faces many significant challenges, especially that of a growing town. We continue to see new people coming to our Church and finding a spiritual home amongst us. We pray that this will continue to happen. However, we cannot sit still, but must take every opportunity to go out and give everybody the opportunity to know the great joy that comes from knowing our Lord and Saviour Jesus Christ. To that end our Ministers started to progress the vision for future activity in the neighbourhoods and communities that make up the town of Ashford as well as its surrounding villages. We also continued our witness in the town centre through Easter and Christmas open air events at the bandstand.

Once again, I would like to thank everybody for their support and encouragement given to me during this, my first year as Treasurer. The role can be both demanding and time-consuming, but it still gives me a feeling of great satisfaction and makes me feel that perhaps I am, in some small way, serving the God who has blessed me in so many ways.

Trustees Responsibilities

Under the Charities Act 1993 the Trustees are required to prepare a statement of accounts for each financial year which gives a true and fair view of the state of affairs of the charity at the end of the financial year and the incoming resources and application of resources in the year. In preparing the statement the Trustees are required to:-

- 1. Select suitable accounting policies and apply them consistently.
- 2. Make judgements and estimates that are reasonable and prudent.
- State whether applicable accounting standards and statements of recommended practices have been followed, subject to any material departures disclosed and explained in the statement of accounts.
- 4. Prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue its operations.

The Trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charity at that time and to enable the Trustees to ensure that any statement of account prepared by them complies with the regulations under Section 42(1) of the Charities Act 1992. They are also responsible for safe-guarding the assets of the trust and hence for taking reasonable steps for the prevention of fraud and other irregularities.

CHURCH SECRETARY'S REPORT 2018

Text for 2018: "Be strong and courageous. Do not be afraid; do not be discouraged, for the Lord your God will be with you wherever you go." Joshua 1: 9.

2018 will be remembered by many of us as a sad year as we had to say "Goodbye" to several dear friends who had completed long, faith-filled lives of service. We thank God for our memories of them and their wonderful examples to us through the years. These sad times were balanced by some joyous ones as we witnessed the arrival of new babies; the dedication of young children; four baptisms and a wedding. We thank God for His presence with us in all the seasons of life.

2018 was also the year when we marked the conclusion of the work and witness of Brook Chapel. The work there had begun in 1898 when some Christians from ABC had held an open air meeting. Seven years later the congregation that had grown there began to meet in the old forge amongst the old horse shoes. There were ups and downs through the years with many lives touched. It was a training ground for apprentice preachers including some who would go on to full-time ministry. The last service of public worship was held in January 2004 and, in the following years became a place for "away days" and ministers' meetings with its final years of use by the parish council which moved out in 2016. The building was deteriorating so the decision was made to formally close and then sell the chapel. This took place in the spring. It is now a private house.

One mission closed but the church's call to mission began to be expressed in new ways throughout the areas of the town as we began missional communities and life groups. By the end of the year we were able to take the Christmas message to two more venues as well as the High Street. We are also pleased to use our building missionally by hosting Street Pastors and Kent Refugee Action Network.

Our links with BMS have been strengthened as we welcomed an Action Team in May and later in the year, decided to link with serving missionaries in Peru (continuing friendship with the Clarks who were at SABC), Kosovo (continuing support of the work where the Jakemans had served) and Nepal (building on a link made during our ministers' Sabbatical visit in 2017).

Our appreciation needs to be expressed to all those who serve among our children and young people. Sunday group leaders; GB and BB teams; holiday club week; Soul Survivor leaders have been wonderful gifts of God to His church.

Another gift of God to us has been the arrival of Natalie to the church office. Our times are certainly in His hands! God was clearly at work in the way that He brought Natalie to us at exactly the time that Djamila began her maternity leave.

There is also another ending and beginning as I now step down from this role of church secretary. In January I felt strongly that this was to be my final one. It has been a real privilege to have been a deacon and then secretary of ABC and I am ever grateful for all the support that you have been to me.

BOUGHTON REPORT FOR 2018

The chapel has continued to hold services each Sunday and have Coffee Break and Lunch Club monthly. At the services we miss Brenda Barrett who has moved to Scotland to be nearer to one of her sons and, although leaving her home in Kennington was a wrench, she now has more immediate family support if it should be needed. Apart from Brenda those attending remain the same as last year. This can also be said for Coffee Break but Lunch Club has seen a few additions, filling spaces lost last year. One member who is no longer able to come because of back problems used to have a meal as Alan took one to his home in the village. However, he has now moved to Brambles care home in Wye. Thanks to Heidi and Alan, with assistance from Carol, Rose, Joyce and Joan, we could provide a few more meals and so we shall see how things develop. This is our primary outreach in the village and so it needs to be as effective as we can make it.

The other item for report is that the car park is now usable. This could mean other openings for use of the premises because the chapel could be made available to others. So far the deacons have had days apart there and there has also been a meeting of the trustees of "Uprising". The car park has made the chapel more visible to passing traffic and it will be enhanced when the revised front access has been completed. It would be good if there could be greater use made of the premises and it may be that having Coffee Break outside during warmer months will be a form of advertisement.

As always we are grateful to all who lead our services and it is good to have one of our ministers leading the monthly communion. There are no preaching team meetings now but the same members continue to lead our services together with Rev Ambrose Oliver and we have had additional input from Stewart French, known to those who attend coffee morning and Lite Bite at Station Road. We are grateful to all who are willing to use their Sunday afternoons to help us.

Looking ahead some houses are being built on the Wye Road and we shall want to contact those who occupy them when they are completed. The close proximity of the chapel might be convenient for any who are looking for a place of worship or who might be interested in a coffee morning midweek. Otherwise we trust that God's will may be done and that we may be responsive to any change that he brings. Any who want to join us at worship will be very welcome.

SAFEGUARDING REPORT 2018

I am delighted to report that almost all of our workers with children, youth and seniors have undertaken training in the past year: 7 in April at Canterbury BC and 37 on 6 October here at ABC. It was helpful to have input on the many aspects of Safeguarding that impact our senior members as well as up-dated information relating to children including the dangers of grooming these days.

As is often the case with good training a requirement for more action is identified. The two main challenges for us this time are the needs to ensure the presence of a trained First Aider at all our activities and to ensure that written Risk Assessments are undertaken by all our organisations. First Aid training is now being planned to take place in 2019. Those leaders familiar with Risk Assessments are sharing their experience and the resulting written RAs are now being stored centrally in the church office.

There has been no need to report any concerns to outside agencies in 2018. However two reports were made, which involved children with Additional Needs, from which we have learned. These reports were investigated and internal action taken. A course organised by Urban Saints on Inclusion proved to be relevant and helpful and has given us yet another opportunity. Should we appoint a "Champion" for those with Additional Needs: someone who would make more of us aware of the challenges that some of our children and their parents face?

At the May CMM we agreed to adopt the up-dated Baptist Union Safe to Grow policy and guidelines. This policy statement is now displayed on the rota notice board next to the crèche. Full guidelines and downloadable resources are available on the Baptists Together website: www.baptist.org.uk

Routine safeguarding action is required by us all every week especially as parents collect their children from their groups. Exits should be secure and children should not return to empty unsupervised rooms.

ABC is blessed to have such conscientious workers with our children, young people and senior members. I would like to take this opportunity to express our gratitude for all that they do.

NOTES TO THE FINANCIAL STATEMENTS

FOR THE YEAR ENDED 31ST DECEMBER 2018

1. ACCOUNTING POLICIES

Basis of preparation of financial statements

The financial statements have been prepared to give a true and fair view and have departed from the Charities (Accounts and Reports) Regulations 2008 only to the extent required to provide a 'true and fair' view. This departure has involved following the Charities SORP (FRS102) published on 16 July 2014 rather than the Accounting and Reporting by Charities: Statement of Recommended Practice effective from 1 April 2005 which has since been withdrawn.

The financial statements have been prepared under the historical cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant notes to these accounts. The financial statements have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 16 July 2014 and Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and Charities Act 2011.

Ashford Baptist Church constitutes a public benefit entity as defined by FRS102.

Fund Accounting

General Funds are unrestricted funds which are available for use at the discretion of the Trustees in furtherance of the general objectives of the charity and which have not been designated for other purposes

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors. The costs of raising and administering such funds are charged against the specific fund. The aim and use of each restricted fund is set out in the notes to the financial statements.

Income

Non-covenanted donations and other income are brought into income in the year during which they are received, with the exception of donations given for a specific purpose which are carried forward as deferred income and matched with the relevant expenditure. Legacies are credited to the income and expenditure account in the year in which they are received.

Expenditure

Specific items of expenditure that relate to either direct charitable expenditure or other expenditure are attributed to the appropriate category. Items of expenditure which involve more than one category are apportioned on the following basis:

Manse Expenses - 25 % direct charitable, 75 % management and administration

All expenditure is inclusive of irrecoverable VAT.

Depreciation

Depreciation is provided to write off the cost of the asset over its estimated useful economic life.

Assets are depreciated at the following rates:

Computer Equipment at 33.3 % on Cost

Fixtures, fittings and equipment at 15 % on Written Down Value

Motor Vehicles at 20 % on Cost

Depreciation is provided at rates calculated to write off the cost of each asset over its useful life. Items of equipment are capitalised where the purchase price exceeds £250.
