

# Trustees' Annual Report 2018

In line with Charity Commission requirements, our Trustees have ensured that our activities have the widest possible public benefit, whether in the Christian or Youth Work operations. Assets and resources have been used to further the Objects of the Constitution and the specified Mission Statements adopted by Trustees in past years. Funds have been ethically sourced, and control of finances maintained. Legal rules have been complied with and relevant policies adopted or updated, each specifically approved by Trustees.

Open access for all our events and activities has been applied in line with our Equal Opportunities policy and our underlying Christian principles.

In November our Chair, Margaret Taylor was forced to step down from the role due to pressure of work. Our Vice Chair, Linda Cunningham has taken over the Chair responsibilities until the 2019 AGM in March of that year. Margaret takes with her our sincere thanks for the work she has done during 2018. Chris McIntosh retired from his Treasurer's role in October after using his skills to review our financial procedures and operating processes. Thanks to him for his work and the smooth handover to Keith Taylor, a very experienced Accountant and Financial Auditor, who has taken up the post. Heather Turner took over the HCT Secretary role and, together with Keith Taylor and Linda Cunningham are very welcome additions to the Trustees list. Darren Byford, a local Councillor, and Joanne Davis, an experienced Youth Work Practitioner have been appointed as Co-opted Trustees. Darren replaced Councillor Janet Holmes who retired after many years of helpful support and guidance. Margaret Strong, a retired Safeguarding Expert, took up the vital role of Safeguarding Officer. John Gallaghers' new role dealing with fundraising bids and other important matters has been very successful as shown in the financial section of the report.

The United Service was supported by all our churches. The 2018 United Service took place in January at St Andrews Church, Netherton led by Father John Geary.

Last year's Forum was a great success at Horbury Methodist Church, and we thank our guest speakers, Flora and Dick Davis for their talk on There is no "them" only "us" – welcoming asylum seekers and refugees

On Good Friday, 30<sup>th</sup> March, we attended a "Tenebrae" service at St Peters, led by Father Christopher Johnson. We distributed Easter eggs to the Community in the Co-op on Easter Saturday with HCT leaflets to reach out to our community. We strongly believe being involved with our community is part of our work.

Christian Aid Week went very well raising £3,000. Thanks to all the Churches for contributing and particularly to Carole Shaw, our Christian Aid Group Chair for all her hard work organising and supporting our Churches with various Christian Aid activities.

In May we held our free Whit Community Party at Horbury Academy including games, a bouncy castle, BBQ, archery, cake and much more! It was a fantastic success and circa 200 people attended. We hope to build on this year's success with another Community Whit Party at the end of May 2019.

In September, we held our now annual community Quiz Night at St Johns Church, led by our quizmaster, Mark Hunter. The evening was very useful in bringing people together in a fun and challenging way.

Christmas carol singing took place in the Co-Op, where we reach out to the community and hand out service times and chocolates for the children. This is always a joyous occasion at the end of our calendar of events

Services continued to be held at the residential homes in the area and are very well received by people who gain much from the communal singing, company and encouragement that they get.

Our grateful thanks go to Heather Turner for compiling and editing the monthly newsletter. We have widened leaflet distribution community to keep informed of HCT news and church community events.

The Horbury Breakthrough Youth Project has had a busy and successful year with 699 young people accessing the project in some way. Our staff team have now been with the project for two years and have an excellent work ethic and lead well. We have twenty-two volunteers, all actively involved on a regular basis, plus a further twenty-seven young representatives / officers / youth trustees. Skills development has been a key theme during the year, widening our options.

We are now running seventeen weekly sessions, six residentials, fundraising activities, school lessons, self-esteem groups, Duke of Edinburgh Awards and much more. Special events and trips included a Church Sleepover, York Dungeon, Indoor Go-Karting, LaserZone, Hesley Wood Scout Activity Centre residential – including archery, and rock climbing, seaside day trip, camping - including kayaking, Alton Towers, North Yorkshire Water Park, Go Ape, outdoor laser combat game, bowling and food, Escape Rooms, sledging, wheelchair basketball. Our young people joined partner residentials including Aire and Calder Methodist Circuit residential and the Horbury and South Ossett Phoenix Rotary Club's Youth Leadership Award. The annual Celebration of Young People Awards night took place in July and the Youth Lunch took place in November at Horbury Methodist Church with inclusive entertainment by young people. We feel it is right to

have people from different generations in our community mixing together for food and enjoyment. Excellent relationships exist with Horbury Academy, Wakefield MDC, The National Coal Mining Museum, Young Lives Consortium, Huddersfield and Leeds Trinity Universities, local Churches and other partners.

The position of Treasurer transferred from Chris McIntosh to Keith Taylor in October 2018 and thanks are due to Chris for work in 2017/2018 and his assistance during and since the handover.

2018 was another successful year in financial terms, with Total Bank and Cash Balances increasing by £14,587 from £37,624 to £52,211; with total receipts £101,976 (2017 £102,683) and total payments £87,389 (2017 £86,656). The Big Lottery Fund grant of £59,003 represented 58% of the total receipts in 2018. The Trustees are actively looking for sources of income to reduce the dependency on the Big Lottery Grant.

Other external Donations and Grants of £23,000, from Aire Calder Methodist Circuit (£1,500), Garfield Weston Foundation (£10,000), Leeds Methodist District Advance Fund (£5,000), Wakefield Metropolitan District Council (£2,500) and Wakefield Diocesan Family and Social Welfare Fund – Wakefield and Huddersfield Episcopal Area (£4,000), were a further 23% of the total receipts. A special thank you to John Gallagher for all his hard work in submitting the various claim forms and of course we mustn't forget all the various external organisations that have supported us in 2018 and in previous years.

Numerous Fund-raising activities and Events throughout the year, including The Asda bag pack, Awards night, Fashion Show, Forum, Great North Run, Quiz night, Snowden sponsorship, Street collections, Whit event and the Youth lunch, generated £8,751 representing 8% of the total receipts. Regular Donations from several loyal individuals together with our own Churches generated £5,693, representing 6% of the total receipts. Our heartfelt thanks to everybody who has supported Horbury Churches Together in this way. Activity contributions by our youth people towards the cost of activities including The Duke of Edinburgh award, archery and various holiday activities, generated £5,504, representing 5% of the total receipts.

Payments in 2018 totalled £87,389. Salaries, Pensions & National Insurance of £59,346 represented 68% of payments, Youth work of £12,751 represented 15% of payments, Rent, Utilities and other Office costs of £11,509 represented 13% of payments and other costs of £3,783 represented 4% the payments.

The Horbury Breakthrough Youth Project continues to benefit from the Trustees and individuals who give their time freely together with our own Churches who provide free or reduced rent for meetings and youth activities at Church premises. Great thanks are also due to the Trustees, Ministers, Officers, Business Committee members, our Youth Work Staff, Volunteers, Parents and very importantly, members of our Churches who support all we do. Thanks to all for on-going prayers and support. Trustees for 2018 were:
