## Structure, governance and management

#### Constitution

Friends of Bowhill Primary School is a Charitable Incorporated Organisation registered with the Charities Commission on 18 August 2017. The Governing document of the Charity is a Foundation constitution dated 18 August 2017. The registered Charity number is 1174308.

## Method of recruitment and appointment or election of Trustees

The first Charity trustees were appointed on 18 August 2017 following completion of Trustee consent forms and Trustee Eligibility declaration. Appointment of Trustees will be in accordance with the constitution. Suitability is determined by an interest in the work of the Charity, eligibility, personal competence, specialist skills and local availability. New Trustees will be inducted into the workings of the Charity on joining by the Chair and other trustees.

### Objectives and activities

### Objects and aims

The Charity's objects are as follows:

To advance the education of the pupils of Bowhill Primary School and other schools in the Exeter Learning Academy Trust by engaging in activities or providing facilities or equipment which support the school and develop relationships between staff, parents and the wider community.

The trustees achieve the charitable objects by running a Parent, Teacher and Friends Association, known as the PTFA. The PTFA has formal members, who are the Trustees and a number of informal members who attend the PTFA meetings and provide much valued support at the various events throughout the school year.

### Achievements and performance

Report by our Chair, Kelly Voysey:

2018/19 was a fantastic fundraising year for the PTFA and it is once again my pleasure to write this year's chairperson's report.

As a school community, we have managed to raise a fabulous £9,847 which exceeded the total raised in 2018 and is the highest level of support for our school ever provided by the PTFA.

You may have already seen the redecorated school hall since coming back after the summer and agree that the new colour has made an amazing difference to the feel of the space. New play panels are attracting plenty of attention in the top playground and make a great addition to the existing new scheme. We know children are really enjoying the panels in their playtime. Other items funded by the PTFA have been new PA and microphones, class Christmas parties, raised flower/veg beds in KS1, Year 6 Leavers' hoodies and autograph books, and additional PE equipment.

None of this would have been possible without your support; coming along to events, baking cakes, donating at the Summer Fete. The entire PTFA team would like to extend our thanks to you and your families for supporting us. We truly hope the events we run make a difference to being part of Bowhill, not just for fundraising but for the fun, laughs and memories.

Future plans to improve and support the school are afoot and we know the school wish to improve the MUGA which is a highly used space. This year we would like to focus on fundraising for this particular area. Every penny raised by the PTFA is used for the school to spend on items or activities which enhance our children's experience at Bowhill.

Our calendar of events is shaping up to be as strong as last year – we plan to keep the Christmas Fayre in the fundraising calendar for December. We worked hard to improve the Christmas Fayre last year to reduce the queues for Father Christmas and offer a good selection of stalls. We will continue to make this a great event but as ever we welcome your feedback.

As a new parent at Bowhill 6 years ago, I knew next to no-one at school and was pretty apprehensive about school gate life. After attending a PTFA meeting one Friday afternoon, I was warmly welcomed and very quickly made new friends with people with children in all year groups. These people have become firm friends and have helped me navigate my way through school life.

This year, I am very aware that a large proportion of our core fundraising team have children which are in the last years at Bowhill. This means that we will see a significant drop in our numbers by the time the year is out. To continue the strength of our fundraising capabilities, we are in great need of new committee members. Please, even if you are just mulling over joining us, come along to a meeting or chat with one of the core team to find out more about us.

I would like to thank the existing volunteers who pitch in and help out with the events we run. Thank

you to all of you. Our teaching and school support team are phenomenal, and I would like to thank everyone who helps makes the PTFA run more smoothly within the school team and our teachers who stay late to help with events and regularly go above and beyond.

Lastly, a huge personal thank you to our trustees who are a dedicated core of volunteers and make all of our events happen. Thank you for hard work and time spent in making such a successful PTFA. I've loved working with you all. This year is my last as Chairperson so I would like to welcome Charlotte Baker, mum of boys in Year 6 and Year 2, to the role of Chairperson along with Jenny Sexton in the role of Vice Chairperson. You'll make a great team.

#### Financial review

The Charity held 8 fundraising events, which achieved a profit of £9,847 (2018: £8,040). The events included Christmas Cards with the children's own designs, Disco, Raffles, Cake sales and the annual Summer & Christmas Fayres.

The Charity funded improvements to the School playground through adding play panels, tables and redecoration of the walls in the outside shelter area. The PTFA also funded PE Equipment and new PA system with microphones, subsidised the Class Christmas parties and Year 6 Leavers Hoodies. At the end of the year the PTFA also funded redecoration of the hall. Other expenditure incurred was for Subscriptions and Licence fees.

All funds are held in a bank account and a small amount of petty cash. The Charity does not have any investments or any other assets or liabilities.

### Reserves policy

The Trustees base their decision on an appropriate level of reserves with reference to planned pattern of expenditure. The Trustees will ensure that reserves are sufficient to enable the Charity to meet essential expenditure as well to continue financially supporting projects for Bowhill Primary School.

The Charity will maintain a minimum level of reserves of £1,000. Higher reserves may be appropriate when the Charity is building up funds to support a specific future larger scale project. The Reserves held at 31 August 2019 was £8,980. The Charity is building reserves and plans to commit future funds to improving the surface of the Multi Use Games Area.
