Objectives and activities

Summary of the objects of the charity set out in its governing document

To further such charitable purposes for the public benefit as are exclusively charitable according to the laws of England and Wales as the trustees may from time to time determine.

Donations With A Difference is a grant making trust supporting general charitable purposes. It is the policy of the trustees to make grants to a wide range of charitable bodies and individuals.

Grants are made primarily, but not limited to, registered charities, charitable organisations and individuals in the UK within the following funding areas; Physical Health, Mental Health & Education.

The charity continues to raise funds in numerous ways by running various events as described in "Section D Achievements and performance". Some of the sporting events not only raise funds for the charity but also improves and encourages physical health.

Grants in 2018 were as follows:

Orchard School - £3,200

Award to the Orchard School for £3,200 towards their project which delivered eleven face-to-face sessions with 16 youngsters over the year. The aim of the project was for 100% of the pupils to attend all of their classes over the year and over 50% to improve their behaviour & improve academically.

Jacob Marley - £300

Helped provide Jacob Marley with a GoTo seat. This allowed Jacob to be seated on the floor with his friends and younger brother, enabled the family easier access to visit friends and family as the seat is adaptable to fit other existing chairs, and gave Jacob a new perspective in his life.

Vivhaan Pradhan - £1,200

Vivhaan Pradhan was provided with a trike which will help his mobility and allowed him to develop his social skills by interacting with other children when outdoors.

SeeAbility - £540.61

A grant of £540.61 was given to SeeAbility in Maidstone. The money was used to buy a whole range of new equipment to improve the accessibility of the kitchen. All these items helped the ladies have more independence when preparing food.

Curtis Ratcliffe - £15,338

Curtis Ratcliffe had cerebral palsy, epilepsy, scoliosis and hip dysplasia, and was blind so needed a Smart Mustang Power Chair to gain some independence and normality, both in his own house and outdoors. The Power Chair allowed him to travel independently along a pre-determined route using a head switch control. Donations With A Difference provided a grant for £15.538 to help the purchase of the £20,000 chair.

Tree Tots - £400

Donations With A Difference provided a grant of £400 to Tree Tots. The money was used to buy initial equipment for the group which provided weekly outdoor activities for under-5s.

William Green-Rose - £164

William Green-Rose was diagnosed with global developmental delay, epilepsy, right side weakness, optic nerve hypoplasia and visual impairment but he gained some mobility over the years. This meant that he needed lots of physical help to stand and walk, and as he developed further he needed more support which will be offered by the LiftVest we donated, worth £164.
