Structure, governance and management

The PCC is made up of Clergy, Reader, Church Wardens and elected members from the church. Working under the National Church Representation Rules, all church members are encouraged to register on the Church Electoral Roll and to stand for election to the PCC.

The PCC operates under the chairmanship of the vicar, it's constitution provides representation from the whole membership of the church. The PCC oversees the life and work of the church and is responsible for the financial management and maintenance of the church buildings.

The PCC holds 4 scheduled meetings in a year but can also convene extra special meetings if and when there is need. There are committees that cater for the different facets of the Church's administration, these committees meet as and when required and report back to the PCC.

Objectives and Activities

The parish aims to promote love and worship of God in the community through acts of worship drawn from the Book of Common Prayer and the Church of England's Common Worship. The Gospel of Christ is proclaimed in the parish as recorded in the Holy Scriptures, embodied in the traditions of the Church and day to day living.

The PCC is committed to be an inclusive community where all are welcome regardless of age, race or way of life. Also, the parish provides a welcoming place of worship to all Christians irrespective of their point in the journey of faith.

The parish gives pastoral ministry to the London Borough of Barking & Dagenham by holding services with the Mayor and Councillors on both Civic and Remembrance Sundays.

Review of the Year 2018

Church Attendance

There were 324 names listed on the Parish Electoral Roll in 2018

PCC Report

The PCC in the course of the year contributed to the lives of the local community through the range of worship services offered in the church and a range of other spiritually benefitting activities.

There were four scheduled PCC meetings during the year at which the following were discussed:

- Vestry Elections
- Finance and Church Fabric
- Sub Committee Reports
- Deanery Synod Reports
- School Governing Reports

An extra meeting of the PCC was held in March 2018 to discuss the Heritage Lottery Fund - The Abbey - Unlocking Barking's past, securing its future. The bid for the fund was done in conjunction with the Council and it was proposed to be used for repairs to the Bell Tower. Regrettably the bid did not materialise. An appeal fund has however been initiated to raise finance for effecting the most essential repairs.

The Breakfast Club continued to serve the community by providing weekly breakfast to the poor and homeless. The year saw an increase in the number of people accessing the service, the number of volunteers and donations of money and food.

During the year, **The Ladies Breakfast Bar**, a forum to welcome ladies to breakfast and fellowship took place twice in the year as opposed to the three sessions that was planned. The missed session was a result of the harsh weather brought about by - Beast from the East - in March 2018.

The **Fellows of Antioch**, the men's fellowship of St. Margaret's Church had their meetings every last Sunday of the month. The fellowship assisted with events in the church while fostering communion amongst members and welcomed new members.

St. Margaret's Church Centre carried on its role by continuing to serve meals in the refectory and in hiring out the centre hall for events. Apart from service to the to the local community this was also a source of extra income for the parish.

Financial Review

In 2018 the PCC had offerings of £67,807 (£78,711 in 2017). Offerings went down by £2,931 (4.7%).

Total expenses for 2018 was £85,481 (£88,904 in 2017) a decrease of 4% in comparison to 2017 figure.

A deficit of £17,675 was thus recorded for the financial year. However, there is an outstanding income from tax recoverable from HMRC which is expected to offset an appreciable proportion of the recorded deficit.

Details of receipts, payments, movements between funds and balances held in all the funds are in the financial statements.

Conclusion

Many thanks to all the volunteers who work so hard to make the parish a welcoming place of worship and fellowship. We appreciate all the people that continue to give offerings and donations to the church but would also like to reach out for more help and support in maintaining the fabric of St, Margaret's - A place of Great History and Heritage.

May God in His infinite grace and mercy continue to grant us the will and devotion to serve Him and bring His light to our community.

Treasurer's Report

In 2018 incoming resources were £67,807 (£78,711 in 2017). Offerings decreased by £2,931 (4.7%) a substantial reduction reversing the small but significant increase following the appeal made three years ago. May I please appeal again that your offering is very important particularly to ensure we pay parish share in full and keep the work of the Church going.

Expenses decreased by £3,423 (4%) to £85,481 (£88,904 in 2017), a confirmation of our cost reduction initiatives where possible. Parish share of £52,008 (£52,008 in 2017) was paid in 2018, this is 77% of our incoming .resources and 74% of allocated parish share.

We recorded a deficit of £17,675 for the year 2018. This is summarised in the table below. The deficit is mainly due to tax recoverable from HMRC and the parish share which continues to put pressure on our finances.

We have continued to be prudent in managing expenses whereby we only spend money on the absolutely necessary as demonstrated by the fall of 4% in expenditure.

Please let us all continue our support of the Church to ensure its preservation for future generations as it has been preserved for us.

Independent examiner's report to the PCC of the Parish of St Margaret's Church, Barking
