Vision Wimborne Report for AGM on October 24th 2019
Vision Wimborne has held two meetings since the last AGM.

Issues discussed included the derelict building on West Street, ideas about improving the area around Church Street and Cook Row and the problem of replacing broken paving slabs with tarmac. We are hoping that Vision Wimborne can be included in a consultation exercise on the strategic plans for Wimborne being developed by the Town Council.

Several of us from Vision Wimborne have been attending meetings to help the Youth Café to get started. There will be a report on this later in the meeting

Councillor Shane Bartlett used part of his ward budget to buy two events shelters (one 14x14 and one 10x10 feet) and 3 professional marques (one 5x6metres and two 5x8 metres) Guttering will be bought so the marquees can be joined together. There is also a large fire pit for story telling or singing round the camp fire. These are all available to borrow by local charities or community groups.

There is some money left to be spent on more assets for the local community.

We hope there will be enough money in our account to produce a newsletter this year. This takes a considerable amount of time and effort and we rely on volunteers to help

with the design and editing. We include the various groups that are part of Vision Wimborne and so we all benefit from the publicity acquired.

Last year we had two planning officers from East Dorset Council talking to us about planning matters and particularly the developments round Wimborne. To-nights speaker follows on from last year and will tell us about some of the planning gain for the town. During this last year our local council has changed, disappeared in fact, to be replaced by Dorset Council. We wait to see how these changes will affect things in our town. The Town Council continues with some extra responsibilities, Some of which we will hear about this evening.

I must not finish this report without thanking Alan Breakwell for keeping our accounts in good order. He not only does the Vision Wimborne books but also Dial-a-Ride and Dreamboats. We really could not manage without him. Thank you very much Alan. It is good to know our finances are in safe hands.

I must also thank Pam Shrubb for running the tombola at the Charities fair last November She is doing it again this year and would be glad of any contributions. The tombola raises a very useful £ 100 for our funds.
