

# Summary of the main achievements of the charity during the year

#### Worship and Prayer

Newjoy is keen on introducing a wide range of services this year to cater to individuals and families in our community to find both beneficial and spiritually fulfilling. For example, our Tuesday evening prayer services provide a quiet, intimate and reflective time for families to pray and fellowship with others especially those who for some reasons could not catch up on the Sunday service.

This year, we have been successful in introducing our Thanksgiving Service on the 1<sup>st</sup> Sunday of each month. An opportunity for families to reflect on the goodness of the Lord in the cause of month and share their testimonies to encourage others to be steadfast and unmoveable in their faith and relationship with God and others.

This year has been successful with many of our community initiative programs. The church general conference has been successful with bringing many families together to pray for our communities, cities and nations.

Our community BBQ service in the summer was a huge success as we saw many people in the community come to church to fellowship and enjoy free meal and drinks. In all, we were able to serve over 100 members from the community aside usual church members.

In addition, our children and youth conference was a delight especially in seeing how important young people are to the future of the church. Gradually, it is becoming obvious that this ministry has the youth at heart with a vision that will raise many young people for Christ and society.

Activities such as Women's Conference, Movie Nights, Worship Nights, weekly soup kitchens and leadership empowerment seminars all proved to be a huge success.

Our Christmas Community Carol, Dinner and Giveaway stand out in our churches achievements. In the Christmas service alone, we were able to organise carol service for some care homes in the community, a free 3-course meal for over 50 people in the community and handed over 70 food parcels to families and the homeless in the community. We plan to do more by cooperating with other high streets shops and organisations in the coming year.

All are welcomed to attend our regular services. At present, we have 65 registered members including children and youth. The average weekly attendance is about 50 but this number increased at peak services such as BBQ, Christmas Carol and Baby dedication services among others.

We have celebrated 5 baptisms and 8 baby naming and dedications services. We have buried no one this year.

It is Trustees policy to maintain a balance of unrestricted funds (if possible), which equates to at least three months of unrestricted payments, the equivalent of £1000, to cover emergency situations that may arise from time to time.

The balance of £1,256 held on unrestricted funds at the year-end meet our target and good news for us moving into the new year.

The churches principal source of funding includes Church members and partners worldwide. We continue to look forward to securing gift aid in the coming year and also accessing grants in the coming years to help us to do more in our communities.

Total receipts on funds were £10,458 which came in through weekly offerings, tithes, freewill giving from members and partners.

Out of this amount, our accrued expenditure was £9,202. This amount was spent on Rent £5900, Community support and welfare £973, Weekly soup community soup kitchens £449, new equipment £289. The rest went into stationary, transportation for members and events.
