TRUSTEE'S REPORT

The trustee's present their reports and accounts for the year ended 31st December 2018.

Since the last report for the year ended 30th June 2017, there has not been any significant changes from the operations of the charity to update in the current report.

During the period of this report, some activities undertaken by the charity and future development plans are outlined below.

a. ACTIVITIES UNDERTAKEN TO FURTHER THE CHARITY'S PURPOSES FOR PUBLIC BENEFIT

1. WELLBEING SUNDAYS

To reinforce the benefits of the Healthy You, Healthy Communities initiative, the church holds an annual Wellbeing Sunday event. This event emphasises the importance of maintaining a 360 degree view of wellbeing. It included sessions on physical & health wellbeing, mental & emotional wellbeing, financial & material wellbeing, marriage & social relationships wellbeing, education & intellectual wellbeing and faith & spiritual wellbeing. For the future, the Church is working towards holding a Wellbeing Summit to provide a forum to facilitate the promotion of a healthy lifestyle.

2. CANDLELIGHT CHRISTMAS CONCERT

The Church is committed towards the fostering of community spirit and holds an annual concert to celebrate the Christmas season. We work together with other churches, both locally and from outside the county, to promote the peace, joy and goodwill associated with the Christmas season. The concert is growing and is gaining more engagement with members of our communities.

b. REVIEW OF ACTIVITIES

During the period under review, we maintained our connection and relationship with various members of our community in many ways. All manners of human and material resources were made available as we committed ourselves to demonstrating the Love of our Saviour, Jesus Christ, to every member of our community and anyone we met.

c. PRINCIPAL FUNDING

The charity's principal source of funding remains the same. The church members provide this mainly through voluntary tithes and offerings. Contributions and Pledges are also taken for specific projects.
