### Achievements and performance

From September 2017 we have provided a weekly counselling service for young people in the town. The service has been offered, free of charge, by a qualified and experienced counsellor supported by volunteers acting as welcomers. Training for volunteers has been provided all volunteers are DBS checked. During 18/19 this service has been suspended as we were not successful in drawing the expected numbers of clients. This is believed due to failure to engage adequately through social media and other outlets popular with our intended clientele. During the suspension we have been revisiting these aspects with a view to improving and enhancing them before we re-launch the initiative.

The charity has acted a lead group for an application for a Community Asset Transfer of a patch of council owned land adjacent to the charity's premises.
