Objectives, strategies and activities

The Charitable Incorporated Organisation (CIO) was setup and registered to take over the running of the charitable activities of the unincoprorated charity of the same name, charity number 281198. The transfer of the assets and funds from the previous unincorporated charity into this CIO did not occur until 1 January 2019.
