#### Preamble

St. Mary's Parochial Church Council (PCC) has the responsibility of cooperating with the incumbent, the Reverend Dr Robert Stephen, in promoting in the ecclesiastical parish, the whole mission of the Church, pastoral, evangelistic, social and ecumenical. The PCC is also specifically responsible for the maintenance of the Church of St. Mary's, Handsworth.

## Objects and Activities

The PCC is committed to enabling as many people as possible to worship in our church and to become part of our parish community at St Mary's. The PCC maintains an overview of worship throughout the parish. Our services and worship put faith into practice through prayer and scripture, music and sacrament. In particular, we try to enable people to live out their faith as part of our Church through:

- ♣ Worship and prayer; learning about the Gospel; and developing their knowledge and trust in Jesus.
- ♣ Provision of pastoral care for people living in the parish.
- ★ Sharing our faith and outreach work.

To facilitate this work it is important that we maintain the fabric of the Church of St. Mary's.

## Worship and Prayer

The pattern of services has continued with a Holy Communion at 8.00am every Sunday using the Book of Common Prayer (1662); The Parish Eucharist is at 11.00am every Sunday; and Evensong is at 5.00pm, usually on the third Sunday of the month. All of these services has viable numbers attending,

All are welcome to attend our regular services and we are glad that our worshipping community is so very diverse in age, ethnic origin, employment and family situations. Given the demographic of the area, where only 22% would identify as Christians and these are not all Anglicans, we can be confident in a steady growth. At present there are 66 parishioners and regular worshippers who live beyond the Parish on the Church Electoral Roll, which will be completely revised in 2019.

The Church of England gathers statistics on the life of the Church each year and this year I share with you the key figures with the same statistics from 2010 and 2015 for comparison. Many of these are average numbers for all services on a Sunday and in the week and so can easily be skewed by how many special services there are (particularly during October when statistics are more closely recorded) or by external factors like the weather or, in our case, a cold Church because we have had inadequate heating.

When the refurbished Church is available we can reasonably expect that there will be an increase in the numbers of weddings and funerals as we shall then have greatly improved facilities. Our building will become a tool for mission rather than just a spiritual landmark in the area.





I have been glad to have had the support of my 4 licensed Readers who have assisted as Liturgical Deacons at the Parish Eucharist, have officiated at other services, have preached and have supported me in the pastoral care of the congregation. I also express my thanks to my Churchwardens, Doreen and Keith Hemmings, for their constant and consistent support, advice and encouragement and their unstinting generosity with their time and talents.

## Deanery Synod

4 members of the PCC sit on the deanery synod. This provides the PCC with an important link between the parish and the wider structures of the church.

#### Pastoral Care

Some members of our parish are unable to attend church due to sickness or age. The Rector or one of the Readers have visited all church members who have requested it, to celebrate communion with them either at their homes or in hospital. There is a very good and effective support network in the fellowship and this is a source of encouragement to many.

#### Financial Review

The details of the Parish and Church finances follow in this report. We are aware of the need to raise funds in the immediate future for the reordering and are glad that, because of the 'rainy day' monies in the general funds we can put the work in hand with some element of faith for God to provide the funds we need. The F&GP have pursued a policy of consolidating our unrestricted funds to simplify bookkeeping and management of investments. With the pressure from the Parish Share having increased and the uncertainty of the Diocesan funding being addressed in People and Places, we are aware that there is the ever present pressure to proceed with prudence.

#### Volunteers

We are a Church together and there is always a willing group of supporters for the many and various activities from cleaning to cooking and supporting special ventures (e.g. the annual beer festival): there are too many to mention by name. However, I would be remiss if I did not thank Edna Simkin, our Treasurer; Eddie Lear, who manages our investments and the Hall accounts; Roger Tipper, our independent examiner who has demonstrated his commitment to us in his tenacity in overcoming significant health issues to complete this work; to Richard Paton-Devine who has stepped-up to help with compiling the accounts; to Betty Lear our PCC Secretary and to Margaret Thomas who has, in this last year, been her Deputy; and to Christopher Hazeley-Jones for managing the Hall bookings together with Ron Hollins who has taken on additional care taking duties.

## Structure, Governance and Management

The method of appointment of PCC members is set out in the Church Representation Rules. At St. Mary's the membership of the PCC consists of the incumbent (our Rector), churchwarden(s), the readers and members elected by those members of the congregation who are on the electoral roll of the church. All members of the congregation are encouraged to register on the Electoral Roll and stand for election to the PCC.

The PCC members are responsible for making decisions on all matters of general concern and importance to the parish including deciding on how the funds of the PCC are to be spent. New members will receive initial training into the workings of the PCC. Given its wide responsibilities the PCC has a number of committees each dealing with a particular aspect of parish life.

During this year we have taken some time to reflect on the roles and responsibilities of the various officers in the Church and to think positively about how we ensure there are people to take on these roles in the future.



RANSFORMING

The standing committee of the PCC is the Finance and General Purposes Committee and it is responsible to the PCC and reports back to it regularly with regular reports given to the full PCC and discussed as necessary. Other committees deal with safeguarding, pastoral matters and social activities. The PCC are responsible to the Diocese to act as Trustees for the Church Hall.

## Administrative information

St. Mary's Church is situated on Hamstead Road, Handsworth, Birmingham. It is part of the Diocese of Birmingham within the Church of England. The correspondence address is The Rectory, 288 Hamstead Road, Handsworth, B20 2RB. The PCC is a body corporate (PCC Powers Measure 1956, Church Representation Rules 2006) and is an independent charity registered with the Charity Commissioners.

## Report on the Fabric (Keith Hemmings)

If you drive down Church Hill Road you get a view of our Church that is unrivalled. The building, now that the tower has been refurbished, stands proud and, we pray, is a constant witness to the love of God and his dependability at the heart of our Parish. This is justification enough for us to invest the time, money and love that we do to ensure that the buildings we have entrusted to us reflect God's glory.

This has been a quieter year than some, but some of the highlights were:

- i) After a great deal of negotiation, persuasion and argument we were granted a Faculty for the reordering of the Nave of the Church. As this happened in December we were only able to prepare the tender documents for decisions in the New Year. All involved are aware that the work has to be completed by the Bicentenary of the death of James Watt on the 25th August 2019. We are grateful to the Chancellor for the very positive way he ensured that questions were addressed and obstacles cleared.
- ii) The regular programme of maintenance has been continued, especially with the clearing of the roof areas and the gutters and drains.
- iii) A flag pole was installed and the Diocesan Flag is flown on all Sundays and Holy Days and the Union Flag flown on the dates notified by the Lord Chancellors Office.
- iv) The Parish Hall has proven to be a popular venue for family parties and most people have respected the space. We have also been glad to use the space for worship during the coldest spells in the year (although the 8.00am congregation braved the cold throughout).
- v) Our thanks to all those members of the congregation and community who have supported the various cleaning days: it does help with keeping the Church clean and useable.

The Finance & General Purposes Committee (as the only Standing Committee of the PCC) continues to carry most of the workload behind the scenes on behalf of the PCC. Currently serving on this committee are:

## INDEPENDENT EXAMINER'S REPORT TO THE P.C.C. OF ST. MARY, HANDSWORTH

This report on the financial statements of the Parochial Church Council ("PCC") and St. Mary's Church Hall Charity for the year ended 31<sup>st</sup> December 2018, which are set out on pages 8 to 15, is in respect of an examination carried out in accordance with the Church Accounting Regulations 2006 ("the Regulations") and the Charities Act 2011 ("the Charities Act).

## Respective responsibilities of the PCC and the Examiner

The PCC is responsible for the preparation of the accounts. The PCC considers that an audit is not required for this year under S.144 of the Charities Act and that an independent examination is needed.

It is my responsibility to:

- Examine the accounts under S.145 of the Charities Act
- To follow the procedures laid down in the General Directions given by the Charity Commission (under S.145 (5)(b)) of the Charities Act and to be found in the Church Guidance, 2006 edition, and
- To state whether any particular matters have come to my attention.

## Basis of Independent Examiner's Statement

My examination was carried out in accordance with the General Directions given by the Charity Commission and Church Guidance. An examination includes a review of the accounting records kept by the PCC and a comparison of the accounts presented with those records. It also includes consideration of unusual items or disclosures in the accounts and seeking explanations from the PCC officers concerning such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently no opinion is given as to whether the accounts present a "true and fair view" and the report is limited to those matters set out in the statement below.

## NOTES TO THE ACCOUNTS

## **ACCOUNTS**

The financial statements of the PCC have been prepared in accordance with the Church Accounting Regulations using the Receipts and Payments basis. The following assets are recognised but not necessarily valued in the Balance Sheet: moveable church furnishings held by the churchwardens on special trust for the PCC and which require a faculty for disposal.

## TRUST INCOME

Various small bequests for general purposes are invested in CBF Investment units.

## CHURCH RESIDUE (endowment)

Following the creation of a separate charity to hold the Church Hall, 283 & 285 Hamstead Road and the electricity substation, these funds are now held for other purposes.

The Capital Fund represents the surplus on the disposal of Hutton Road Mission Hall and other property: there are no provisions relating to their use. Part of these funds was used for the Parish's contribution towards the purchase of accommodation for an assistant curate. This property was sold in 2014, and in 2017, £31,414 was used towards the refurbishment of the Church Hall. The Diocesan Trustees hold the balance in CBF Investment Units or as a cash balance.

Income is used for general parish purposes.

## TIMS BEQUEST (endowment)

A bequest from the Estate of Albert Leslie Timms is held in trust by the Birmingham Diocesan Trustees, the income from which is to be applied only for the upkeep of the fabric of St. Mary's Church.

## VAUGHTON BEQUEST (endowment)

The Vaughton Bequest is held in trust, the income to be applied only for the upkeep of St. Mary's Church.

## ARRAND LEGACY (endowment)

The Capital funds represent the final distribution from the Estate of Elizabeth Arrand, the remainder having been allocated to the main roof appeal. The funds are to provide income, the use of which is determined by the PCC.

## ASSISTANT CLERGY FUND (endowment)

This was set up many years ago to support a full-time assistant clergyman. The investment is provide by way of units in thebe Investment Fund representing moneys bequeathed by the Hampton Goffe family.

## JAMES WATT MEMORIAL FUND (endowment)

Certain investments were left in trust by the Watt family for the maintenance of the memorial statue of James Watt and the Income Fund represents the accumulated income to date, after deducting maintenance costs. The investment is held in the CBF Investment Fund.

## ST. MARY'S (COFFEE HOUSE) TRUST (endowment)

Surplus moneys from this trust are administered by the PCC in accordance with the trust deed, in succession to the Trustees of the Handsworth Parochial Charities. The investment is held in the CBF Investment Fund.

## ST.MARY'S CHURCH HALL CHARITY (Regd. No. L4/603/840) (Restricted)

The charity was registered on 28<sup>th</sup> February 1985 to correct anomalies that had appeared over the ownership of the properties which the Trust held at its inception: St. Mary's Church Hall, 283 & 285 Hamstead Road, Handsworth and land on which stands an electricity substation. The property is vested in the Custodian Trustee, which is Birmingham Diocesan Trustees Registered. The Managing Trustee is the Parochial Church Council of the Ecclesiastical Parish of St. Mary, Handsworth.

The property and surplus income are to be used for the purpose of furthering the religious and other charitable work of the Church of England within the Ecclesiastical Parish of St. Mary's Handsworth.

The Capital Fund represents the surplus proceeds from the sales of 283 and 285 Hamstead Road, less the costs of improvement to St. Mary's Church Hall and the Pound. No formal valuations of St. Mary's Church Hall have been made, and consequently its value is not reflected in the Balance Sheet. The bulk of the funds were used to undertake the refurbishment of the Church Hall in 2017.

## ST. MARY'S SPECIAL PROJECT FUND (designated)

This fund holds moneys set aside for special projects to be identified by the PCC at St. Mary's. Movements are shown in the accounts.

## PARISH RESERVE (designated)

This fund was created in 2017 to provide monies, principally the proceeds from the sale of the Church of the Epiphany, for investment to produce income for general parish use.

## Report from the Bellringers (Rosemarie Seadon)

#### AIMS
