Motion 1:

This meeting approves the planned reorganisation of the Parish of Bedminster into 3 parishes which shall be St Francis Ashton, St Aldhelm's Bedminster and St Paul's Southville. The parish boundaries to be those previously agreed and shown on the map presented at this meeting.

Any serious safeguarding incident must be reported to the Diocese Safeguarding Adviser. The PCC is required to report these incidents to the Charity Commission also. However, the House of Bishops' Guidance requires that these reports be undertaken on behalf of the PCC by the Diocesan Board of Finance, via the Diocesan Safeguarding Adviser and Diocesan Secretary. In order to enable this to take place each PCC is also required to pass a resolution delegating this function to the Diocesan Board of Finance.
