Structure, governance and management

The charity is an incorporated association governed by its memorandum and articles of association, together with its constitution.

Trustees are appointed at the AGM with there being a minimum of three and a maximum of twelve. At the AGM one third of the trustees must stand down, often the longest serving trustees stand down first, but may choose to stand for re-election. All trustees must be members of East Sussex Foster Care Association and members can nominate themselves for election.

Objectives of the charity

The objectives of East Sussex Foster Care Association as set out in the Memorandum of Association are to promote all or any charitable purposes for the benefit of the community mainly but not exclusively within the County of East Sussex and in particular the advancement of the education of the public in matters relating to substitute care. In particular the education, training and support of foster carers and their families, the relief of Looked After Children, their Carers and their Carers' families by providing facilities and services in the interests of social welfare with a view to improving their conditions of life.

The Association is to support East Sussex Foster Carers and their families in their efforts to achieve the best possible outcomes for the children in their care by working in partnership with all appropriate statutory and voluntary agencies. It undertakes this task by offering a range of events, advocacy, training and support for the both the families and the children they care for. Its membership is comprised of East Sussex Local Authority registered Foster Carers and the managing group is formed by elected Trustees/Directors' from within that membership.

Activities, achievements and performance

12th April 2018- Nature Workshop- Unite the Beat

This was two, two-hour workshops in a partnership with "Unite the Beat". The workshops took children and carers into woodland, where they used nature to create their own music and film. 12 children went with 5 adults.

$13^{th}\ 14^{th}\ 15^{th}\ April\ 2018$ - PGL Residential trip to Windmill Hill

This took 25 children aged between 11-18 and 13 adults on a residential stay at PGL activity centre at Windmill Hill (Hailsham). Over the three days children, social workers and volunteers took part in over 8 different activities. This was funded by **Children in Need**.

24th & 25th April 2018- Bluebell Walk-Fundraising/ Awareness

This is a regular fundraiser sponsored by the Alfriston Bluebell walk. This is a local farm that hands over the running of the very popular Bluebell walk (visitor attraction-allowing the public to walk through the farmland

enjoying the wild Bluebells). The owner allows local charities and associations to run the event and café for two days at a time. Money made in the café is kept by the charity, money made for the walk is kept by the owner (the owner often donates a top up amount from their own profits to help the charity).

3rd May 2018- Social Worker Hero Awards

These awards are run by ESFCA. Carers nominate social workers that have really helped or gone above and beyond the call of duty to support families and children. Two social workers win the awards, which in turn helps build the relationship between ESFCA and the Social worker teams.

9th June 2018- Horse Riding

In partnership with Plumpton College, two groups of six children were given the opportunity to have a tour of a stables, a beginner's guide to horse care and a half-hour riding lesson. This event was subsidised by ESFCA

6th July 2018- 25th Celebration Barn dance

2018 saw ESFCA celebrate 25 years of supporting looked after children and their carers in East Sussex. ESFCA held a barn dance for foster families (members) and children. This was subsidised by ESFCA with families paying a ticket price of £10.00 to attend. Trustees and Patrons (Jayne Torvill OBE and Dame Jacqueline Wilson) were in attendance.

13th July 2018 & 12th October- Baby & Toddler Group

A small group of carers that look after babies & toddlers meet up for a coffee & chat in a safe environment. There is soft play for the toddlers to socialise. This is organised and run by two trustees with the aim of giving support to an often-overlooked group of carers and children. This is funded by ESFCA donations.

23rd July-28th August- Family First Nights-Mousetrap Theatre Productions.

Mousetrap Theatre Productions subsidise ticket prices for over 45 theatre productions in London's west end. ESFCA is a preferred partner for this scheme and facilitates the offer to all members. The offer is a once only offer for children to experience theatre/dance/music. Members pay £6.00 per person for the thicket with the rest of the ticket price being subsidised.

3rd August- 5th August 2018- Sainsbury's Awareness 3rd October-13th October 2018- Sainsbury's Awareness

7th February-9th February 2019-Sainsburys Awareness

2th May-4th May 2019- Sainsburys Awareness

ESFCA were chosen as Sainsburys (Hampden Park) & Sainsburys Local (Seaside Eastbourne) as their charity of the year. Both stores ran fund raising activities over 4 weekends through the year. ESFCA trustees & volunteers also ran desks at both sites raising funds through tombola's and promoting awareness of the Association.

31st August-2nd September 2018- PGL Residential Trip Little Canada (Isle of Wight)

This took 24 children aged between 7-18 and 13 adults on a residential stay at PGL activity centre at Little Canada (Isle of Wight). Over the three days children, social workers and volunteers took part in over 8 different activities. This was funded by Children in Need.

22nd September 2018- Chessington Zoo- Sibling Sunshine Days

This event is Funded by National Lottery "Awards for All" and allows ESFCA to take 35 looked after children (and their carers) who have been separated from their siblings to enjoy some time together. Merlin's magic wand supply tickets to Chessington Zoo and the coach is funded from the Awards for all donation.

3rd October 2018- Beachy Head, 10k Fun Run

ESFCA had a request from the organisers of the Beachy Head Fun Run to help marshal the 10k racecourse. 10 volunteers and trustees went to the event to assist marshal the event and in return a donation was made to the association.

12th October 2018- Charity Golf Day- Lottebridge Golf Course

Ray Cruttenden (Owner of the Lottebridge Drove Golf Club), kindly donated the use of his golf course for the day, 12 teams of golfers took part in two rounds of golf over the day in a tournament. Breakfast and Lunch

was kindly donated by Mike Jackson (Dizzy Pig Catering) and the event raised over £3,500 through the competition and Raffle held on the day.

19th-21st October 2018- Butlin's- Sibling Sunshine Project

The Sibling Sunshine Project was set up by ESFCA to bring looked after children who have been separated from their siblings and live with different carers/ residential home. The **National Lottery "Awards for All"** donation allowed 9 foster families (23 children) to spend a weekend at Butlins in Bognor Regis. Once there the children could make use of all of the activities open to them and play with their brothers and sisters. This gave the children lasting memories of sharing a holiday together.

23rd October 2018-Halloween trip to Thorpe Park

The through care/leaving care team requested support to take young people on a Halloween trip to Thorpe Park. Some of these children had never been to a theme park before. Our association provided 51 tickets, coach and £8.50 food allowance for each person. The trip consisted of 40 young people aged 16 to 21, and 10 staff.

26th -28th October 2018PGL Residential trip to Windmill Hill

This took 23 Young People Who Foster aged 7-18 and over 13 adults on a residential stay at PGL activity centre at Windmill Hill (Hailsham). Over the three days children, social workers and volunteers took part in over 8 different activities. This was funded by **Children in Need**.

11th November 2018- Horse Riding- Horam Manor Horse Riding Stables

Horam Manor horse riding stables offered the association discounted rates and provided three consecutive weekly riding experiences. Foster Carers and the whole family were able to participate. The sessions included a hack out in the woods and two lessons. The Foster families paid a small contribution to take part in the event. A great experience for the families.

16th November 2018- Conference East Sussex National

This year saw ESFCA hold a one-day conference for foster carers, social workers & other professionals. The theme for this important event was 'communicating & direct work with traumatised children'. Guest Speakers Richard Rose and Theresa Hadfield delivered lectures and workshops to the delegates, who also had a chance to network with fellow guests. 133 delegates took part in the conference and the event was self-funded by ticket sales and Exhibitor charges.

23rd November 2018-Keep it Reel Fund

Reel posters donated £1000 for us to set up a 'Grandparents fund' to allow social workers to request small special treats for children. A very special way of helping our foster families.

9th December 2018- Christmas Party

Our yearly treat for young and old alike, 116 children and 77 adults attended. The Kings centre provides the Venue for our party free of charge. We had a kids DJ with fun dancing and games, Father Christmas with his sleigh (loaned from the Lions club) handed out presents to all the children. The Soroptimists donated gifts for children to choose and wrap up as a surprise for their foster carers. Part funded by the Magdalen & Lasher charity.

5th January 2019-Pantomime

ESFCA took a block booking of over 200 tickets to the Eastbourne theatres pantomime performance of Cinderella. The Performance was a matinee at 11:00 allowing perfect timing for all ages to attend. There was also a provision for disabilities as ESFCA ensured disabled seats were available to those who needed it. This event was paid for by funding events throughout the year by Trustees and Volunteers. All Attendees were asked for a small donation of £8.00 towards tickets. The attendees were also given a box of family chocolates to share and bottles of water, again paid for by donations made throughout the year and particularly from Happy Days charity, John Jackson Trust and the Roy Hudson Trust.

17th February 2019 Supporting the Children in Care Council

We were extremely pleased to be able to support the CICC with funding to provide Rucksacks filled with essentials such as teddy's hair brush notebook and pens etc. for children coming into care for the first time. We also helped fund Room to Rant, inspired by the work of poet Lemn Sissay, enabling them to put together

two workshops where they had the opportunity to write and perform a rap song at 'Audio Active' based in Brighton.

19th 20th & 21st February 2019- Inspire workshop

The ever-popular half-term workshop returned and ran for three days over the February half-term. The course ran between 10:00 and 13:30 on each day and allowed 18 nominated children to build confidence and resilience through performing, singing, dancing and gymnastics. The culmination was all of the children performing three songs from the Greatest Showman to a small audience at the end of the final day.

12th, 14th & 21th March-Reflect, Recharge & Relax

During March, ESFCA took three groups of foster carers for an experience to reflect, recharge and relax. Reflect took 20 carers to Afternoon tea at Ashburnham place (Battle), Recharge saw 38 carers meet for a Chinese meal at the Happy Dragon (Pevensey) and Relax allowed 14 carers to use the spa & health facilities at Bannatynes health club. This was fully funded by ESFCA as a treat for our carers.

22nd 29th March & 05th April- Reflexology

ESFCA trialled a three-week course (three, two-hour sessions) teaching foster carers reflexology for babies & toddlers to help their children relax and help with behaviour and sleeping problems. The course was subsidised by ESFCA with the carer donating a small contribution.

Suitcases for emergency moves

ESFCA are proud to have a stock of luggage available to social workers and assessment teams and have already distributed over 200 suitcases to children that have had to be moved as an emergency or travelling to respite.

This was made possible by the amazing generosity from Tripp Luggage who has continued to support ESFCA over the last 5 years.

Financial review

We are extremely grateful to receive an annual grant of £20,000 from East Sussex County Council (ESCC) which enables us to employ staff to support the trustees in running the charity. This money also provides back office and operating costs. This is named our designated fund.

We continue to receive restricted funds from ESCC to top up our allegation fund to £10,000 annually, which is held by us to support any foster carer facing an allegation. The fund enables independent support to be provided to our foster carers which could involve a lengthy and complex investigation.

All grants from the wider community have been fully spent on the nominated activity and the association has often contributed further funds to enable more children to benefit from the specific project.

Our reserves remain the same as last year. These are held to provide a safety net to provide annual events such as holidays, PGL weekends, the Christmas party and Pantomime should we be unsuccessful in receiving donations for these cherished activities. We also would be able to continue operating for a period of time should the Local Authority withdraw its annual grant. The association can access our reserve fund immediately should the need arise.

Where donations are received and the donor has a specific request, we mark these funds restricted so they are only used for that purpose.

We have also for the third year running been voted by local Sainsburys, this year at Hampden Park and Seaside Eastbourne as their charity to support and this has been a tremendous success for us.

We continue to hold stock of new suitcases donated from Tripp luggage and other providers. These are available to specialist teams of Social Workers needing to move children in an emergency thus ensuring that their personal belongings are carefully packed and transported with the young person.

The annual events within this financial year has been one of the busiest years ever and has provided so many events, activities and projects. We have had donations and fund raising from so many varied organisations in our local community and are truly amazed at the generosity from so many.

Furthermore, Jayne has allowed use her picture in our publications and local press.

How delighted I am to welcome Dame Jacqueline Wilson as a second patron to our organisation this year. Jaqueline has already attended many events and the children and families have been thrilled to meet and chat with her as well as have their books signed. Independent examiner's report to the trustees on the unaudited financial statements of East Sussex Foster Care Association.

I report on the accounts of East Sussex Foster Care Association for the year ended 31 March 2019 set out on pages 2 to 12.

Respective responsibilities of trustees and independent examiner

The charity's trustees (who are also the directors of the company for purposes of company law) are responsible for the preparation of the accounts. Notes to financial statements for the year ended 31 March 2019

1. Accounting policies

The principal accounting policies are summarised below. The accounting policies have been applied consistently throughout the year and the preceding year.

1.1. Basis of accounting

The financial statements are prepared in accordance with the provisions of Section 1A 'Small Entities' of Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

1.2. Going concern

The trustees are of the view that the charity is a going concern and will continue for the foreseeable future.

1.3. Incoming resources

All incoming resources are included in the statement of financial activities when the charity is entitled to the income and the amount can be quantified with reasonable accuracy. The following specific policies are applied to particular categories of income:

Voluntary income is received by way of donations and gifts and is included in full in the statement of financial activities when receivable. The value of services provided by volunteers has not been included.

Grants and incoming resources from charitable activities are recognised in full in the statement of financial activities in the year in which they are receivable.

Income from investments is included in the year in which it is receivable.

1.3. Resources expended

Expenditure is recognised on an accrual basis as a liability is incurred. Expenditure includes any VAT, which cannot be fully recovered, and is reported as part of the expenditure to which it relates.

1.4. Tangible fixed assets and depreciation

Expenditure on individual items of office and computer equipment costing less than £5,000 is written off in the period in which the expenditure incurred.

1.5. Fund accounting

Unrestricted funds are available to spend on activities that further any of the purposes of charity. Restricted funds are specifically for particular areas and projects undertaken by the charity.

1.6. Average number of employees

The average number of employees during the year was 2. There are also a number of volunteer support workers.
