The Camden Fencing Club ran fencing demonstrations in local schools and on Hampstead Heath to encourage sport among young girls and boys in Camden. We were pleased that these sessions increased our youth membership generally and especially of girls. We continued to promote the I Deserve It Project - free six week fencing courses for girls and young women during 2018 – 2019 (sponsored in parts by Sport England, British Fencing and Camden Fencing Club).

The Winton family were recognised for their donation and the creation by the Club of the Camden Winton Fund to support talented fencers compete in the UK and abroad.

Winning medals at National and International sabre and foil events in varying men and women age categories. Highlights of Fencers results for the season within the Club include:

We increased our hall rental to accommodate the increased attendance for popular Tuesday competitions and training. We are delighted that we have more fencers competing in the UK and Internationally. This has led to increased travel expenses for coaches. We are fortunate that the Camden Winton Fund was able to assist Fencers compete in Olympic qualifies in globally. 


