The Association was formally established by Deed of Trust made on 11th March 1998.

The Association is a registered Charity Number 1062244.

OBJECTIVES

Its objectives are the care, welfare, treatment and rehoming of stray and homeless cats and kittens.

ACHIEVEMENTS AND AIMS

We have had a challenging year and have unfortunately not managed to rehome many cats. We are now caring for those who have long term issues, who are elderly or have medical problems so cannot be rehomed. We are concentrating on their well being so have not been able to take in many other animals. This will continue for the foreseeable future. We have invested in new enclosures so that these long-term residents will have space to roam freely.

TRUSTEES RESPONSIBILITIES
