Under those Articles, the members of the Executive Committee are elected at the AGM to serve a period of twelve months, subject to ratification at each AGM.



Aberconwy Mind has a membership base which has representatives on the Board of Trustees. The governing document of Aberconwy Mind was amended and updated in February 2016 to introduce 'Associates' representing service users of our Association to promote open discussion and involvement from those who use services to ensure relevant issues and ideas are implemented in strategic policies; used to develop new services, formulate and refine existing services and answer any areas of concern.

Aberconwy Mind plan, prioritise and review work within a systematic framework. The Board of Trustees, which meets once a month, follows a set agenda which reviews finances, service provision and delivery, staffing and other organisational issues. Planning is also facilitated via open discussion at centre meetings and management level. These meetings are minuted and presented to the Board of Trustees for approval. Priorities are set through discussion, in order of importance.

Aberconwy Mind recruits and trains volunteers to assist in the smooth running of the centre and there are currently have base of 45 volunteers.

Aberconwy Mind has reviewed all policies and procedures as part of our Quality Management in Mind process which includes the induction and training of our trustees, staff and volunteers. The Mind Quality Mark is endorsed by the Charity Commission and is an ongoing process.

The charity will ensure that its recruitment and selection procedures follow the equality and diversity policy. Two references will be taken up from all successful candidates prior to any formal offer, where appropriate referees will be asked to comment on the applicant's suitability for the role. Where relevant to the post, the successful applicant will be asked to agree to a DBS (Disclosure & Barring Scheme) enhanced, when deemed necessary for the role. Disclosures will be requested prior to the applicant taking up post.

Induction for the new trustees, staff and volunteers will include information on all policies and procedures and on-going training will be provided.

All staff and volunteers will have a designated supervisor who will provide appropriate ongoing support and supervision.

Risk management

The trustees have examined the major strategic, business and operational risks which the charity faces and confirm that systems have been established to enable regular reports to be produced so that necessary steps can be taken to lessen these risks.

Aberconwy Mind has indemnity insurance to cover trustees and former trustees up to the value of £500,000, which is shared over all LMA's as part of the standard Mind block insurance

The trustees confirm that they have referred to the guidance in the Charity Commission's guidance on public benefit when reviewing the aims and objectives of Aberconwy Mind and in planning future activities.

Aberconwy Mind is affiliated to the national organisation of Mind and incorporates the national aims and objectives in its constitution.

Service Provision

Aberconwy Mind provides a various array of support services over seven days a week. This includes daily "drop-in" services at its premises in Llandudno in order that the users can relax, socialise and participate in the full range of services on offer at the centre. Other services are provided across the county of Conwy through our various projects.

The wellbeing centre is run by volunteers on a daily basis who are mainly recruited from within the surrounding area, thus encouraging local people to provide and become involved in delivering the service. By recruiting this way, we find that it raises positive images of mental health thus making the service a more integral part of the community.

The trustees would like to gratefully acknowledge the value and their thanks to the body of unpaid volunteers totalling some 45 without whom Aberconwy Mind could not continue to provide its range of essential services.

Achievements and Performance

The charity's main achievement over the past year was to continue the provision of our resource centre, one of its primary functions is the provision of a drop-in service, which was open at some point seven days a week, and primarily run by our team of volunteers, often recruited from service users. The services provided by our volunteers are generally for individuals who are experiencing mental health problems and related illnesses. We also encouraged other agencies to use our premises e.g. Unllys, Communities First, AA, WEA Cymru, OPUS, Age Connects. We continue to operate as a multi-agency resource centre, offering facilities to other charitable organisations.

People who use these services are the most marginalised vulnerable service user. The fact that they use our premises reinforces the safety people feel in coming to our centre. We are able to offer an affordable alternative within our resource centre.

Aberconwy Mind endeavours to hold many fundraising events throughout the year. These include the Christmas Fair, Spring Fair, World Mental Health Day, Summer Fair and other small events held at the centre. These events are often co-ordinated by the volunteers and the associates.

Our social enterprise, Agor: Open has now been trading for four and a half years supported by the Big Lottery Fund up to February 2017. Agor: Open was incorporated on the 23rd June 2014 as a trading subsidiary to Aberconwy Mind. The Rabbit Hole Café received the prestigious award for Social Enterprise of the Year from Conwy Business Awards 2018 and again in 2019.

The BLF initially provided the capital and revenue funding over a three-year period (£498,891) which ended in early February 2017. We have since received additional funding from the WCVA Active Inclusion Fund to support new opportunities within our health and wellbeing centre for voluntary positions and supported paid placements. The decision was taken to cease trading of The Rabbit Hole on 12 October 2019, the charity will review the usage of the space for the benefits of the service users.

Since April 2013 we have been working as part of the Parabl Talking Therapies partnership with lead providers, Cais (BCUHB funding). This funding has been confirmed to March 2020. This project has allowed us to roll out the Serenity Programme across the whole of north Wales and also includes provision of Coping with Life courses (run across Conwy & Denbighshire), Mindfulness groups and one to one counselling. Aberconwy Mind currently employs 6 staff on this project, including fully qualified counsellors.

Financial review

Funds have been used to maintain existing services and further develop services including the promotion of volunteer opportunities and a newly adapted recovery model to support service users.

During the year, the charity has seen our reserves fall to £533,457 with unrestricted reserves falling to £150,304. This is partly due to previous ringfenced profits made by The Rabbit Hole Café being used to support mentoring and volunteer opportunities within the social enterprise and supporting staff posts not directly supported by grant funds. However, a charitable covenant of £15,253 from The Rabbit Hole Café was included in the income of the unrestricted reserves, this ensures that we are still able to comply with our reserves policy of having a minimum of three months running costs, aiming at achieving the equivalent of six months.

Since April 2019, all major funding bids have been received. The BCU Health Board have continued funding on the same level as last year and will also be rolled over to March 2020. The Local Mental Health Grant & SPD Scheme which forms part of core costs, now being facilitated by the BCUHB, will be put out to tender with services likely to be re-commissioned from April 2020. This therefore raises a potential serious threat to the smooth running of the centre as these funds currently cover core costs to the organisation.

Aberconwy Mind were successful in winning the tender to provide the Recovery Compass project on behalf of Conwy County Borough Council to provide mental health support services across Conwy for three years and we have now completed our third year of service delivery and funding has been extended for a year to prepare service users for the transition. Plans are being put in place to mitigate any future risk and we are looking at accessing funding from different sources.

Staff costs

No employee is paid more than £40,000 p.a.

COMMITMENTS

Pension commitments

The charity contributes to a defined contribution scheme for the benefit of its employees. The annual commitment to this scheme currently is approximately £6,500.

As the law on workplace pensions has changed, as an employer we are legally required to automatically enrol eligible staff into a pension scheme and make contributions. All eligible staff are now enrolled with the Nest pension scheme.

Grants - Revenue

Betsi Cadwaladr UHB

This grant contributes a grant and salary package to enable the organisation to meet its objectives of providing a support service and daily "Drop-in" centre for users in the Aberconwy area. An additional grant is used to provide support, therapeutic activities, promote opportunities for social integration and facilitate the development of skills of individuals with mental health needs within the Conwy County Borough area.

Conwy County Borough Council - Recovery Compass

Aberconwy Mind were successful in tendering to provide mental health support services across the county of Conwy. This three year project has now completed in March 19 with a one year transition extension until March 20

Lloyds Foundation – Enable / Invest

Enable: This grant supported the role of a researcher working with academics from Bangor University to research the effectiveness and benefits of our bespoke 'My Recovery & Wellbeing Plan'.

Invest: This grant follows on from the Enable research project and will be cover a period of 3 years and currently supports the role of a Day Services Modernisation Officer.

WCVA – Active Inclusion

We have been successful in acquiring 2 x ESF projects to support partial existing staff posts and creating new voluntary and paid supported placements within our social enterprise cafe. This grant is confirmed to December 2019.

Gwynt y Môr

This grant, which was to support the post of the Volunteer Coordinator ended in October 2018, the above Active Inclusion grant detailed above now supports this post.

Policy on reserves

Aberconwy Mind recognises that we need to ensure that funds are available to cover unforeseen eventualities that would result in the organisation experiencing financial difficulties. Recommendations by the Charity Commission, the Kings Fund and Mind are that six months running costs should be kept in reserve. Aberconwy Mind will endeavour to achieve this goal, however, if this is not obtainable due to financial restraints, then the minimum amount to be kept in reserve will be no less than three months running costs.

Plans for the Future

Aberconwy Mind plan to continue providing a mental health resource centre in order to promote mental health and assisting in relieving and rehabilitating persons suffering from mental health problems or conditions of emotional distress.

Agor: Open, our trading arm is now incorporated and it is hoped that all profits will support the future self sustainability after. Additional grant funding received will support the project during the transition period of building the business whilst also providing valued mental health support services.

We also plan to:-

- Investigate further funding opportunities in order to sustain and develop current staffing levels.
- To build on business opportunities through our trading arm.
- To look for additional ways to self generate income through utilising all space within our building
- Build on partnership working with our fellow Mind associations to maximise opportunities to generate additional income.
- To investigate further possibilities of local fund raising.



NOTES TO THE FINANCIAL STATEMENTS

FOR THE YEAR ENDED 31 MARCH 2019

1. BASIS OF ACCOUNTING

The financial statements have been prepared under the historical cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant notes to these accounts. The financial statements have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 16 July 2014 and the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102) and the Charities Act 2011.

The charity constitutes a public benefit entity as defined by FRS 102.

2. ACCOUNTING POLICIES

The principal accounting policies are summarised below. The accounting policies have been applied consistently throughout the year and the preceding year.

Cost allocation

Costs are apportioned between various expenditure headings as necessary in accordance with the best estimates of the trustees.

Tangible fixed assets

Equipment is stated at cost less accumulated depreciation. Depreciation is provided to write off the cost less estimated residual value of fixed assets over their expected useful lives. It is calculated on the original cost of the assets at the following rates.

Plant and machinery	20% on the reducing balance basis. 20% on straight line
Freehold and Long leasehold property	Nil 5% on the straight line basis

Freehold and long leasehold property, excluding the lift, owned by Aberconwy Mind has not been depreciated because, in the opinion of the trustees, the programme of refurbishment and repair maintains the property to a standard whereby the residual value will be maintained. Consequently, the amount of any depreciation would not be material.

The lift completed, in freehold and long leasehold property, is being depreciated over its estimated useful life of 20 years.

Voluntary income

Donations are accounted for when received.

Assets received by way of a gift are valued according to the best estimate of trustees, capitalised and recognised as a donation in the Statement of Financial Activities.

Grants receivable

Grants are not recognised until the conditions for receipt have been complied with. Grants applicable to future periods are deferred and recognised in those future periods.

Pensions

Aberconwy Mind pays defined contributions into externally managed pension plans for employees who are eligible and have entered into such contracts. Contributions are charged to the Statement of Financial Activities as they fall due.

Unrestricted Funds

Unrestricted funds are donations and other incoming resources receivable or generated for the objects of the charity without further specified purpose and are available as general funds.

Restricted Funds

Restricted funds are to be used for the specific purposes as laid down by the donor. Expenditure which meets these criteria is charged to the fund, together with a fair allocation of management and support costs.

INDEPENDENT EXAMINER'S REPORT
