CHAIRMANS REPORT

Good Evening everyone. This is my first year as Chairperson and, although I have served as a volunteer here in the tea bar for almost 6 years, being chair of this league of friends has taught me a great deal about this hospital. It has been a learning curve and believe me, I am still learning.

As a fund raising organisation, our aim is to help improve facilities both for the patients and the staff by providing equipment, some of which you have seen here this evening together with items for the patients' and staff comfort. During the last 12 months we have allocated over £74,000 for this purpose - quite a staggering amount I am sure you will agree.

Our income increases year on year and It amazes me how we raise these sums of money mainly by providing the facilities here in this room. Our fund raising events are however extremely well supported by members of the Abergele community who attend our coffee mornings, choir and Christmas concerts and not forgetting the annual summer fete which last year raised over £3,000. This years will be held on the 22nd June so please come along and enjoy our programme of performers and spend some money on our many stalls.

Abergele hospital is very much in the hearts of people who have been patients over the years or who attend the very busy ophthalmic and orthopaedic departments and this is shown by the donations regularly received - some of them extremely generous. You will see plaques on some of the chairs you are sitting on and these were purchased with donations from the family of the late Lloydie, who had been a very long-standing supporter of the LOF. Also money received from the Prestatyn LOF following their closure.

Not wishing to blow our own trumpets, but we receive such encouraging comments from both patients and the general public - we can only assume that we are doing something right.

Government red tape has raised its' ugly but necessary head this year in the form of the Privacy Policy, which we are required to have in place. I am more than grateful to Jan, my Vice Chair, who has spent hours preparing this and to Gill for typing it and it will, within the next few weeks, be available to all the volunteers for their information. There are many changes in policies which relate to the way we are required to adhere to it in running this type of facility and Jan keeps us all up to date on these - her brain is without doubt more up to speed on rules and regulations than mine is.

Our Rota sec. Iris has had a challenging first year in keeping the tea bar staffed but she has somehow managed even though we have had several of our team temporarily out of action with long term illnesses and we were all shocked and saddened by the very sudden passing of Sue Allen who could always be relied upon to provide trays and trays of cakes for our functions. She is very sorely missed.

It goes without saying that all this would not be possible without the help of all our wonderful volunteers and the committee members some of whom are here tonight. And I am grateful to them all for their continued support.

A very big thanks to Jan who, as my Vice Chair has guided me through my first year - believe me she is a fountain of knowledge and keeps her finger on the pulse making sure we are always up to date on various procedures. I really would not have had a clue without her input. Jan is stepping down as Vice Chair but if she thinks I will not be pestering her on a very regular basis she is very sadly mistaken - perhaps she should change her telephone number.

Daphne, our treasurer, is kept busy with our accounts and processes requests we receive from the hospital for equipment etc.

And lastly Sue our secretary who manages to keep on top of the all secretarial work following meetings and who is responsible for liaising on the choir and carol concerts and keeping the events calendar up to date.

This will be my last year as Chair person, but I am confident that when I give my 2020 report it will be just as encouraging - we do seem to get better the older we get.

So once again thank you for coming along this evening and for everyone's much appreciated support.
