#### MAJOR ACTIVITIES AND ACHIEVEMENTS IN THE YEAR

A separate report, detailing major Scouting activities and achievements this year, is associated.

The Special Grants and Activities funds have been combined into a Development Grants fund for the support of individuals, groups and permit and activity training.

The reserve funds from Middlewood plus the closing balance of Middlewood accounts have been combined to form the Hollinwood Trading reserve fund. A separate fund, for matched funding, has been set aside for the development of the new Hollinwood Scout Camp site

The International fund is kept in a separate CAF Bank, which is being used to receive individual's payments for International Expeditions, and to make payments related to those expeditions. This fund is shown as restricted as GMW is only acting as an agent. This account is or has been used by Roverway 2018, Malawi 2018, Climb Morocco 2018, Jamboree 2019 and Philmont 2019.

#### General comment

The Trustees' policy on reserves is to hold funds against specific purposes only. General funds shown on the closing balance are, therefore, all allocated to designated funds, as shown on page 3. Such funds are to enable the administration of the County and management of the campsites to be carried out in accordance with minimum standards and local initiatives, to provide support for adult training & development and the management of Scouting activities, to develop Scouting within the County and to allocate an agreed level of financial grants towards the furtherance of Scouting within the County.

The Trustees' policy on interest received from invested funds is to retain such income to preserve the value of the investments.

The renewal/replacement and acquisition plan for our assets continued, in line with our authorised budget.

The Trustees have identified the major risks to which they believe the County is exposed. They have reviewed these and established systems to mitigate them.

The assessed contingency has been revised to £17,491 in conjunction with our budget setting procedures.

The objects of the County are as detailed within the Association's Policy, Organisation and Rules.

The County is a trust established under its rules which are common to all Scout Counties.

Trustees are appointed in accordance with the Policy, Organisation & Rules of The Scout Association.

The accounts have been drawn up on the receipts and payments basis in line with the Scout Association's rules as amended by the Committee of Council in January 2005.

#### Next year

In the following 12 months there will be a continued drive to increase our membership, maintain and improve the quality of the progressive training programme and to keep valued records in accordance with the Counties development plan.

Like this year, we will celebrate the achievements of our members and to enable those awards to be recognised and appreciated by family members and the wider community.

The new structure will enable us to train even more leaders and advance our opportunities for gaining more knowledge, awareness and skills.

# INTERNATIONAL SECTION REPORT

During 2018 the major County International event was the MAD4Malawi Community project. The team worked in partnership with Kasupe, a UK based charity working in Malawi. The team completed number of projects including a water bore hole (drilled before arrival), solar pump, water tank, piping stand taps, kitchen area for the school, a fruit orchard, classroom makeovers and meeting local scouts. The team have always maintained original concept "Making A Difference For Malawi" and that is what it was all about creating a benefit to the local people. No less important was the **GMW Climb Morocco Event** with 6 leaders and 10 YP's. Some of the YP's were novices when signing up but through well planned training days and weekends Chris Starkie, Andy Bradley and the team got them to a good standard. New routes were logged and named achieving one of its major objectives.

The North West Scout Region International teams continued to work together on a fifth North West Region Scouts ShelterBox Scavenger Hunt in Liverpool and following another full event started preparation for the sixth event in 2019.

## DUNHAM PARK SCOUT CAMP

Starting our year was our very special AGM at Dunham Park to thank Pat and Bob Haynes who retired from the executive committee, when we arranged Davyhulme Band and a photographer who created a photo book of Dunham and the guests at the AGM, which was presented at our annual Christmas meal at the Swan with two Nic's.

We completed two major achievements this year, firstly the re-roofing of the Frank Harrop Lodge together with insulation in the roof and new gutters and barge boards. The second being a new electrical supply to the toilet block allowing us to install hand dryers, extractor fans, shaver and hair dryers in the adult facilities. We also have had architect plans drawn up for the other half of the block.

The duty wardens list was 90% covered which has been fantastic, allowing the shop and facilities to be fully open and the site to welcome visitors to look around. Camping and visitors have increased from 6,869 nights in 2017 to 8,366 nights in 2018.

The Tuesday crew have been busy as ever completing various jobs and projects around the site, making it look great. We had our first unplanned work this year with the campfire circle which spent about five months under a foot of water, originally an old pond which had been drained when the site was developed in the 1980's but the surrounding tree roots had invaded the pipe work.

The National Trust ranger, Andrew Wylie, finally came to our aid with a gizmo to help track the pipe and clear the blockages.

We had our annual site meeting with Stewart Robinson in January to review the standards of the site and discuss the plans for the climbing wall and the redevelopment of the toilet block, he gave us some contacts for exciting things such as road stone and stock fencing.

The unwelcome campfire pond put us back on our plans for the spring delaying the new gates at the site entrance, the reroofing of the Shooting and Archery ranges, the Tomahawk range and the Beaver trail around the site.

We have also looked at our lone working and Health and Safety policies at the site.

The management committee is headed by Jon Davis, Chairperson from Cheshire County and Judith Summersgill, Secretary.

Whilst the "friends" group announced in my last AGM report after a small delay got formed, headed by Paul Wilkinson, Pam Graham Treasurer and Louise Jackson Secretary and are to apply for charity status shortly.

We have also looked at the booking system and given feedback to make changes to allow customers to book easier and produce a condensed receipt / invoice.

Thanks to the work of our volunteers in refurbishing these, we now have a working wood processor which goes a long way to help us when processing trees; a training package has been put in place to train our volunteers going forward.

Other additions to the Laavus have been installation of land drains, footpaths and purchase of equipment such as safety gear and cooking equipment. We're unable to cover everything in this report as there's simply been too much to take in in terms of progress at Hollinwood since we began this journey. Weekends continue to be busy and we should rightly first point out the ongoing hard work and commitment shown from our dedicated core team. I'd like to thank Allan, Connor, Dan, Eric, Gill, Joe, John, Big Matt and Little Matt, Lindsay, Paul, Reese, Jack, Ian, Phil Rigby, Phil Rowe, Jacob, Al and Val, Dasa, and many others.

Literally through wind, rain or shine there's always a presence at Hollinwood, especially on Saturdays, and this shows in the way the campsite is developing.

If you think back to how the campsite was just a couple of short years ago, we've really begun to make our mark on the woodland and fields we're lucky enough to have.

The progress we've made on the Himalayan Balsam probably best embodies the way we've started to tackle challenges head-on.

It's meant we've reached out to various groups and organisations, we've had a task with a clear goal to work towards and each step we've made we've been able to congratulate ourselves on another bit of progress.

Everyone at some point has had a hand in it. It's also meant we've been able to connect with people who may never have heard of us otherwise and this in turn has led to donations towards the camp and offers of further help.

In short, we're not just getting rid of Himalayan Balsam but we're building connections, enthusiasm and support for the camp. Donations and grants to the camp have come from Worsley Rotary and Boothstown Wobble locally and recently as far as Sheffield for free scaffolding directly from the goodwill that exists around Hollinwood.

But of course, there's much much more to what we've achieved.

The team have really come together and here are a few highlights in no particular order;

- We built the brew room which meant having a good attitude to teamwork
- We built a bird hide which showed we cared about our surroundings
- We have rebuilt and maintained our patchy machinery showing our resourcefulness

- We have improved our surroundings and made Hollinwood a pleasant place to be which has led to groups wanting to return again
- We have reached out to the local community to show that we are not simply a place for us to hang out at weekends
- We have secured materials and machinery to help in our endeavours including a new trailer, flail mower and strimmers, fencing and gates showing that we're prepared to invest in Hollinwood
- We have responded quickly to urgent events such as break-ins and fires and stayed late until the problem has been fixed meaning that we care about the well being of Hollinwood and each other.

Additionally, 3 culverts have been placed across the main site ditch to enable better access to the site by way of a grant from the Woodland Trust and a temporary parking area has been levelled whilst we await the planning consent for the full car park. Further evidence that we're moving in the right direction.

But perhaps the biggest strides forward have taken place 'behind-the-scenes'.

There are a number of extremely dedicated people who are working tirelessly Hollinwood's ensure future. It quite hard to quantify the complexity of what is involved in making a campsite. For those who don't know, Middlewood came into being by virtue of a letter asking for the use of some land for the local scout group. Hollinwood is, shall we say, slightly different.

Some of the work includes: applications, planning change-of-use applications, meetings with our landlords, architectural meetings, meetings with consultants about surface water run-off, pilings and arboriculture reports, fundraising applications and presentations to local groups, evenings spent talking to councillors and Lord Lieutenants or working out how much things will cost with our quantity surveyors, poring over plans and drawings and asking around through contacts trying to find the right people to help at the right time.

One of those people is Tom Green who has supported us immeasurably through the minefield of designing and building Hollinwood.

I'd also like to give special thanks to Derek Batchen who has worked relentlessly sending, filing and tracking correspondence between many different parties and organisations.

The task is a big one but we're making good progress and in the next 6 months real changes are going to begin to happen quickly and each member of the team is central to making these happen.

Please, continue to be engaged and resourceful. Carry on working hard and looking out for ways that we can continue to make Hollinwood better.

Since May 10th we've had over 450 cubs, scouts, brownies and guides visit Hollinwood; Boothstown Scouts and Guides were the first group to 'officially' camp at the site in June.

This itself is an enormous positive and young people are already starting to benefit from the campsite. It means we've also been able to raise some revenue and improve our security over the summer months.

Requests to use the site are coming in from far and wide. Interestingly other scouting organisations like the Federation of Scouts de Europe and The Polish Scouts in UK, have both expressed an interest in not only using, but helping to build and develop the site.

We've also welcomed over 100 outside volunteers to the camp. This is going to be something that continue to support we in the next 12 months and is proving invaluable in increasing people's awareness of Hollinwood and in raising the large amount of money we need to build the site. Companies such as Sage, and Transport for Greater Manchester have all supported the site providing volunteers under their Corporate Social Responsibility programmes. Sale and Altrincham Conservation Volunteers continue to help too.

And, as always, we're looking to increase our team numbers and hope that our team will support us in doing this. We will continue to offer Hollinwood as a place where people of any age and skill can feel welcome to come and help.

#### What's Next?

Our full planning applications have been submitted and we hope to have positive outcomes in November. Services (Electric and Water) are to be completed as soon as possible.

We'd like to set up a 'friends of' group to encourage local involvement in the site, we are aware of a large number

of active local people with weekday time spare that would love to garden and socialise on a 30-acre plot.

Further invasive species removal is needed over the coming years. We want to continue to encourage active use of the site by groups in Greater Manchester West and beyond.

The construction of the toilet block and Start-up building is needed initially to enable more usage of the site as without the toilets Scout usage is limited by camping permit restrictions. Opening up of camping areas in the bracken patch and further tree planting will be available for groups to come and be involved and feel more connected to the site.

Improvements to site security to the east of the site is needed. Drainage on the camping fields is also paramount and will take many people working diligently to achieve.
