

KCRS was founded in April 2018 and launched to the wider community in June 2018. During its first reporting period, KCRS has concentrated on recruiting volunteers and supporters and raising funds in order to participate in the UK government's scheme for sponsoring refugees. Our main achievements for this period have been:

- raising awareness of KCRS within the local community;
- developing policies and associated management documents as required by relevant regulations;
- reaching and exceeding the minimum bank balance required by the Home Office for groups engaged in Community Sponsorship;
- drafting a refugee resettlement plan and supporting documents for approval by the Local Authority and by the Home Office according to the terms of the UK government's Community Sponsorship scheme;

- growing the KCRS membership as a basis for future volunteer efforts. We recruited members, supporters and volunteers; we enrolled 47 member subscriptions from individuals and 5 from organisations; and
- establishing and maintaining a relationship with the Local Authority.

### Structure, governance and management

KCRS is a Charitable Incorporated Organisation (the CIO) with voting members other than its charity trustees. Its activities and remits are governed by its constitution, adopted by the KCRS trustees at its Trustee Meeting on 17 April 2018. The trustees applied to the Charity Commission for a CIO to be constituted and for its registration as a charity. Registration took effect on 5 June 2018, whereupon KCRS became a body corporate.

The trustees' meetings are currently held twice per month.

We recruit our trustees by election by the AGM of members or by appointment (excepting this first reporting period, where trustees were declared in the application for registration or, since then, appointed.

## Financial review

In the period since incorporation KCRS has received several larger donations from the Kingston faith community and 47 individuals have taken up subscriptions. KCRS ended its first financial year with a net cash funds surplus of  $\pounds$ 14,541 thereby meeting the conditions for the Community Sponsorship scheme.

### Our receipts were £14,676

• <u>Membership subscriptions</u> were £945

Five faith organisations have taken up organisational membership, at £100 each:

Kingston Quakers Kingston Methodist Circuit Kingston St John's Anglican Church Kingston Peace Council Kingston Liberal Synagogue

Forty-two private individuals have taken up individual membership at £10 each, and five have taken up the concessions rate of £5.

Donations were £12,702

KCRS is very grateful for the generosity of various donations from faith organisations:

#### Our payments were £135

The main expenses incurred in the year were in relation to publicity for the launch of KCRS and local fund raising activities.

### Policy on reserves

Free reserves are defined as unrestricted funds less the net book value of any fixed assets held. As at 31 March 2019, KCRS had free reserves of £14,541.

KCRS reserve policy is to hold a minimum free reserve of £3,100 in order to smooth income flow and so facilitate future sustainability of the charity's activities.

The trustees have set out their intended use of the KCRS free reserves in note 5 on page 10 to the accounts. KCRS reserve policy will be reviewed annually, or more frequently if major changes of circumstance require this.

## Trustees' responsibilities

The trustees are responsible for keeping proper accounting records and for ensuring that the accounts comply with the Charities Act 2011 and the KCRS constitution.

The trustees are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud or any other irregularities.

The trustees have determined that the audit requirement of section 144 of the Charities Act 2011 does not apply.
