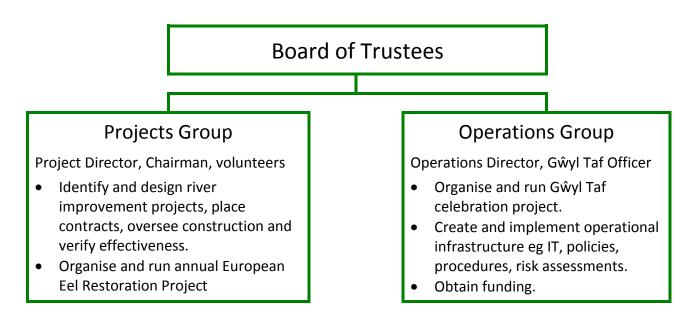

5. Organisation



The current number of Trustees and volunteers does not allow us to have a large number of Committees or sub committees. Therefore, two groups have been established who both report directly to the board of Trustees.

The Project Group is still focused primarily on river improvement projects, and the new European Eel Project in schools. We continued to run the eel project with seven schools, one six form college and two education centres. The Operations Group looks at, funding, governance and staffing. Plans and progress are discussed at the Board of Trustees meetings every two months, and each group leader presents an update.

7. Objectives

The objectives of the organization are: -

- a. To promote the conservation, protection, rehabilitation and improvement of the rivers, streams, water courses and water impoundments in the rivers Taff, Ely, Rhymney, Ebbw, and Sirhowy together with their catchment areas in all their aspects in South East Wales and adjacent areas of their banks and riparian lands;
- b. To promote the conservation, rehabilitation and protection of the indigenous species of animal and plant life of the rivers, streams, water courses and water impoundments in the Rivers Taff, Ely, Rhymney, Ebbw, and Sirhowy together with their catchment areas in all their aspects in South East Wales and adjacent areas of their banks, riparian lands and thereby enhance the biodiversity in the South East Wales area;
- c. To advance the education of the public in the understanding of aquatic habitats, their related catchment areas, and their animal and plant life and the need for the conservation, protection and rehabilitation and improvement of such environments.

8. Goals for 2018/19

- The Gwyl Taf project has now finished successfully.
- We were successful in applying for the Rural Development fund for the Taf Bargoed catchment.
- Develop fundraising capacity within the Trust. This has started with Dr Marsh Smith taking on the role of CEO of Affonydd Cymru. His expertise at raising funds is already helping all member trusts
- Deliver a European Eel Project in 2018 which will also run in 2019
- Maintain involvement with community partnerships and local and national bodies.
- Further develop policies, procedures and operating practices as needed.
- Maintain active involvement with Afonydd Cymru and the other Rivers Trusts working in partnership wherever possible.
- Work towards the securing of the funding from the Cardiff Bay Salmon Mitigation Project that we can use as match funding where necessary for a European Marine Fisheries Fund for the freshwater stage of migrating fish. The European Marine

Fisheries fund was granted in June 2018 but we could not start it until September 2018. Several project have been worked on for us to be able to use this fund and these will be progressed in 2019.

- Water quality of Cardiff's three main rivers and tributaries can be tackled with the above. We hope this may improve how we work with the local environment groups as well as Farmers in the Ely and Vale where the rivers and streams run into the Taff watershed.
- The impact that the water quality is having on the local environment can be greatly improved by the above.
- The groups who we worked with were Natural Resources Wales, Welsh Water, Keep Wales Tidy, Groundwork Wales Angling Clubs and River groups as well as Councillors and Council officials. The funding we had for a survey on the river Ely, the survey will now help us establish a pattern of work on this river. The employment of a Farm Advisor a post that has been critical in other trusts working with farmers, will be a priority.

Performance in Delivering Goals

- Our volunteer capacity continued to be used with the area of undeveloped land adjacent to the river continuing (Gwyl Taf).
- In 2017 we were successful in a bid to the Rural Development Fund and we have successfully appointed a Project officer to run this Project. He did not start until March 2018 so the project will now run until Sept 2019. On this RDP project the officer exceeded all his targets and more during the year. This will be beneficial for year two. He also joined in to our European Eel project, as well as making a major community impact working with local people on the ground Our report for 2016/17 mentioned in the plans that we would be working on a Project on the River Thaw. The seed funding from RWE Power led to Dwr Cymru Welsh water adding extra funds under one of their programmes, Natural Resources Wales also supplied funds for this project. It started late in 2017 and has continued through 2018 with completion of the use of the first tranche of funding for the river being used up by Dec 2018. More funding is in the pipe line.
- Relationships with all partners have continued

9. Plans for 2019/20

Our main focus for the coming financial year will be to continually look for more funding and projects. A new fund in Wales the SMS or Sustainable management Fund was launched and working in Partnership with Merthyr Council a bid has been made. The outcome will be known in 2019. Continue to progress the use of Cardiff Bay Mitigation fund as well as the use of funding that has been given as a civil sanction. A civil sanction is where a company volunteers to pay a sum to benefit the environment in the main after it has caused environmental damage through some error in its management process. The sum will be paid to improve the environment where the pollution occurred as well as further afield. It is paid without court proceedings but the incident if repeated can lead to prosecution if it occurs again. Continuing the RDP project and the Taff Mitigation Project.

10 Financial Management

Financial Policy

In accordance with the Memorandum of Association, the Trustees retain overall responsibility for the implementation of financial policy in furtherance of the objects of the Trust. They delegate powers for day-to-day running of the Trust to the Projects and Operations Groups.

11.Reserves Policy

It is the aim of the Trustees to maintain a level of reserves sufficient to carry out the objects of the Trust. Where the Trust has been involved in habitat improvement projects, completed in partnership with Natural Resources Wales and other funds, these organisations meet the full capital costs of the schemes thus minimising the potential liability of the Trust. The Trust contributes to these projects with volunteer time. Where possible the Trust looks for extra funding.

12.Risk Management

As a small charity, the Trust is managed by a close-knit group of highly committed and professional individuals with the benefit of expertise and advice from Afonydd Cymru and the River Trust. Public Liability & Personal Accident and Trustees Indemnity insurance cover are in place. Careful risk management of projects undertaken in partnership with other agencies ensures that all projects have an agreed cost ceiling and on completion of each project no contractors are paid until money is received from the project partners.

13.Principal funding sources

To date these have been from Natural Resources Wales, Greggs the Bakers. Some funding is ring-fenced, as it has been given for specific purposes. 2018 Saw European funding through the RDP Project coming in as well as the previously mentioned Cardiff Bay Fund.

14.Trustees Responsibilities

Company and charity law requires the trustees to prepare financial statements for each financial year that give a true and fair view of the state of affairs of the charity and of the surplus or deficit of the charity for that period.

The trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charity and to enable them to ensure that the financial statements comply with the Companies Act 1985, applicable standards, the statement of recommended practice and the regulations made under the Charities Act 1993. The trustees are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

Report of the Trustees for the Year Ended 31 March 2019

The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 31 March 2019. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015).

OBJECTIVES AND ACTIVITIES

Objectives and aims

The objectives of the charity are those of promoting the conservation, protection and improvement of the waterways within the South East Wales catchment area together with that of the indigenous species of animal and plant life in such waterways. In doing so, the charity will undertake to advance the education of the public in the needs and requirements of aquatic habitats and support the social and economic regeneration of the catchments by engendering the sustainable use of the river valleys and the associated environment with benefits to the region's economy, social well-being, tourism and regeneration. The charity will act as a focal point and coordinator between similar organisations and with the national authorities to achieve these goals.

Report of the Trustees for the Year Ended 31 March 2019

ACHIEVEMENT AND PERFORMANCE

Business Review for the Year During the year the Trust, again carried out a European Eel in the Classroom Project to replace the work we have carried out with Salmon for many years. This engendered much interest as there has always been a mythical belief about Eels. The Thaw project was the Catalyst for the Eel project and has developed into a wider Thaw Habitat Improvement Project. The Trust intends to keep this project going and are actively look for funds to do this.

The Trust Directors and volunteers continued with their Angling Taster days, involving the large number of registered Coaches within various South Wales Angling Clubs. During the year such events continued to be very well received, especially the events during the National Fishing Months of July and August. This coaching work, as well as catering for able bodied individuals, also attracted a considerable number of disabled and disadvantaged individuals of all ages. This important project has, over the years, introduced a large variety of individuals into the sport of Angling.

The Gwyl Taf Project ended before the end of March 2018.

New courses for schools had been developed as part of the Gwyl Taf project such as "You and Your River" and "How Your River Works", and these were trialled during the 2018 -19 year. The courses proved highly successful in our Regional Development Project mentioned below.

In order to try to diversify the sources of funds, we applied for funding from the Rural Development Fund and this was progressed to a successful conclusion when we were awarded the funds in late 2017 with the first income being received, this year, in June 2018. This project is the Taff Bargoed Rural Development Project and is aimed at involving the local community. We employed a dedicated officer to run this project who started in March 2018. It is a catchment based project and the hope is that success with this project in teasing out the catchments problems will lead to a very much larger bid being made to a Sustainable Management Fund. During 2018 the targets set for this project were exceeded by a large margin and our work together with the Project Officer's work has proved a huge success. Part of the project was to run a River Restoration Course. Three persons finished the course and in the months following, they found work. The knowledge they gained from the course helped them to decide a future work direction.

Substantial funding was given to the Trust from what is called a Civil Sanction settlement just before this year commenced. A "Civil Sanction" is where a company or organisation does environmental damage and it is certain a court case will result. During the fact finding stage, to avoid a court case, the company can ask to pay out a Civil Sanction for work to be carried out in or near to the area where the environmental damage occurred, or, in agreement with the prosecuting Authority, in an area where the spending of the Civil Sanction will result in the greatest benefit to the Environment. In our case this has resulted in two flows of funding.

Firstly as a result of the March 2018 Civil Sanction receipt, we established a project - The Taff Ely Alternative Mitigation (TEAM) Project. Using this Civil Sanction Funding as matched funding, we were successful in attracting further funding from Natural Resources Wales that they had held in abeyance in a fund called the Cardiff Bay Mitigation Fund for work that it was considered needed doing to help the Salmon population on the River Taff post the closure of the Cardiff Bay Barrage. This enlarged TEAM project fund enabled The Trust to employ a new Project Officer for the TEAM project who will be looking at many areas of work that have been identified by Natural Resources Wales as being essential work to improve the River Taff system for migratory fish passage and spawning. Our work has already, in the year, enabled us to complete some of these projects and these can be seen on our new Web Site www.sewrt.org.

Report of the Trustees for the Year Ended 31 March 2019

ACHIEVEMENT AND PERFORMANCE Business Review for the Year

The second Civil sanction received in the year was via Welsh Water, who allocated funds for the Trust to look into Taff Habitat Improvements. As a direct result of receiving this Civil Sanction Funding in late 2018 we have employed a Farm advisor who in 2019 brings the number of Project Officers we employ up to three.

The consolidated six Trusts in Wales, being, South East Wales Rivers Trust, West Wales Rivers Trust, Clwyd Conway and Gwynedd Trust, The Dee Rivers Trust, The Wye & Usk Foundation and the Severn Rivers Trust (The Severn Rivers Trust carries out much work in Wales and is called a Cross Border River Trust), have allowed Affonydd Cymru to make an "All Wales" bid to the European Marine Fisheries Fund for funding on Migratory Fish Rivers. This fund was applied for by Stephen Marsh- Smith OBE CEO of Affonydd Cymru. Approval for the funding came through in early January 2018, but as with all these funds, it was not until later in the 2018 year that the final consent was given. Work on this project with this fund will start in 2019.

With thanks to Greggs the Bakers, we continue to use a small shop unit owned by them, as an office base in Treforest. This is proving a very useful base for our employees and volunteers to work from and have meetings at. Greggs have been a substantial supporter of the Trust and we are very grateful for all the help they have given us in not only providing this unit but also for them assisting to fund the Trust, over the years.

On the main funding front, the Trust is very grateful to Natural Resources Wales, from where the majority of our funding comes. We will continue to look for more funding avenues that can spread the funding requirements of the Trust.

Looking forward 2019-2020 will be an exciting year for us working on all the projects indicated above as well as planning a funding bid for work on one of our main Rivers in the Taff Catchment the River Cynon. We will also look to bid to the Post Code Lottery for this fund.

FUTURE PLANS

The directors and trustees will continue to work closely with all its partners and contacts to release additional funding that will be used to promote our aims and objective and to build on our past successful projects.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The charity is controlled by its governing document, a deed of trust, and constitutes a limited company, limited by guarantee, as defined by the Companies Act 2006.

Organisational structure

The Trust was established as a company limited by guarantee with each member agreeing to contribute £1 towards the payment of any debts should the company ever be wound up and unable to pay it in full its liabilities. In the event of the company being wound up with a surplus of assets after all liabilities have been met, all such surpluses will be distributed to like-minded "not-for-profit" organisations.

Decision making

The Charity is organised and policy implemented through the Board of Directors who meet every two months.

ACCOUNTING POLICIES 1.

Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015), Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Financial reporting standard 102 - reduced disclosure exemptions

Income

All income is recognised in the Statement of Financial Activities once the Charity has entitlement to the funds and it is probable that the income will be received and the amount can be measured reliably.

Specific Projects Funding Income is primarily received from Natural Resources Wales and Welsh Water with the remaining project income coming from other institutions both private and public. All Income and Donations received are in relation to the charity's primary objectives as detailed on page 1 of the report of the Trustees.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Taxation

The charity is exempt from corporation tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the Restrictions arise when specified by the donor or when funds are raised for charity. particular restricted purposes.
