Report of the trustees of Capel Parish Nurses for the 1 September 2018 to 31 August 2019

1. Structure, management and governing document

The trustees who held office during the period 30 June 2017 to 31 August 2019 and the governing document are detailed in the charity information on page 2

- a. New trustees are appointed by the existing trustees.
- b. New trustees are inducted by the existing trustee body.

2. Objectives and activities

The main objectives of the charity as set out in the governing document are:

a. The relief of sickness and the preservation of health, in accordance with a Christian ethos in and around Capel St Mary by the provision of Parish Nurses.

3. Achievements and performance

The main achievements of the charity in the accounting period were:

- a. To pay our Parish Nurse OT to set up and run a Dementia Café using funding received from Suffolk Community Foundation, given by the Dementia Friendly Communities Grant Programme.
- b. To establish a Craft Club aimed at tackling loneliness using specific funding from Suffolk Community Foundation given by East of England Co-op.
- Training a volunteer Mental Health Occupational Therapist who is now accredited to Parish Nursing UK.
- d. To maintain our volunteers to work with the Parish Nurses Team and to train a new team to support the work of the Dementia Café.
- e. Serving the community of Capel St Mary by the provision of advocacy support, health education, increasing and maintaining safety and independence within the home and continuing a monthly Hope Hub café to support those with mental health issues.
- 4. The policy of the trust is to maintain 6 months of expenditure as free reserves.

5. Funds

The reserves from last year included earmarked grants received for specific purposes which were underspent at 31 August 2018. As detailed above these grants have been spent on new initiatives which have become established this year. We are currently in the process of applying for further grant funding to enable these activities to continue.

6. Public Benefit Statement

a. The trustees have considered the Charity Commissions guidance on public benefits. The trustees are satisfied that the reported activities for the year show that a good level of public benefit is being delivered.
