Report of the Trustees for the Year Ended 31 March 2019

The Trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 31 March 2018. The Trustees have adopted the provision of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015).

Report of the Trustees for the Year Ended 31 March 2019

## OBJECTIVES AND ACTIVITIES Objectives and aims Charity Aim

The Salford Foundation Trust is a grant giving charity that helps children and young people to develop their hobbies, interests, skills and talents by providing funding that would otherwise be unavailable from any other source. It does this by offering the opportunity to apply for funding and provides support for young people between the ages of 5 and 25 who live in Salford. Priority is given to applicants under the age of 21.

## Overall Expenditure for 2018-19

This year The Trust received 65 applications across three funding rounds.

Of the 65 applications submitted, 53 received grant funding with a further 9 successfully submitted to a partner organisation where the request did not meet the Trust's criteria for funding.

The total expenditure for the year was £12,439 (which includes a number who were still receiving staged or continuous payments from the previous years).

#### **Operational Development**

In this year the Trust has been engaged in offering wider support to applicants including referral to other forms of support for families including debt advice and access to personal support services. The Trust is now engaging with the wider issues of the family - typically around debt/lack of income, lack of confidence to access services. Poverty and consequential additional needs not normally the remit of the Trust have been identified and the Trust has provided a signposting/advocacy role to enable access to services that may provide families with the route to address their issues and stabilise family income. This stabilisation will allow some to fund the opportunities for their children and allow the Trust to divert attention to others who require immediate support to access opportunities and to provide longer term support for children in families where circumstances are less likely to change for the better.

The Board has reviewed its Objects in the light of this increased demand and it is the intention to seek adjustment to the Objects in the next financial year to better reflect this additional role.

During the year there was also:

- o An amendment to the application form to better understand family circumstances and family sources of income e.g. nationally recognised benefits to better prioritise need.
- The launch of a new Website providing clearer information for users and potential donors.
- An application to Salford University Business School for volunteer interns to assist in developing the marketing and social media profile.
- o The production of a short promotional film to promote the Trust at a golf day dinner.
- A new award, the Len Collinson Award, was established. Mr Collinson was a personal contributor to the Trust and died in 2018. In recognition of his support it was agreed that there would be an award made in his name. For 2018/19, the recipient was a young dancer who has been supported by The Trust for two years for his attendance at a renowned centre of excellence for ballet.

## Partner Engagement

The Trust has two key groupings - a grant awarding Sub-Committee and a Board of Trustees:

The Sub-Committee includes representation from other contributors including Salford Community Leisure and a local McDonald's franchisee along with Trust Board members.

McDonalds lent their support by providing two opportunities to one of The Trusts recipients who was representing England at the Cerebral Palsy CP World Games in August 2018. He and his Mum raised £268.10 at the Eccles McDonalds and £173.14 at the Urmston restaurant - a total of £441.24.

#### **OBJECTIVES AND ACTIVITIES**

#### Objectives and aims

In the second quarter of 2018 BNY Mellon's Manchester office employees chose to fund raise for The Trust. Activities included participation in the Great Manchester 10K and Half Marathon, a toy donation of \$7 per toy donated to the charity for distribution and 18 participants engaged in the July, "Tough Mudder" Challenge. There was also an in house raffle with all monies from tickets sales going to The Trust.

There were additions to the Board during the year including Mr Lee Morgan, Managing Director, Thermatics and the reappointment Mr Tony Bannister. As part of their planned support for the Trust, Thermatic will also be adopting The Trust's logo onto all new van livery. This will say "We are supporting The Salford Foundation Trust". They also displayed one of The Trusts collection boxes in their staff communal area to encourage donations and make visible their support in house.

The Trust continues to work closely with organisations across the City to identify children and young people who most need our support, including Youth Offending teams, Salford Sports Network, MAPAS, employment referral agencies and Gaddum, the Salford Young Carers Association. - with 26 different sources of application.

### **Types of Applications**

Of the 53 applications approved the Arts category including performing arts was awarded and received the highest number of applications for consideration. Sport was the second highest category of applications funded followed by Hobbies.

#### **Case Studies**

Jacob competed at the Cerebral Palsy (CP) World Games in Barcelona. Jacob participated in the 200 Individual Medley, 100 Breaststroke, 100 Freestyle, 400 Freestyle and the 100 Backstroke where he achieved a silver medal. He was one of the youngest in this competition at 14 and was up against 20 year old athletes, as the rules state that it is the classification on the day, rather than the athletes' age group. Jacob's Mum, Ann Marie, said about The Trust. "Myself and Jacob would like to thank you for the support you have given Jacob over the last few years and I genuinely believe his achievement would most definitely not have been possible without your help."

A young carer who supports her father, who is no longer able to work due to disability, has been supported to attend drama training. Her ambition is to become a professional actor

Siblings have been supported to continue their football and swimming sessions following the loss of their father this year following a short illness. This in turn impacted the family's income substantially, that they would no longer have been able to continue these pursuits.

A young swimmer with learning disabilities has been supported to continue her swimming training. As she advances in her competition opportunities, the single parent family have an escalation in costs, to support her development with the ambition to become a Paralympic athlete in future

## **Notable Personal Achievements**

Nick Abbott, Chair of The Salford Foundation Trust was awarded Trustee of the Year award 2018 at the Heart of Salford Awards.

Having won the Salford Sports Network Achiever of the Year Award 2018, Ewan Wilson, a young swimmer funded for seven years by the Trust, went on to win The Greater Manchester Sports Achiever of the Year 2018.

#### **Support and Donations**

In the year, Salford Foundation contributed £13,532.88 to fund salary, NI and pension costs for The Trust's Project Co-ordinator. This ensures that all donations received are used to support the direct costs of the opportunity for each applicant and not on the administration of the Trust. Salford Foundation also donated £11,071 to support young people.

#### **OBJECTIVES AND ACTIVITIES**

This year the Trust benefitted from a number of other kind donations:

- o In May 2018 a number of people nominated the Trust as their charity for the Greater Manchester Half Marathon and 10K run including Property Tectonics, Salford Foundation and BDO. BNY Mellon contributed an additional 50% of all funds raised by their staff and Salford Foundation matched the amounts raised by their staff. The event generated a total of £5,710 after the purchase of places and running tops.
- o Private donations of £4,000.
- Salford Community Leisure also continued to support the Trust with a donation of £2,000.
- Property Tectonics donated £4,250 through fundraising activities including the Greater Manchester 10K Run and their Annual Golf Day.
- A bag pack took place in December at the Morrison's store in Eccles with the support of community volunteers raising £332.

The total donation from partners to be used to provide financial assistance was £34,329.

Additional plans for 2019/20 include a 24 hour five a side football event and a charity ball.

#### Conclusion

The year has seen a period of growth in active participation by supporters. This has provided The Trust with an opportunity to:

- o raise its profile further amongst prospective applicants and/or organisations who are active in the community
- o increase public awareness through extending the marketing of the Trust via social media and newsletters and rebranded website salfordfoundationtrust.org.uk
- o increase awareness with private sector partners.

Our thanks go to our Trustees, volunteers who have participated in fund raising events through their businesses and to all the referees who have taken the time to support applications and engage in ongoing dialogue with the Trust to ensure that the resources available make the most impact on the lives of children and young people.

### Public benefit

The Trustees confirm that we have paid due regard to the Charity Commission guidance on public benefit reporting in deciding what activities the charity should undertake.

#### FINANCIAL REVIEW

#### Reserves policy

The Trust has reserves of £42,940 at the year end. Minimum reserves are maintained, as funds are held primarily for distribution in grants.

### STRUCTURE, GOVERNANCE AND MANAGEMENT

#### Governing document

The Salford Foundation Trust (SFT) is governed by its Memorandum and Articles dated 19th March 2015 and run by a rotating board of Trustees who constitute the membership, there are no other members.

The Trust obtained its charitable status on 4th August 2004.

The Salford Foundation Trust was born from and initially funded by Salford Foundation Ltd (SF), whose views are represented at SFT board meetings by four Trustees it has nominated. The remaining five Trustees of SFT are independent of Salford Foundation and thus ensure Salford Foundation Trust runs as an effective independent body.

If a Trustee who is representative of Salford Foundation Ltd ceases to hold office within SF, they shall resign as a Trustee of The Salford Foundation Trust. However, if there is a vacancy for a non-SF representative or the numbers of the Trustees is increased, they can be nominated by SFT to hold non-SF representative position on the board.

Salford Foundation representatives can hold office for three years without re-election and will be responsible for replacing a Trustee who is not a representative of Salford Foundation, whose maximum term of office is one year.

The Trust Project Co-ordinator reports to the Chief Executive of SF, who regularly meet to update on the progress of The Salford Foundation Trust. Applications to SFT are assessed by a committee which meets every three months and compromises of four Trustees chosen by rotation. Board meetings are held every two to three months.

#### Risk management

The Trustees have undertaken a policy of risk management and have endeavoured to ascertain the likely risks that they are subject to and have considered appropriate policies to deal with the risks which are foreseeable in relation to the operation of the organisation.

#### 1. ACCOUNTING POLICIES

## Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

#### Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

## Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Grants offered subject to conditions which have not been met at the year end date are noted as a commitment but not accrued as expenditure.

#### Taxation

The charity is exempt from corporation tax on its charitable activities.

#### Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.

## Pension costs and other post-retirement benefits

The charitable company operates a defined contribution pension scheme. Contributions payable to the charitable company's pension scheme are charged to the Statement of Financial Activities in the period to which they relate.
