### **Objectives and activities**

- A. To promote the arts for the benefit of the public in the district of Craven, North Yorkshire, and adjacent areas, in particular by encouraging access to, engagement with and participation and creativity in the visual arts;

Craven Arts had a very well attended Christmas exhibition exhibiting 24 artists' work Skipton Town Hall on 1st -22nd December 2018 and with Craven Arts Weekend demonstrations of 18 artists professional process.

This is the third year that the exhibition has been held and it built on the success of the first years. As such there were greater benefits for the venue and Skipton as a location for displaying visual arts.

It was important to show case the event during the Christmas weekends when visitor numbers were expected to be high and it gave Craven Arts the opportunity to contribute to the Christmas event by offering visitors to the town an additional attraction during their visit to what is clearly a lucrative event for the local economy.

There were 18 mediums described in the artist's work providing a broad and eclectic mix for the exhibition visitors to enjoy. The breadth of the mediums displayed clearly demonstrates that there is a wealth of artistic skill and varietythat can be used to promote arts in the Craven district.

The visitors and artists alike respond well to the art exhibition being in the Town Hall. Craven Arts got nice press from the exhibition. We hope to return to the space with the Christmas Exhibition after the repairs have been completed.

# Summary of the main achievements of the charity during the year

In addition to the Christmas Exhibition described above, Craven Arts hosted Craven Arts Weekend: Arts Trail

1.On Saturday 25th- Sunday 26th August 2018

Craven Arts members hosted a weekend of creative displays as Craven Arts Weekend:

Summer Arts trail in Skipton combined of 18 artists demonstrating their professional process organized as free to public to visit.

There were 5 locations and about 300 visitors on that weekend.

This was the third full year for Craven Arts as a CIO and the main achievements were the Christmas Exhibition and the Craven Arts Weekend together with a membership totaling over 65 artists.

We are growing in the speed of about one new member every week.

We started our successful collaboration and members exhibitions in Mill Bridge Gallery in April 2018. Eleven members exhibited during April 2018 to 2019. Collaboration continues with the new year long series of twelve new exhibitions with even more integrated collaboration with Mill Bridge Gallery.

Craven Arts started our successful opening of our first Studio in June 2018 on 7a Otley St. Skipton. 5 artist members have worked in the premises during June 2018 - April 2019. 8 artists have exhibited on the Members CA-Wall during this time and sales from the space are up every month along with the number of Workshops hosted in the Space. Visitors numbers are up too and there are about 5 people visiting every week day and about 10 people every Saturday.

We started Work-experience Program with Craven College creative students. So far we have had 3 work experience students working with Craven Arts and some artists and the experience has been pleasant.

Craven Arts has no policy on reserves as yet. It is a not-forprofit charity with minimal receipts and expenditure. There is a small balance of cash held in the bank.

The principal source of fund for the year were membership fees and bank interest. We also got grant from CDC and NYCC Councillors (Solloway, Madeley, Rose, Dawson) of £800 to buy furniture and essentials for the studio space.

The main event financially was taking on the studio which was initially expensive in setting it up and it not being fully occupied. However now it is fully occupied it is bringing in a steady small income. The selling opportunities of the Christmas Exhibition and Arts Trail were both run on a cost neutral basis. All of these help to achieve both our objectives (as noted above)

No investments were made during this period and therefore there is no policy in place.
