#### Objectives and activities

#### Summary of the purposes of the charity set out in its governing document

To advance education and relieve financial hardship amongst migrants, those seeking asylum and those granted refugee status, particularly by the provision of advice and guidance. To advance the education of the public in general about the issues relating to refugees and those seeking asylum.

Summary of the main activities in relation to those purposes for the public benefit, in particular, the activities, projects or services identified in the accounts

Weekly drop-in session (The Hub') providing information and support sign-posting help, English lessons for adults, Turkish and Arabic lessons and homework help for children, activities for younger children, shared meal, and regular guest speakers. Weekly youth club ('4 Comers') providing a range of social activities, sports and trips for young people aged 11-18 from the community. Weekly coffee morning groups to reduce isolation, a weekly Men's Group, and weekly Wellbeing for Women project. Additional one-off programmes such as health and fitness through the provision of Zumba classes and information on healthy eating, parenting courses, a mentoring scheme for young people, and a programme to develop employability and related skills. Hardship support for families and individuals facing destitution.

The trustees consider that they have complied with their duties to have due regard to the public benefit guidance published by the Charity Commission.

#### Achievements and performance

Summary of the main achievements of the charity, identifying the difference the charity's work has made to the circumstances of its beneficiaries and any wider benefits to society as a whole. We have continued to run our weekly drop-in service, known as The Hub. This year we have run 35 x 3 hour sessions. The main activities at The Hub are:

- Turkish & Arabic language classes, now including GCSE level, for children to develop confidence, self-esteem and language skills
- Educational support, including extra help for children who speak no English when they start school as new arrivals in the UK; help with homework for children whose parents are unable to assist them; liaison with schools
- English language classes for adults and teenagers, who because of cultural barriers or immigration status do not attend existing ESOL classes in York but whose English is very limited. We also support learning of adults and teenagers who are able to attend ESOL classes
- Talks from voluntary & statutory service providers in York to ensure that this community can access health, leisure and social services
- Signposting to key agencies e.g. Citizens Advice Bureau, Education Department, legal advice, mental health services, housing, specialist immigration advice
- We are seeing an increasing number of families and individuals with complex immigration needs, who we are able to support by referring to or liaising with other agencies, and offering help from our Hardship Fund where appropriate
- A safe space where men, women and children from refugee and migrant communities, and volunteers from York, can meet together and share food.

We offer additional support outside The Hub to families who are particularly vulnerable and isolated. This includes:

- A hardship fund for destitute families and those experiencing severe financial hardship
- Home visits for families who are particularly isolated
- Liaison with legal services for those seeking asylum
- Access to leisure services we register families for the library, free passes for local museums, arrange for parents and children to access mother and toddler groups, and support children to access swimming pool etc
- Additional homework support in the home for children whose parents speak little or no English and who are struggling to keep up in school

- Weekly coffee mornings, to reduce isolation and provide an additional opportunity for English conversation practice
- A Weekly Wellbeing for Women project, including mother & baby group and free Zumba class for Women
- A Weekly Men's group
- Parenting courses, with translation into Arabic and Turkish, run in partnership with Family Matters

An independent evaluation was undertaken over the Hub during the year. This evaluation demonstrates that Refugee Action York:

- is providing opportunities for individuals to meet and socialise within their own community groupings, and with people of other diverse backgrounds
- provides opportunities for refugees and asylum seekers to share their own cultural heritage and learn more about British culture and history
- makes a contribution to improving participants' general sense of well-being, reducing their sense of isolation, and boosting their self-esteem
- · supports children and young people to do something positive and enjoyable
- · is providing significant benefits to partner community and voluntary organisations
- · provides secure environments in which people can learn, play and relax.

This evaluation also included obtaining direct feedback from service users:

- "Learning English has helped with life in this country. Can speak to wider community, go shopping and make an appointment"
- "Good advice on health and schools"
- "Felt lonely but much happier now"
- "RAY has been a hope for my future. If RAY wasn't here I would feel so bad and stressed"
- "I am really happy and proud of where I am with my English. Without RAY I would not be able to do this"
- · "I have made some friends who will be with me for life"

The report listed some benefits to service users:

- "vital lifeline for them" RAY provides a safe, supportive learning environment to help ease refugees into the wider community
- Reaches the most hard to reach
- Service users would probably not otherwise access these services particularly as ESOL provision has been cut back
- So much more than an English lesson. Provides opportunity to make friends, learn wide range of skills from a whole range of classes on offer.
- One to one support in dealing with individual problems, signposting on to relevant services and helping ensure they are picked up by these services
- Demonstrates particular strength in helping service users to access health services, successfully working in partnership with health visitors, GP's and the Housing teams.
- Project provides the gateway to mainstream services they need. Service users trust staff at RAY and will be guided by them in understanding the rules and requirements of a particular service

The evaluation also included direct feedback from other external stakeholders & partners:

- Staff and volunteers always helpful and communicative. Viewed to be professional and dedicated. High praise for Manager for her leadership skills and clear commitment to the project.
- · Staff have a positive and non-judgmental approach to volunteers and are a good role model.
- "Very positive. Good communication and working relationships which means we talk about user problems speedily and resolve difficulties quickly"
- Have a "can do, pro-active approach and are always looking for new ways of working and new ideas to improve"
- Strength of RAY is integrating young people and families into what is available in the City. Helps build confidence.
- Massively needed and well thought of service in the City.

#### Financial review

#### Review of the charity's financial position at the end of the period

2018-19 has been another year of growth for RAY, and this is reflected in the charity's finances for the year with both income and expenditure increasing accordingly. Core services have continued to be in high demand, with additional services delivered where a need was identified. As a result of this demand, spending has exceeded income, with a proportion of this representing a utilisation of restricted funds brought forward at the start of FY19, and the remainder being the use of some reserves in order to maintain services during transitions between funding partners. The medium-term outlook remains positive, with funding from The Big Lottery Fund and Children in Need in place until 2021. The Trustees continue to work hard to secure funding adequate to deliver RAY's services sustainably, whilst also maintaining reserves at an adequate level. RAY's existence and success remains due to the generous support of individuals, community groups, businesses and trusts, both within York and from further afield. The Trustees wish to take the opportunity to recognise and thank everyone who has contributed to RAY's financial position in the year, without which the services and support provided to service users would simply not be possible.

#### Statement explaining the policy for holding reserves stating why they are held

Reserves have fallen slightly in the year, as a proportion was utilised in order to maintain RAY's services whilst funding was secured. The level of reserves at 31/03/2019 is below the stated policy of holding 6 months of running costs of RAY's core services. As demand for services has grown, spending on core services has increased markedly in the year which, in combination with the utilisation of some reserves (as mentioned above), has left reserves as a proportion of core spending closer to 3 months. Whilst this is below the target set, the Trustees believe it still represents a reasonable level of protection against any short-term funding issues, or other unexpected events. The Trustees recognise the importance of maintaining reserves and will be working towards increasing the level of reserves back towards the stated target in the coming 18 months.
