Objectives and activities

The charity's objects

The objects of the CIO are to further or benefit the residents of Thorpe metropolitan district of Leeds and the neighbourhood, without distinction of sex, sexual orientation, race or of political, religious or other opinions by associating together the said residents and the local authorities, voluntary and other organisations in a common effort to advance education and to provide facilities in the interest of social welfare for recreation leisure time occupation with the objective of improving the conditions of life for the residents.

In furtherance of these objects but not otherwise, the trustees shall have the power: to establish or secure the establishment of a community centre and to maintain or manage or co-operate with any statutory authority in the maintenance of such a centre for activities promoted by the charity in furtherance of the above objects.

The charity's main activities

Running a Community Centre

Public benefit statement

In setting our objectives and planning our activities our Trustees have given serious consideration to the Charity Commission's general guidance on public benefit and in particular to provide facilities in interest of social welfare with a view to improving condition of life for residents.

Achievements and performance

A joint Christmas Fayre was held with the Thorpe PTA, it was well attended. Christmas parties were held one for the youngsters in the village and one for the pensioners. A Halloween Disco was also held which was run by two of our young residents. These were in addition to our weekly Coffee Morning and Art Class. Two visits for meals and entertainment were also organised for our users.

Financial review

Net expenditure for the year was £198, including net expenditure of £849 on unrestricted funds and net receipts of £651 on restricted funds.

Reserves policy

The charity's free cash reserves at the year end were £1,341.

The reserves that we have set aside provide financial stability and the means for the development of our principal activity. We intend to maintain our reserves at a level which is at least equivalent to our annual operating expenditure, estimated for the year 2019/2020 at £1,200 and with a maximum level of £2,200. This is to ensure that there will never be a shortfall in funding available, for the following year, as this would compel closure of the charity. We intend to use the reserves in part, in the following manner in 2019/2020.
