Our workers also run a series of events throughout the year to which school groups and others are invited. Summary of the main achievements of the charity during the year

Achievements and performance

In 2018/2019 the Trust has employed four keyworkers: a part-time singer/songwriter, a part time storyteller, and one full and one part-time keyworker. Our new full-time keyworker joined us in September 2018. The team make regular visits to around 50 schools in the Bradford area, and occasional visits to schools in other areas of the country. Their work is supported by a dedicated part-time administrator.

The **assemblies**, **lessons and workshops** provided throughout the school term support schools in meeting the requirements of the National Curriculum, build understanding of the Christian faith, assist with social cohesion, and allow students to experience the creative arts. Such enrichment of the school curriculum improves pupil enjoyment of school and can have a direct impact on attainment. The Trust's policy of making these available regardless of the ability to pay is of importance as schools face increasing budgetary pressures.

In addition to this work the team have been involved in the following ongoing and one-off projects during the year:

Re:wind and Fast Forward, a programme linked to the RE curriculum and transition, is well established in Shipley. These free sessions are attended by almost all the Year 5 and 6 students in the town. They increase their understanding of major Christian festivals, and are assisted with the transition to secondary school. During this year we have also provided staff support to CLiKs in Keighley to provide these events in their area while they were without a worker.

The Bible Times Exhibition plays a regular part in the life of both schools and churches as it makes annual visits across the city. This year it visited seven churches. This helps schools to build relationships with places of worship. The exhibition itself includes both Jewish and Christian exhibits, building understanding between faiths. Bibles in different languages encourage inclusivity.

Refugee Voices seeks to develop understanding and inclusivity of refugees and asylum seekers, especially in schools. Those directly involved have the opportunity to take part in a drama project and performance. For the wider school it increases understanding of the issues and can assist them in gaining School of Sanctuary status. This year the project ran in two schools. In one, a wider range of art workshops ran alongside the project.

Holiday Club was a programme called Team Builders, by Scripture Union. We were able to provide the programme free of charge, providing holiday activities that were open to all. Over 80 children attended during the week.

The Big Light Party provided an alternative to traditional Halloween activities. As with holiday club, the event was provided free and was open to all. The theme was fairy tales, and focused on the redemptive aspects of those stories.

The Rock Solid youth group project has expanded this year. The original group in Wilsden is continuing with funding from the local Methodist Church. A new group, funded by the Bradford North Methodist Circuit has started in Shipley.

Prayer Spaces are a way of engaging school-aged children with prayer

in a creative and fun way. As the activities don't conform to the 'normal' patterns of Christian prayer, they cross cultural and religious boundaries.

Open the Book is a national project through which small teams of storytellers take Bible stories into school assemblies, bringing them to life with props and costumes. The Trust is responsible for the coordination of the six local storytelling teams, visiting eight schools.

Church youth work is an aspect of our new keyworker's role. Funded by Shipley Baptist Church, he works with the 9-15 year-old's in the church, providing a Sunday youth group, Sunday school classes, and linking work with their schools. The activities have also included meeting with young people from other local churches on a regular basis.

Zephachoir was launched in September 2018, with the aim of providing a space for children to sing and have fun, to build confidence and community. Following a review, taking into account what the children enjoyed in the sessions, this has now been rebranded as Cake Club, and includes a wider range of activities.

Other events during the year included an evening of storytelling and music, aimed at adults, called Kintsugi Tales, and a training day for church workers working with children who have been in care, or have attachment issues. In February we celebrated our 25th Birthday with a week of events linking with the different groups that we work with, showcasing the work that we do and finishing with a Celebration service at Bradford Cathedral.
