He has been liaising with outside agencies, reviewing income generation opportunities, mitigating cost exposure in the lease and recommending systems for improving administration. We really appreciate the excellent support given and look forward to his continued support in the future.

Treasurer

Maureen Farronan continues to function as Treasurer. We thank God for her faithful dedication to this role.

Vision

To encourage men, women and children to know God and make Him known; and to empower them to fulfil their destiny in God.

Mission

To achieve our vision through prayer, fasting, bible studies, training, teaching and evangelistic outreaches. To present the holistic gospel to all in an atmosphere of excellence and to see the power of God demonstrated.

Finances

Costs saving measures remain ongoing. We are monitoring all spending inorder to reduce the financial deficit.

Administration

The work of Administration is currently being performed by volunteers. This will be reviewed once the financial state of the ministry improves. We are still looking for more volunteers to assist in this department.

Training Sessions

Ongoing training is vital in order to keep up to date with the rules and regulations of Charity Commission. We are thankful for the training sessions provided by Amryl Reuben and look forwards to more training sessions in the future.

Training sessions for Leaders were held on 15/6/19 and 29/619 by Amryl Reuben. We explored the roles and responsibilities of leaders and were encouraged to be diligent and serve with excellence.

Membership

The leadership team agreed for a training session to be held for all members.

This training session was conducted by Amryl Reuben on 29/6/19. On the 7/7/19 the right hand of fellowship was extended to all who wanted to comply with the reaffirmation of their membership. The right hand of fellowship will be extended again for new converts, new attendees and others to have the opportunity to become members. A membership handbook will be developed to distribute to members. Teaching sessions on various doctrinal topics will be delivered in the New Year. Our aim is to see spiritual and numerical growth and members maturing in their faith in God.

Hortus Road

We are still seeking to rent the building as attempts so far have been unsuccessful.

New Building

We firmly believe we are strategically placed in this multi-cultural location to assist with spreading the gospel of the Kingdom of God. We are extremely grateful for the extra space received with the acquisition of this building. The extra space now makes it easy to host Junior church, prayer and bible study sessions. The Tea and coffee area in the foryer provides an environment that is conducive for people to mingle and socialize after services. The extra space upstairs provides the opportunity to host events and functions. Although we are yet to maximize the full use of the extra spaces in this building, we are in the process of looking into ways of marketing rooms for Hire. We believe this is vital as it will assist with income generation.

We thank Bro Joe and Bro. Joseph for their assistance with the maintenance of the building.

Challenges

The cost of maintaining the building is high. Costs saving measures are in place. We are believing God for financial increase to cover the cost of expenditure.

Rough sleepers, as well as young people smoking and drinking in front of the building at nights are proving to be extremely challenging both 'socially and on a spiritually'. We are constantly cleaning in front of the building from the litter left by these groups. Referrals have been made to the Street link who have provided some support for rough sleepers, however, the problem remains ongoing.

Departments

The Ladies ministry continues to function. Ladies Ministry Leaders are Brenda, Amryl, Marilyn and Mary.

The Children ministry restarted on 1/7/19. Leaders are Amryl and Julia

The men's department restarted in May Pastor Morgan leads this department.

Regrettably, we were unable to restart the youth department. Volunteers are needed to assist in this department.

We strongly believe in the power of prayer. Prayer will always be an essential part of this ministry. We thank all who have been praying for this ministry and would like to encourage everyone to continue in fervent prayer.
